1. These two lots, the original extents of which were 3 roods 20 perches and 3 acres 7 perches respectively, were sold to the encroacher on November 29, 1930. It was, however, found later that the actual encroachment was only on a portion of the lots and that the alienation of the remaining portions would adversely affect dealings with adjoining blocks of Crown land. The sale was therefore cancelled and the two lots which have since been resurveyed are now advertised for sale to the encroacher.
