FINAL ORDERS.

LAND SETTLEMENT ORDINANCE, 1931.

Settlement Order.

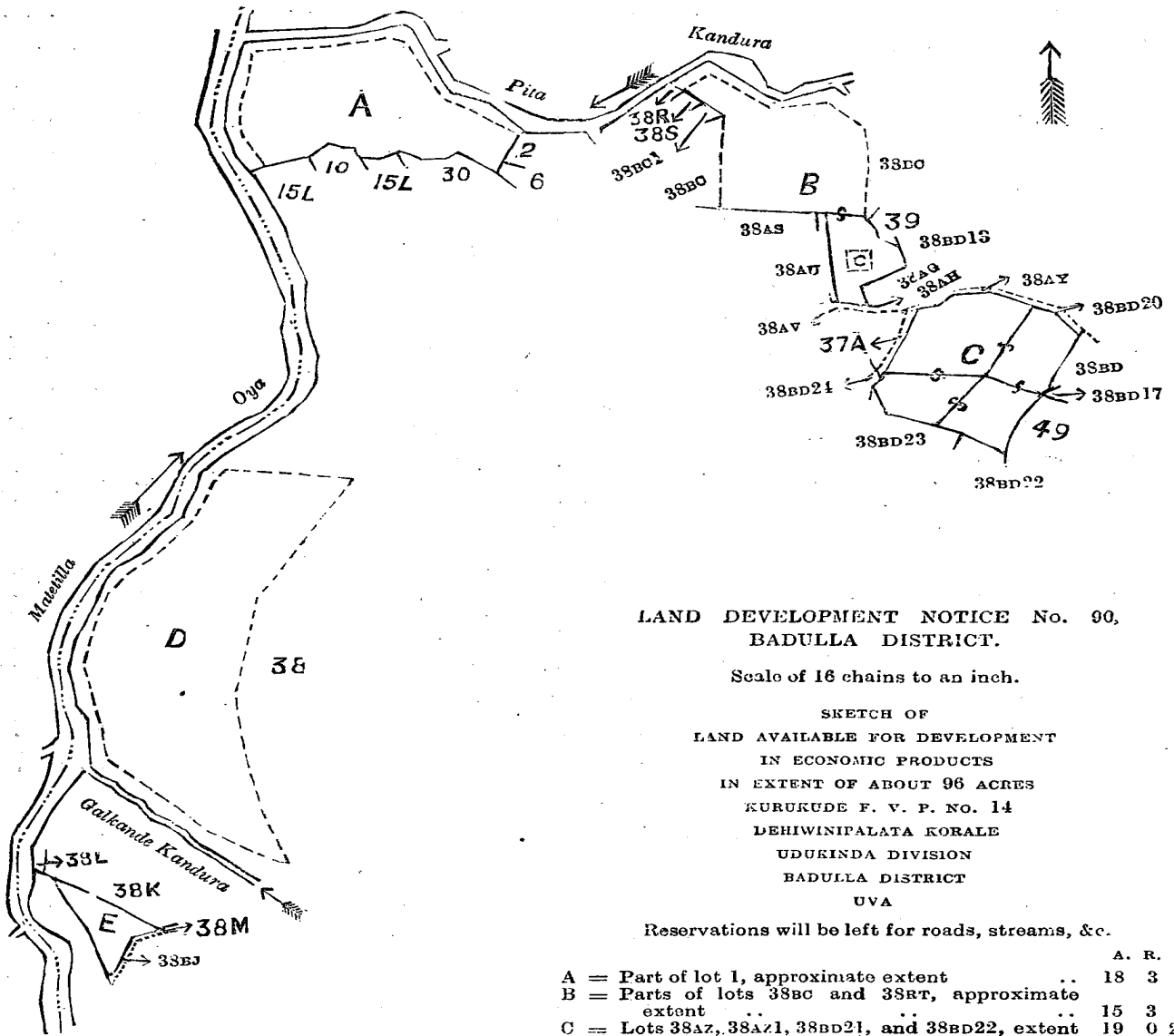
