## FINAL ORDERS.

## Order under Section 4, Sub-section (1) of "The Waste Lands Ordinances of 1897, 1899, 1900, 1903, and 1927," declaring Land to be Crown Property.

In the matter of the land commonly called or known as Moragollehenyaya (reservation along streams), situate in the village of Welagane, in Kudagalboda korale in the Weudawili hatpattuwa of the Kurunegala District, in the North-Western Province, and of "The Waste Lands Ordinances of 1897, 1899, 1900, 1903, and 1927."

WHEREAS in pursuance of section 1 of the said Ordinances it was duly notified on the 27th day of June, 1930, that if no claim to the land commonly called or known as Moragollehenyaya (reservation along streams), situate in the village of Welagane, in the Kudagalboda korale in Weudawili hatpattuwa of the Kurunegala District, in the North-Western Province, containing in extent 6 acres 3 roods and 2 perches, and shown as lot 1 in advance extract No. 4 of block survey preliminary plan No. 1,050, was made to Walter John Lancashire Rogerson, Esq., Acting Government Agent, North-Western Province, within the period of three months from the date specified in such notice, such land would be declared the property of the Crown (*vide* Notice No. 10,574):

And whereas Mr. Leonard Cecil Pullenayagam of Mahatenna estate, Kandy, on behalf of his wife Mary Augusta Savundarie Pullenayagam made claim thereto, and whereas the said claimant was absent on service of summons and

her claim to the land was dismissed by default, I, John Radley Walters, Acting Government Agent, North-Western Province, under and by virtue of the powers vested in me in that behalf by section 4 of the said Ordinances, do hereby on this 9th day of December, 1931, order and declare under section 4, sub-section (1), of the said Ordinances, that the said land, as more fully described herein below, is the property of the Crown.
