NOTICE is hereby given that on Tuesday, May 24, 1932, at 1.30 P.M., the Government Agent, Southern Province, will put up to auction, at his office at the Galle Kachcheri, the right to mine for mica and plumbago in the under-mentioned Crown land in the Galle District, which is believed to contain mica and plumbago, for a period of five years on the following conditions:—

(a) The lease will include the right of mining for mica and plumbago only, and will be for a period of five years at the yearly rent of Rs. 10 per acre, and subject to the covenants and conditions as sanctioned by Government, a copy of which can be obtained at the Kachcheri. The highest bidder for the lease of the under-mentioned allotment shall be the purchaser, provided that the price offered by him amounts at least to the upset price at Rs. 75 per acre.

(b) No bidding shall be finally accepted unless the person making the same shall, on being declared the highest bidder, immediately pay to the Government Agent a deposit of 10 per cent. on the amount of bidding, whether he has made a previous deposit or not, and also unless the said person shall, on being declared the highest bidder as aforesaid, signed the above-mentioned conditions of sale.

(c) The purchaser shall pay to the Government Agent within one month of the date of sale the balance of the purchase money and in failure thereof the purchase shall be considered void, and the deposit of 10 per cent., together with any other sum paid on account of the land, shall be forfeited.

(d) On payment to the Government Agent within the time specified of the whole of the purchase money, the Government Agent will grant to the purchaser a lease in the approved form, and the purchaser at the same time execute and deliver to the Government Agent a duplicate of such lease.

(e) Should any error or mistake hereafter appear in the description and admeasurement of the said lands, the purchaser will not be entitled to claim any compensation or abatement of the price in respect thereof.

(f) The fee for the preparation of the lease is 4 per cent. of purchase money, not exceeding Rs. 20, and must be paid on the day of sale.

(g) Full value of timber and fuel must be paid on date of sale.

(h) A deposit of Rs. 50 per acre should be made on completion of sale as security for the due fulfilment of conditions of the lease, and the pits opened should be filled up on termination of the lease.

(i) The lessee may abandon his lease on giving six months' notice and paying the rent due.

The Assistant Government Agent, Hambantota, will on April 30, 1932, at 10 A.M., at the Hambantota Kachcheri, bring up for allotment the under-mentioned portions of Crown land in accordance with the regulations of Government.

The allotments will be made subject to the following principal conditions:—

(1) The permit-holder shall pay an annual rental of Re. 1 per acre, payable in advance on April 30, in each year.

(2) The permit-holder shall clear and plant the land as quickly as possible to the satisfaction of the Assistant Government Agent, and shall complete this work within three years from April 30, 1932. It is also compulsory that the permit-holder should reside on the land.

(3) At the expiration of the period of three years, the permit-holder, provided he has planted up the land to the satisfaction of the Assistant Government Agent, shall be given the right to hold the land upon a tenure to be hereafter established by law, and which may contain provisions for the payment to Government by the tenant of a certain sum annually by way of land revenue and for the periodical revision of that sum as well as restrictions to prevent:—

(a) The land being alienated or mortgaged without the permission of some authority, to be specified in the document on which the land is held.

(b) The land being sold for debt.

(c) The land being abandoned or left uncultivated.

(d) The land being subdivided or becoming subject to undivided ownership.

Such right to hold the land shall, if the payment to Government by the tenant of a certain sum annually by way of land revenue and for the periodical revision of that sum shall not have been provided by law, but not otherwise, be granted upon payment as purchase price of Rs. 30 per acre payable in such instalments as may be arranged between the Assistant Government Agent and the permit-holder.

(4) Should the permit-holder fail to carry out any of the conditions of the permit or if the said land or the interest of the permit-holder be seized in execution of a decree against the permit-holder, the Assistant Government Agent may cancel the permit and take possession of the land and any crops, plantation, building, or other improvements upon it, and the permit-holder shall have no right to claim any compensation whatsoever.

(5) Conditions setting forth in detail the terms under which these allotments will be made are available at the Hambantota Kachcheri for reference.
