ORDERS. FINAL

Order under Section 4, Sub-section (1), of "The Waste Lands. Ordinances of 1897, 1899, 1900, 1903, and 1927," declaring Purchase of Land.

In the matter of the land commonly called or known as Wayagollahena, situate in the village of Aludeniya in Udukaha korale, in Dewamedi hatpattu, in the Kurunegala District, in the North-Western Province, and of "The Waste Lands Ordinances of 1897, 1899, 1900, 1903, and 1927."

WHEREAS in pursuance of section 1 of the said Ordinances it was duly declared and notified on the 30th day of March, 1928, that if no claim to the land commonly called or known as Wayagollahena, situate in the village of Aludeniya, in Udukaha korale in Dewamedi hatpattu, in the Kurunegala District, in the North-Western Province, containing in extent 19 acres and 8 perches, and shown as lot 19 in advance extract 1 of block survey preliminary plan No. 883, was made to Thomas Arthur Hodson, Esq., Government Agent, North-Western Province, within the period of three months from the date specified in the said notice, such land would be declared the property of the Crown (vide Notice No. 9.760).
