# No. 9 of 1933.

# An Ordinance to amend the Medical Ordinance, 1927.

GRAEME THOMSON.

BE it enacted by the Governor of Ceylon, with the advice and consent of the State Council thereof, as follows:—

Short title.

Ordinance.

Amendment of section 51 of the principal

- 1 This Ordinance may be cited as the Medical Amendment Ordinance, 1933.
- 2 Section 51 of the Medical Ordinance 1927 is amended as follows:—
  - (a) Sub-section (1) (a) by the insertion of the words "or surgeon dentist" between the word "surgeon" and the word "or" in line 2 thereof.
  - (b) Sub-section (2) by the addition of the words "and shall not assume or use the titles of dental surgeon or surgeon dentist unless he possesses the qualifications indicated in section 45 (1) (a) and section 45 (1) (b)."

Passed in Council the Twenty-ninth day of March, One thousand Nine hundred and Thirty-three.

# DRAFT ORDINANCE.

# MINUTE.

The following Draft of a proposed Ordinance is published for general information:—

An Ordinance to make Supplementary Provision for the Public and Colombo Electricity Supply Services for the Financial Year 1931-32.

BE it enacted by the Governor of Ceylon, with the advice and consent of the State Council thereof, as follows:

1 This Ordinance may be cited as the Supplementary Appropriation (1931-32) Ordinance, No. of 1933.

- 2 In addition to the sum appropriated by the Appropriation Ordinance of 1931, the several sums appearing in Schedule I hereto and amounting in the aggregate to the sum of nine hundred and fifty-one thousand four hundred and seventy-three rupees and fifty-nine cents are hereby declared payable out of the revenue of this Island for the service of the financial year beginning on October 1, 1931, and ending on September, 30, 1932, in respect of the several services mentioned in the said Schedule.
- 3 In addition to the sum appropriated by the Appropriation Ordinance of 1931, the sum of seven thousand two hundred and fifty-three rupees and sixty-two cents appearing in Schedule II hereto is hereby declared payable out of the revenue of the Colombo Electricity Supply for the service of the financial year beginning on October 1, 1931, and ending on September 30, 1932, in respect of the service mentioned in the said Schedule.
