After May 31, 1932, one or more Land Kachcheries will be held for the selection of applicants for allotments of land. Notice of these Kachcheries will be given. No deposits need accompany applications.

2. High land as well as paddy land will be available for allotment. The following are the terms upon which allotments of land will be made:—

- (1) The permit holder shall asweddumize the paddy land and improve the high land within five years from the date of allotment.
- (2) The permit holder shall pay in advance an annual rental of fifty cents per acre per annum.
- (3) The permit holder shall after the third year of his occupation be liable to pay such Irrigation rates not exceeding at first Rs. 2 per acre as may be determined by Government.
- (4) The Assistant Government Agent will decide the extent of land to be given to each selected applicant and how blocks are to be allotted to selected applicants and his decision in all questions in connection with such allotment shall be final.
- (5) The permit holder shall be subject to all Irrigation and Cultivation rules existing at present or which may lawfully be made hereafter.
- (6) The permit holder will be entitled to make use of the timber on the land for fencing, or for the erection of watch huts or houses on the land. He shall, however, have no right to remove any timber whatsoever from the land without permission which may be granted upon such terms as to payment or otherwise as may be decided.
- (7) The permit holder shall build a house to the satisfaction of the Assistant Government Agent on the land allotted to him and reside therein.
- (8) Should the permit holder fail to carry out any of the conditions of the permit or if the said land or interest of the permit holder be seized in execution of a decree against the permit holder, the Assistant Government Agent may cancel the permit and take possession of the land and any crops, plantation, buildings, or other improvements upon it: nor shall the permit holder nor any person claiming through him have any right to claim any compensation whatsoever for any improvements effected by the permit holder or any other person upon the land.
- (9) The permit holder shall surrender free of compensation any portion of the land allotted to him which may be required hereafter by the Government for roads, channels or any other purpose.
- (10) At the expiration of the period of five years mentioned in condition (1) above the permit holder, provided he has improved the land to the satisfaction of the Assistant Government Agent, shall be given the land upon the following conditions:—

- (a) A small annual payment must be made to Government or a small lump sum will have to be paid in instalments spread over several years.
- (b) The land may not be alienated or mortgaged without permission.
- (c) The land cannot be sold for debt.
- (d) The land must be cultivated.
- (e) The land may not be sub-divided below a certain fixed unit of extent nor allowed to be held in common by more than a certain number of persons.

Conditions.

1. Ordinarily farms of approximately 12 acres in extent will be offered. It is contemplated that a farm of this extent will provide employment and a livelihood for one farmer and his family with 1 or 2 pairs of ploughing bulls but not employing any regular outside labour. Larger farms will be considered in a few cases for persons of larger means who can afford to keep more cattle and employ hired labourers.

2. The land will be given on conditions restricting alienation or mortgage without permission, protecting the holder from seizure of his land or crops for debt, requiring four-fifths of the land to be stumped and ploughed and thereafter kept under cultivation with annual crops and by means of the plough and the harrow, and preventing subdivision of the farm or its passing into the hands of a number of joint owners on the death of the farmer or in any other eventuality.

3. The first clearing of the land will have to be done piece by piece on special permits. The rate at which these permits will be granted will depend entirely on the progress made by the farmer, in stumping, ploughing and cropping the portion of the farm for which he has already received permits.

4. One-sixth of the extent of the farm may be made into a garden with trees and permanent cultivation.

5. An annual quit rent of 50 cents per acre will have to be paid. This will be subject to subsequent revision as provided by law. This rent will only be charged on the portion of the farm permit to clear which for the first time has been given.

6. Residence on the farm will be required unless special exemption is granted. Such exemption will only be considered in exceptional cases.

7. If the whole farm is not satisfactorily broken up by the end of a period of ten years or by the end of such extended period as the Land Commissioner may grant or neglected at any time the registration or lease as the case may be of the whole or part of the farm may be cancelled and the land for which the registration or lease has been cancelled shall revert to Government without compensation of any kind to the farmer.

8. Timber on the land may be utilized free on the land for any purpose connected with the farm. It may not, however, be removed from the land without a permit which may be granted subject to payment.

9. Effect to these terms will be given by registration under a special Ordinance if and when such Ordinance is passed, otherwise by lease.
