FINAL ORDERS.

LAND SETTLEMENT ORDINANCE, 1931.

Settlement Order No. 38 (Ratnapura).

WHEREAS a notice under section 1 of the Waste Lands Ordinances of 1897 to 1903 and 1927 was duly published in the Gazette No. 7,734 of September 20, 1929, and as otherwise required by the said section, in respect of the lands situated in the village of Ihala Pohorabawa, in the Uda pattu north of the Kuruwiti korale of the Ratnapura District, in the Province of Sabaragamuwa, and described as lots 27, 30, 48, 78, 96, 98, 99, 106, 129, 188, 190, and 191 in block survey preliminary plan No. 315 (vide Notice No. 10,206):
