(4) The permit-holder will be entitled to make use of the timber on the land for fencing or for the erection of watch huts or houses on the land. (5) The permit-holder shall make an annual payment. The initial payment shall not exceed 50 cents per acre but this may be revised periodically.

(6) The permit-holder shall be subject to all irrigation and cultivation rules at present existing or which may hereafter be made under the provisions of any Ordinance now in force or hereafter enacted.

(7) The permit-holder shall pay, after the third year, such irrigation rates as may be fixed from time to time by Government. The initial rate shall not exceed Rs. 2 an acre.

(8) The permit-holder shall not dispose of or otherwise deal with his interests under this permit in any way whatsoever without the prior sanction in writing of the Government Agent and any such disposition or transaction shall be null and void.

(9) The permit-holder shall surrender free of compensation any portion of the land allotted to him which may be required hereafter by the Government for roads, channels, or any other purpose.

(10) The permit shall be personal to the permit-holder and shall terminate with his death.

(11) The permit-holder may nominate a person to whom he desires that the Government Agent should issue a fresh permit in the event of the death of the permit-holder during the term of this permit.

(12) On the termination of the permit the land shall revert to the Crown, and no person shall have any right to claim compensation from the Crown for any improvements made upon it.

(13) In the event of the termination of the permit by the death of the permit-holder the Government Agent may at his discretion issue a fresh permit for the land to the person nominated by the permit-holder, if he considers him a fit person or to any dependent of the permit-holder or to any other person.

4. Selected applicants will be required to deposit survey fees, at the Land Kachcheri at the rate of Rs. 3 per acre. This money will not be refunded if Government shall owing to any action or omission of the applicant have been put to the expense of an unnecessary survey, and the Land Commissioner's decision as to whether such fees in any particular case may reasonably be refunded or not shall be final.
