PASSED ORDINANCE.

Ordinance enacted by the Governor of Ceylon, with the advice and consent of the State Council thereof.

No. 20 of 1932.

III. 628. *An Ordinance to amend "The Education Ordinance, No. 1 of 1920".

GRAEME THOMSON.

BE it enacted by the Governor of Ceylon, with the advice and consent of the State Council thereof, as follows:

Short title.

1 This Ordinance may be cited as the Education Amendment Ordinance, No. 20 of 1932.

Amendment of section 17 of Ordinance No. 1 of 1920.

2 Section 17 of "The Education Ordinance, No. 1 of 1920", (hereinafter referred to as the principal Ordinance) is hereby amended as follows:

- (a) by the deletion of paragraphs (b) and (c) thereof; and
(b) by the substitution of the letter "b" for the letter "d" within the brackets in the first line of paragraph (d) thereof.

Amendment of section 18 of Ordinance No. 1 of 1920.

3 Section 18 of the principal Ordinance is hereby amended as follows:

- (1) by the substitution of the word "includes" for the words "is situated within" in the second line and by the deletion of the words "which has been declared to be an education district" in the third and fourth lines of paragraph (b) of sub-section (2) thereof; and
(2) by the substitution of the word "includes" for the words "is situated within" in the second line of paragraph (c) of sub-section (2) thereof.
