KNOW Ye that by virtue of the powers in Us vested by section 5 (1) of the Irrigation Ordinance, No. 45 of 1917, and by Article 93 of the Ceylon (State Council) Order in Council, 1931, We, the Governor of Ceylon, do hereby (1) revoke the Proclamation under the said section published in the *Gazette* of April 17, 1919, so far

as it affects the divisions of the Nuwara Eliya District set out in the schedule thereto; and (2) declare that the several districts of the revenue district of Nuwara Eliya set out in the schedule hereto, shall from and after the date hereof be irrigation districts within the meaning of the said Ordinance.

## SCHEDULE.

*The Revenue District of Nuwara Eliya.*

(1) The district comprising the Diyatileke and Gangapalata korales of the revenue divisions of Udahehaheta; bounded on the north by Mahaweli-ganga, east by Mahaweli-ganga and Belihuloya, south by Gannewe and Kohoka korales in Udahehaheta, west by Maoya.

(2) The district comprising the Gannewe and Kohoka korales of the revenue divisions of Udahehaheta; bounded on the north by Diyatileke and Gangapalata korales in Udahehaheta, east by Belihuloya, south by Udagampaha korale in Udahehaheta, west by Gurugaloaya.

(3) The district comprising the Uda and Pallegampaha korales of the revenue divisions of Udahehaheta; bounded on the north by Gannewe and Kohoka korales in Udahehaheta, east by Oyapalata and Yatipalata korales in Walapane, south by Udapalata korale in Walapane and Kandapola forest, west by Wilkada forest.

(4) The district comprising the Oyapalata korale of the revenue divisions of Walapane; bounded on the north by Mahaweli-ganga, south by Udakudagala and boundary of Yatipalata korale, east by boundary of Medapalata korale, west by Belihuloya.

(5) The district comprising the Medapalata korale of the revenue divisions of Walapane; bounded on the north by Mahaweli-ganga, south by the boundaries of Yatipalata and Oyapalata korales, east by Umaoya, west by Kurunduoya.

(6) The district comprising the Udapalata korale of the revenue divisions of Walapane; bounded on the north by the boundary of Yatipalata korale, south by the boundaries of Meda and Yatipalata korales in Udukinda, east by Gampaha korale in Udukinda, west by Udagampaha korale in Udahehaheta.

(7) The district comprising the Yatipalata korale of the revenue divisions of Walapane; bounded on the north by the boundary of Medapalata korale, south by the boundary of Gampaha korale in Udukinda and Udapalata korale, east by the Kudaoya and Gampaha korale in Udukinda, west by the boundaries of Oyapalata and Udapalata korales.

(8) The district comprising the Medapane, Pallepene, and Tyspane korales of the revenue divisions of Kotmale; bounded on the north by Medagahawatura, Piliwela, Riverside, Peacock Hill, Monaragala, and 24th milepost on Gampola-Nuwara Eliya cart road, east from 24th mile to 25th milepost on Gampola-Nuwara Eliya cart road, Gomburuoya and Kotmala-ganga, south by the boundary of Queensbury gap, Kelliwatto, and Bogahawatte, west by Gorakaoya and Kadienlena estate and Mahaweli-ganga.

(9) The district comprising the Udapane and Ramboda korales of the revenue divisions of Kotmale; bounded on the north by the district boundary from the 24th milepost on Gampola-Nuwara Eliya road until it cuts the Loolkandura-Cannethan District Road Committee bridle path at a point north-east of Stellenburg estate and the division boundary until it reaches the point 6,815 feet elevation and Kotmala-ganga, east by the division boundary from the point marked 6,815 feet elevation following the Pedro-Kondagala ridge at a point  $\frac{1}{4}$  mile north marked 7,725 feet elevation, south from the point where the division boundary cuts the Pundaluoya-Dunsinane road in a straight line to Kunumellagala trig station and to the 46 $\frac{1}{2}$  milepost and the southern boundary of Madacamkura estate until it touches the Kotmale-ganga, west by Kotmale-ganga up to the Kosgolla ferry.

**RULES.****I.—Irrigation Headmen (Section 11 (c)).**

1. The Irrigation Headmen hereinafter called Kama-Vidanes, elected or appointed under section 20 of the Ordinance for the Iranamadu irrigation district, shall be ten in number, subject always to the provisions of section 21 (6).

2. It shall be the duty of the Kama-Vidanes to regulate and supervise the use of any water supplied from the irrigation work and the cultivation of the lands under the scheme, and generally to enforce the observance of these rules.

3. (1) The Kama-Vidanes shall be paid by the proprietors a Suwanthiram at the close of each harvest.

(2) Such Suwanthiram shall be at the rate of three measures of paddy for each acre or part of an acre of the land cultivated during the season.

(3) It shall be the duty of every proprietor to pay the proportionate share of the Suwanthiram due from him in respect of any season, either within four months of the reaping of the harvest or before the removal of the produce harvested from the field, whichever is earlier.

4. No Kama-Vidane shall hold office for a longer period than three years from the date of his election or appointment; but nothing in this rule shall be deemed to prohibit the re-election or reappointment of any such officer, if he is otherwise eligible, for further periods of the like duration.

**II.—Contributions of Labour (Section 11 (d)).**

1. All field channels and drainage channels, which are not in the charge of the Irrigation Department, and which may be used in common by more than one proprietor, shall be constructed, cleared, repaired, and maintained in proper working order, by the proprietors.

2. It shall be the duty of each proprietor to construct, clear, repair, and maintain, either himself or by his agent or servant, such portion of any new or existing channel as may be marked out and defined for him, as the share proportionate to the acreage he holds, by the officer (hereinafter called the Cultivation Officer) appointed by the Government Agent under section 20A of the Ordinance.

3. It shall in like manner be the duty of each proprietor to maintain clear of vegetation and all other obstruction such portion of any field-road path or reservation as may be marked out by the Cultivation Officer as the share proportionate to the holding of such proprietor.

4. (1) The time within which any portion of work, marked out as aforesaid, should be completed, shall in every case be prescribed by the Cultivation Officer.

(2) In the event of any default, neglect, or delay on the part of any proprietor, to whom any portion of work may have been assigned as aforesaid, it shall be lawful for the Cultivation Officer or the Government Agent to cause such work to be carried out or completed and to recover the expenses incurred thereon from such defaulting proprietor in the manner prescribed in section 65 of the Ordinance.

**RULES.****\* Rules for the Protection of the Giant's Tank Irrigation Work and for the Conservation of Water.**

1. No person shall obstruct, divert, cut the sides of, damage, or interfere in any way with, any alavakkai, channel, or other water-course comprised in the "irrigation work".



2. No person shall encroach upon any alavakkai, channel, or other water-course, or any reservation therefor, comprised in the "irrigation work".

3. No person shall interfere with, or in any way damage, any sluice, dam, or regulating work comprised in the "irrigation work".

4. No person shall obstruct, or interfere with, or in any way damage, any road or path comprised in the "irrigation work".

5. No person shall waste, or cause or permit any other person to waste, water supplied from the "irrigation work".

6. The operative control of all sluices and regulators on any parts of the irrigation works for the maintenance of which the Director of Irrigation is responsible shall be exercised by the Director of Irrigation or by a person authorized by him, and no person without such authority shall interfere with the distribution or flow of water therein. Provided that the water shall be immediately issued by the Irrigation Officers in charge of the sluices on the requisition of the Assistant Government Agent; and that it shall not at any time be issued without such requisition, unless in the opinion of the Irrigation Engineer such issue is essential for the safety of the works.

7. For the purpose of inspection and of effecting repairs to the "irrigation work" the issue of water for distribution to the fields may be suspended each year (a) between the 1st and 30th days of April, and (b) between the 1st day of September and the 15th day of October.

8. The issue of water from any regulator, sluice, channel, or other water-course may be suspended by the Director of Irrigation at any time, after consultation with the Assistant Government Agent, should such suspension be necessary in order to carry out repairs urgently needed for the safety of any part of the "irrigation work".

7. For the purpose of inspection and of effecting repairs to the "irrigation work" the issue of water for distribution to the fields may be suspended each year between the 15th day of May and the 6th day of June.

8. The issue of water from any channel, sluice, or regulator may be suspended by the Director of Irrigation at any time after consultation with the Assistant Government Agent, should such suspension be necessary in order to carry out repairs urgently needed for the safety of any part of the "irrigation work".

## VITAL STATISTICS.

### Registrar-General's Report on Vital Statistics of the City of Colombo for the Week ended October 1, 1932.

*Births.*—The total births registered in the city of Colombo in the week were 175 (1 European, 17 Burghers, 104 Sinhalese, 25 Tamils, 18 Moors, 4 Malays, and 6 Others). The birth rate per 1,000 per annum (calculated on the estimated population on July 1, 1932, viz. 289,961) was 31.6, as against 35.3 in the preceding week, 33.2 in the corresponding week of last year, and 31.1 the weekly average for last year.

*Deaths.*—The total deaths registered were 115 (3 Europeans, 4 Burghers, 65 Sinhalese, 17 Tamils, 16 Moors, 6 Malays, and 4 Others). The death rate per 1,000 per annum was 20.7, as against 22.0 in the previous week, 29.6 in the corresponding week of last year, and 25.2 the weekly average for last year.

*Infantile Deaths.*—Of the 115 total deaths, 19 were of infants under one year of age, as against 28 in the preceding week, 30 in the corresponding week of the previous year, and 29 the average for last year.

*Stillbirths.*—The number of stillbirths registered during the week was 13.

*Principal Causes of Death.*—1. (a) Twelve deaths from *Pneumonia* were registered, 6 in Maradana hospitals (including 3 deaths of non-residents), 2 each in Kotahena South and Maradana North, and 1 each in San Sebastian and Wellawatta North, as against 21 in the previous week, and 17 the weekly average for last year.

(b) Ten deaths from *Influenza* were registered, 2 each in Pettah, Kotahena South, New Bazaar, and Kollupitiya, and 1 each in St. Paul's and Slave Island, as against 8 in the previous week, and 10 the weekly average for last year.

(c) Three deaths from *Bronchitis* were registered, 1 each in Maradana hospitals, Maradana South, and Kollupitiya. The number registered during the preceding week was also 3 and the weekly average for last year was 5.

2. (a) Eighteen deaths from *Phthisis* were registered, 12 in Maradana hospitals (including 6 deaths of non-residents), 2 in Kotahena South, and 1 each in Kotahena North, New Bazaar, Maradana North, and Slave Island, as against 5 in the previous week, and 12 the weekly average for last year.

(b) One death from *Phthisis*, of a resident of Colombo town, occurred at the Infectious Diseases Hospital, Angoda, during the week.

3. Four deaths from *Enteric Fever* were registered, 3 in Maradana hospitals (including 2 deaths of non-residents) and 1 in New Bazaar. The number registered during the preceding week was also 4 and the weekly average for last year was 3.

4. Four deaths from *Enteritis* were registered, 3 each from *Debility* and *Puerperal Septicaemia*, 2 each from *Dysentery*, *Worms*, and *Accidents*, 1 from *Diarrhoea*, and 51 from *Other Causes*.

5. *Reported Cases.*—Twenty-two cases of *Measles*, 16 of *Chickenpox*, 5 of *Enteric Fever*, 2 of *Whooping Cough*, and 1 of *Mumps* were reported during the week, as against 20, 22, 7, 1, and nil, respectively, of the preceding week.

*State of the Weather.*—The mean temperature of air was 80.0°, against 80.1° in the preceding week and 81.0° in the corresponding week of the previous year. The mean atmospheric pressure was 29.894 in., against 29.880 in. in the preceding week and 29.896 in. in the corresponding week of the previous year. The total rainfall in the week was 1.88 in., against 2.93 in. in the preceding week and 0.19 in. in the corresponding week of the previous year.

Offer should be made subject to the following conditions by letter, preferably under sealed and registered cover, addressed to the Divisional Forest Officers concerned and posted or handed over personally, the envelope being marked on the left hand top corner "Offer for Purchase of Timber, &c.," and signed by tenderer. The offers should reach the Divisional Forest Officers concerned not later than midday on Monday, October 31, 1932.

3. Lump sums offers should be made for each item in the schedule and be written both in words and figures. Offers may be made for more than one item in the same letter, but should be quoted for each item separately.

4. In the case of offers which in the aggregate exceed Rs. 20, tenderers may remit Rs. 5 either with their offers or within two days of their offers to the Divisional Forest Officer of the Division concerned. This sum will be returned if their offers are rejected. The purchaser will be given credit for the amount in the final payment for the timber. Where the *bona fide* of any tenderer are in the opinion of the Divisional Forest Officer or the Conservator of Forests doubtful, his tender may not be entertained unless the required money deposit is made, if and when demanded by the Divisional Forest Officer.

5. The species, measurements, cubic contents, &c., of the material appearing in the schedule are to be regarded as only approximate, and intending tenderers are presumed to have inspected the timber before they make their offers and they should bring to the notice of the Divisional Forest Officer any serious discrepancies which they may notice. They should also satisfy themselves by personal inspection as to the condition of the timber they offer for.

6. Any tenderer whose offer is accepted shall, within three days of notification of acceptance of his offer, pay the full purchase amount in the case of offers aggregating to Rs. 20, and as follows in the case of offers exceeding Rs. 25 in the aggregate :—

Over Rs. 20 up to Rs. 100, 50 per cent. ; and over Rs. 100, 25 per cent. ; the balance being paid within a fortnight of the previous payment. In the event of failure to complete the purchase, all amounts previously paid shall be forfeited and the timber, &c., revert to the Crown, and be liable for resale at the risk of the original purchaser.

Should any successful tenderer decline or fail to pay any sum or sums as above stipulated for, he shall further be pecuniarily liable for any resultant loss to Government.

The Conservator of Forests reserves however the discretionary power to enforce, modify, or waive any of the provisions in this clause to such extent as he may consider the circumstances justify.

8. All materials shall be removed by purchaser within one month of completion of purchase when a permit for removal will be issued. Extension of time will not be granted except under exceptional circumstances.

9. All materials purchased shall be at the risk of the purchaser until its removal by him on a permit.

10. The buyer, his agent, or his representative shall be liable for punishment under the Forest Ordinance for commission of any Forest Offence in the course of completing the transaction.
