1. Teachers should not forward requisitions for stationery or printed forms. Sufficient supplies of the former will be sent annually by the Head Office, and of the latter by the respective Divisional Offices. Stationery is meant solely for official use and must be used as economically as possible. 2. Inventory certificates must be returned promptly.

 Disciplinary action will be taken against teachers who repeatedly delay the return of inventory certificates.
 Requisitions for books and maps for school use

3. Requisitions for books and maps for school use should be made out in duplicate on the proper printed forms and submitted on the day of the annual inspection to the Assistant Inspector who will carefully scrutinize the requisitions and approve such items as he considers actually necessary. He will then forward the requisition to the Head Office through the Divisional Inspector. Requisitions made in any other way will not be entertained. Teachers must under no circumstances forward requisitions direct to the Head Office at any time.

Clause 149 (e).—Alter "Divisional Agricultural Officer" to "Divisional Inspector".

Forms.—Delete all forms, and where they are referred to in the body of the Code refer to them as "the prescribed form".

VITAL STATISTICS.

Registrar-General's Report on Vital Statistics of the City of Colombo for the Week ended November 26, 1932.

Births.—The total births registered in the city of Colombo in the week were 189 (12 Burghers, 118 Sinhalese, 25 Tamils, 25 Moors, 8 Malays, and 1 Other). The birth rate per 1,000 per annum (calculated on the estimated population on July 1, 1932, viz., 289,961) was 34 1, as against 34 1 in the preceding week, 33 5 in the corresponding week of last year, and 31 1 the weekly average for last year.

Deaths.—The total deaths registered were 175 (1 European, 10 Burghers, 101 Sinhalese, 30 Tamils, 26 Moors, 1 Malay, and 6 Others). The death rate per 1,000 per annum was 31.6, as against 26.3 in the previous week, 27.0 in the corresponding week of last year, and 25.2 the weekly average for last year.

Infantile Deaths.—Of the 175 total deaths, 36 were of infants under one year of age, as against 31 in the preceding week, 26 in the corresponding week of the previous year, and 29 the average for last year.

Stillbirths.—The number of stillbirths registered during the week was 20.

Principal Causes of Death.—1. (a) Seventeen deaths from Pneumonia were registered, 10 in Maradana hospitals (including 8 deaths of non-residents), 3 in Kotahena South, and I each in St. Paul's, Kotahena North, Maradana North, and Maradana South, as against 11 in the previous week and 17 the weekly average for last year.

(b) Ten deaths from *Influenza* were registered, 4 in St. Paul's, 2 each in Kotahena South and New Bazaar, and 1 each in Kotahena North and Kollupitiya, as against 12 in the previous week and 10 the weekly average for last year.

(c) Five deaths from *Bronchitis* were registered, 2 in Maradana North and 1 each in St. Paul's. San Sebastian, and Kotahena North, as against 4 in the previous week and 5 the weekly average for last year.

2. Sixteen deaths from *Phthisis* were registered, 11 in Maradana hospitals (including 2 deaths of non-residents) and 1 each in Kotahena North, Kotahena South, New Bazaar, Kollupitiya, and Wellawatta North, as against 12 in the previous week and 12 the weekly average for last year.

3. Three deaths from *Enteric Fever* were registered in Maradana hospitals (of non-residents), as against 4 in the previous week and 3 the weekly average for last year.

4. (a) Two deaths from *Plague* were registered in Pettah, as against nil in the previous week and 1 the weekly average for last year.

(b) One death from *Plague*, of a resident of Colombo town, occurred at the Infectious Diseases Hospital, Angoda, during the week.

5. Thirteen deaths from Debility were registered, 10 from Enteritis, 8 from Diarrhoea, 4 each from Infantile Convulsions and Puerperal Septicaemia, 2 each from Dysentery, Worms, and Accidents, 1 each from Tetanus, Suicide, and Measles, and 74 from Other Causes.

6. Reported Cases.—Thirty-two cases of Measles, 15 of Chickenpox, 8 of Enteric Fever, and 1 each of Whooping Cough and Plague were reported during the week, as against 27, 21, 3, nil, and 2 respectively, of the preceding week.

State of the Weather.—The mean temperature of air was 78.3°, against 79.2° in the preceding week and 79.4° in the corresponding week of the previous year. The mean atmospheric pressure was 29.855 in., against 29.906 in. in the preceding week and 29.892 in. in the corresponding week of the previous year. The total rainfall in the week was 6.35 in. against 2.83 in. in the preceding week, and 4.58 in. in the corresponding week of the previous year.


