LAND DEVELOPMENT NOTICE.

No. 1, Kurunegala District—Gepellawa Village.

NOTICE is hereby given that applications for certain lands situated in the village named in the list below will be considered by the Government Agent, North-Western Province, at a Land Kachcheri to be held at Hiripiriya Resthouse on January 9, 1933, at 10 A.M. Further particulars of the above lands can be obtained by inquiry during office hours at the Kurunegala Kachcheri, or the Surveyor-General's Office in Colombo.

2. Persons wishing to apply should send in written applications to the Government Agent, North-Western Province, on or before December 20, 1932, stating the extent and locality of the land for which they desire to apply and the crops they propose to grow if allotted land. They are also required to state the extent and location of all lands they at present own or hold on lease from the Crown. An incorrect or incomplete statement of such extent by an applicant will render any allotment made to that applicant liable to cancellation at the discretion of the Government Agent. No deposit need

accompany an application. Applicants should attend the Land Kachcheri to give the Government Agent any further information with regard to their applications. If neither the applicant nor any person authorized in writing to represent him attends the Land Kachcheri the Government Agent may presume that the applicant does not wish to pursue his application further.

3. Allotments will be confined to Ceylonese owning or holding on lease from the Crown less than 50 acres of land in all. Allotments will be confined to ten blocks of 5 acres and two blocks of 25 acres each.

4. The land will be granted on a tenure with conditions aiming at restricting alienation, protecting the land from seizure for debt, preventing pulverization or excessive undivided ownership, and securing that good use is made of the land. As soon as an Ordinance dealing with such a tenure has been passed, the land will be governed by the provisions of such Ordinance.

5. If the land has not yet been surveyed into suitable blocks, the final disposal of the land will be postponed pending survey.

6. Selected applicants will be required to deposit survey fees at the rate of Rs. 3 per acre. This money will not be refunded if Government shall, owing to any action or omission of the applicant, have been put to the expense of an unnecessary survey, and the Land Commissioner's decision as to whether such fees in any particular case may reasonably be refunded or not shall be final.

7. In the case of 5-acre farms, the holder would be allowed to put an extent of not more than 2 acres under permanent cultivation with coconut, &c., and the remaining 3 acres he would have to stump and plough and cultivate annually on a rotation of crops, planting tobacco every third year. Similar terms will be imposed in the case of 25-acre farms, not more than 5 acres being allowed for permanent cultivation and the remaining 20 acres being dealt with under rotation of crops.
