  - (2) No petrol pump or repair shop shall be erected.
- (3) The lease shall be terminable at six months' notice, by either party.
- (4) The lessee shall be given the option of removing the buildings standing thereon at the termination of the lease, but shall not be entitled to any compensation whatever for improvements effected.
- (5) The Government Agent reserves to himself the right to reject any bid without assigning any reasons for such rejection.

- (6) Subject to the reservation in the preceding clause, the lease shall be sold to the highest bidder provided that the sum offered shall at the least amount to the upset rent of Rs. 500 per annum.
- (7) The person declared to be the successful bidder shall, immediately on such declaration, pay a sum equal to half a year's rent and also sign the conditions of sale. The amount so paid shall be credited to revenue and be accounted as rent for the last six months of the lease.
- (8) The rent for the first year shall be paid on the date the lessee signs the lease, and the rents for the subsequent years annually in advance on the anniversary of that date.
  - (9) Buses or lorries will not be allowed into the land.
- (10) Particulars of other conditions may be obtained from the  $\mathbf{K}$ achcheri.
