Ordinance enacted by the Governor of Ceylon, with the advice and consent of the State Council thereof.

No. 3 of 1934.

AL 16/34

An Ordinance to amend the Tea (Control of Export) Ordinance, No. 11 of 1933.

R. E. STUBBS.

BE it enacted by the Governor of Ceylon, with the advice and consent of the State Council thereof, as follows :—

Short title.

1 This Ordinance may be cited as the Tea (Control of Export) Amendment Ordinance, No. 3 of 1934.

Amendment of section 31 (1) of Ordinance No. 11 of 1933.

2 Sub-section (1) of section thirty-one of the Tea (Control of Export) Ordinance, No. 11 of 1933, is hereby amended by the addition of the following proviso at the end thereof :—

“ Provided, however, that no made tea shall be so exported on any stock export licence after a date to be declared by the Governor by proclamation in the Gazette.”
