Purchase of Lease of Grass Lands in Welikada in Charge of the Government Market Garden.

NOTICE is hereby given that the Land Commissioner will receive tenders for the purchase of the lease of the under-mentioned grass lands for a period of three years from June 1, 1934.

- 2. The lessor will ordinarily supply the lessee each month with eighty cart-loads (single bullock) of manure, consisting of decomposed roadsweepings made with or without night soil, but this supply may be terminated at any time at the option of the lessor. (8) No cattle shall be permitted to graze on the land except with the permission of the lessor previously obtained, and any cattle found grazing thereon will be liable to seizure by the lessor or any person authorized by him.

(9) In the event of any breach of the foregoing conditions, the lessor shall have the power to resume possession, and eject the lessee and his workmen from the land.
