## PRELIMINARY NOTICES.

## LAND SETTLEMENT ORDINANCE, 1931.

## Settlement Notice No. 756 (Kegalla).

NOTICE is hereby given, under section 4 of the Land Settlement Ordinance, 1931, that if no claim to any one of the lands specified in the schedule hereto or to any share of or interest in such land is made to the undersigned within a period of three months from the 27th day of April, 1934, such land will be declared under section 5 (1) of the aforesaid Ordinance to be the property of the Crown, and will be dealt with on account of the Crown.
