- 1. It shall be lawful for every mortgagee of any immovable property situate within the administrative limits of the Council, or for any of the heirs or the legal representative of any deceased mortgagee, to cause any such mortgage to be registered at the office of the Council.
- 2. Every person 'desiring to have a mortgage so registered shall forward or cause to be forwarded to the Chairman a statement setting out-
  - (1) the name and address of the mortgagee or of any heir or legal representative of the mortgagee, if he is deceased:

(2) the name and address of the mortgagor; and

- (3) a description of the property or such particulars as may be necessary for identifying it.
- On receipt of such statement and on payment by the applicant of a registration fee, which is hereby fixed at Re. 1, the Chairman shall cause the names and addresses and necessary particulars to be entered in the register kept for that purpose in the office of the Council.
- In the event of any seizure, in execution for the recovery of rates, taxes, or charges due to the Council, of any property concerning which any mortgage and names and addresses may have been registered as aforesaid, the Chairman shall, at least 14 days before advertising such property for sale, serve or cause to be served on the person or persons whose names and addresses may have been so registered, a notice in writing of the seizure, the date fixed for the sale, and the amount for the recovery of which the seizure was effected.
- 5. If at any time before the sale, the amount specified in the notice is paid to the Council, the property shall be released from seizure.

- 5. Where a public stand or any portion of a public stand is reserved for the use of any particular class of hiring car, no motor car not belonging to the class for which the stand is reserved shall enter it or be parked in it.
- 6. No hiring car shall enter or remain in a public stand unless its driver is in possession of a valid permit in respect of it issued under these regulations.

- 7. No hiring car shall enter or leave a public stand except by the respective passages provided for entrance and exit.
- 8. The driver of every hiring car occupying a public stand, or a person capable of driving it, shall be in charge
- of the car while it occupies the public stand.

  9. The driver of any hiring car occupying a public stand shall, when required to do so by a police officer or a person authorized for the purpose by the Chairman, produce the permit issued in respect of such hiring car.

10. The driver or other person in charge of any hiring car in any public stand shall conduct himself in an orderly

- manner.

  11. No hiring car shall be parked in a public stand in hiring cars entering or leaving such stand.

#### RULES.

1. The bunds and spill comprised in the headworks of this irrigation work, shall be maintained and operated by the proprietors, each of the proprietors contributing labour proportionate to his holding, under the direction of the Irrigation Headman.

2. It shall be the duty of the Irrigation Headman, on the occurrence of any defect in the bunds or spill, which in his opinion cannot be repaired or remedied by the proprietors, to report the fact forthwith to the Subdivisional Irrigation Officer at Kandy.

Construction and Repair.—The wewa, ela, or any other work by which any tract or series of tracts in this district is irrigated shall be constructed and kept in repair by the proprietors or cultivators of the fields benefited, in due proportion to the extent which each holds or cultivates: Provided that amunu and pota shall be constructed and repaired according to custom by the joint labour of all the cultivators.

2. The ridges, embankments and water-courses exclusively belonging to any particular tract or paddy field shall be constructed and repaired by the proprietors or cultivators of such tract or paddy field.

3. The construction and maintenance of such works

shall include the construction and maintenance of roads and paths by which access is obtained to such works and

4. The proportion of labour due in respect of any cultivated Crown field in the tract shall be performed by the cultivator; if any such Crown field is uncultivated the labour due shall be performed by the joint labour of all the proprietors and cultivators in the tract.

5. On the day fixed by the vel-vidane for the commencement of work and on so many subsequent days as may be required for the full and proper execution of all necessary works, the owners or cultivators shall assemble together with all necessary tools, and shall contribute their labour in the means of the state of the their labour in the manner and proportion due by each.

6. The portion of each work of construction or repair to be performed by each of the proprietors shall be assigned

by the vel-vidane.
7. No person shall be exempted from his share of labour under these rules on the ground of his land being not cultivated.

8. If any person neglects or refuses to contribute any portion of the work assigned to him, the vel-vidane shall cause the work to be carried out by hired labour, and the cost thereof shall be recovered from such defaulting proprietor in the manner prescribed in section 65 of the Ordi-

nance.

9. In the case of a land leased out to a cultivator, the proprietor of such land shall be deemed to be liable to proprietor of such land shall be deemed to be liable to perform labour under these rules, unless there is an agreement or other proof in writing to the satisfaction of the Government Agent, or unless it is the custom of the locality that such liability shall fall on the cultivator.

10. Division of Water.—If there be several amunu in a river or water-course, the Korala shall determine what proportion of water shall be allowed to the lower amunu.

When there are several tracts under one principal ela, the ela-vidane in consultation with the vel-vidanes of the tracts benefited, shall assign the proportion of water for each tract.

The division of water in any one tract shall be 12.

effected by the vel-vidane of the tract.

13. The size and position of the wakkada or wakkadas, the time at which and for which the wakkada or wakkadas shall be opened, shall be as prescribed by custom, and under the supervision of the vel-vidane.

14. (a) In the event of the supply of water in the wewa, ela, or spring being insufficient, a majority of the proprietors of lands irrigated by such wewa, ela, or spring shall decide which lands are to be cleared and cultivated.

(b) Any proprietor aggrieved by any such decision of the majority shall have the right to appeal against it to the Government Agent.

(c) Where for any reason the proprietors are unable to come to a decision the matter shall be referred to the Government Agent.

(d) Any order made by the Government Agent under

- either of the foregoing paragraphs shall be final.

  15. No person shall do any act which is likely to diminish the water supply of any tract or field, or which deprives any cultivator of his due share of water, or which causes wanton waste of water or in any way benefits one person to the detriment of another.
- 16. No existing custom of taking water to certain tracts or fields for certain harvests, shall in any way be infringed.
- 17. Cultivation of Fields.—When the tract or tracts to be cultivated for any season have been selected by the pro prietors, the preparations for cultivation shall be made simultaneously by the proprietors of all fields forming part of such tract or tracts.

18. Only one description of seed paddy, to be determined by the majority of the cultivators shall be sown in

any one tract.

- 19. No proprietor who fails or is unable to sow the selected description of seed paddy shall be deemed to be exempted thereby from the duty of rendering the customary assistance to the other proprietors, nor shall he be entitled to receive any assistance other than the customary assistance from the other proprietors.
- 20. For the construction and maintenance of the customary fences and watch-huts on each tract, every proprietor shall contribute labour proportionate to his holding in person or by substitute.
- 21. Except for agricultural purposes, no cattle shall be introduced into a tract which has been fenced and cultivated till the crop has been reaped and removed.
- 22. Each cultivator shall continue to contribute his share of labour till the crops of all the cultivators in the same tract have been reaped and removed.
- 23. General.—No new dams or elas shall be used for the irrigation of new lands or for other purposes which may effect in any way the supply of water to existing fields, except with the approval of the Government Agent.
- 24. The cultivators of lands belonging to Devalas and Viharas shall be deemed to be proprietors for the purposes of these rules, and shall have all the rights and be subject to all the duties and liabilities of the proprietors.
- 25. These rules shall apply, as far as practicable, to malankumbura.
- 26. Any damage caused to the crops of a field by cattle trespass, or any act of negligence on the part of any other proprietor shall be inspected and assessed, as far as possible in the presence of the person or persons complained against, by the vel-vidane and two disinterested persons; and a joint report shall be furnished to the complainant, for production in any action or proceedings that may be instituted
- Where it is not customary to construct fences, cattle shall be tethered at a distance from the tract
- 28. No person shall be elected or appointed under section 21 of the Ordinance to be an irrigation headman unless he is a proprietor of land in the tract for which he is elected.
- All irrigation works shall be under the supervision of the irrigation headman or other duly authorized officer and any tampering or interference by any other person shall be an offence.
- The headman appointed shall be responsible for all irrigation property in his custody.
- 31. The vel-vidanes shall keep, and amend annually a list of the proprietors of lands under each irrigation work and the extent of their holdings.
- 32. Each of the proprietors of lands under cultivation shall pay the vel-vidane a huwandiram at the rate set out in the schedule to this rule.

Schedule

Buttala and Wellawaya four kurunies.

Udukinda, Yatikinda and Wiyaluwa two kurunies.

The vel-vidanes of the several tracts irrigated by a principal ela shall act under the instructions of the elavidane with regard to the maintenance of the principal ela, and shall pay to the ela-vidane one-fourth of the "huwandiram " received by them.

34. Except with the permission of the Government Agent or other authorized officer, no water from any tank or other irrigation work shall be allowed or used for any purpose other than that of irrigating paddy plants.

Where subsidiary elas are required for the purpose of leading water from the main elas, it shall be the duty of each proprietor to construct that portion of any subsidiary ela, which passes through his own land, along such lines or

in such directions as the vel-vidane may mark out.

36. The rules for the aforementioned districts of Yati-kinda, Wellawaya, Buttala Udukinda and Wellawaya. Wellawaya, Buttala Udukinda and Wiyaluwa published by proclamation in the Gazette of September 27, 1895, and deemed to be in force heretofore by virtue of the provisions of section 2 of the Ordinance, are hereby repealed.

# FOREIGN PARCEL POST RULES.

#### General.

- 1. These rules may be cited as the Foreign Parcel Post Rules, 1934, and shall be in force from and after August 15, 1934
  - 2. In these rules, unless the context otherwise requires—
    "money" shall mean coins of all kinds whether or not current in Ceylon or elsewhere, and currency notes, and shall include money orders, postal orders, and postage or other revenue stamps, exchange bills, bank post bills, bills of exchange, promissory notes, cheques, and all orders and authorities for the payment of money, whether negotiable or not, bonds, coupons, and securities for money whether negotiable or not:

negotiable or not;

"jewellery" shall mean gold or silver in a manufactured or unmanufactured state, watches in gold or silver cases, and jewels, diamonds, and precious stones, or any article of a like nature which, apart from the workmanship, has an intrinsic or market

- the expression "specified in the Post Office Guide" shall be deemed to incorporate by reference in the rule where it occurs the appropriate information as to terms, conditions or requirements, published in the Post Office Guide, and amended from time to time by notice published in the first instance in the Post Office Daily List, by the Postmaster-General under the provisions of the amended section 12 (3) of the Ordinance.
- 3. Foreign parcels may be sent to the countries and places specified in the Post Office Guide: Provided that the Postmaster-General may refuse to accept for transmission by Foreign Parcel Post any postal article or articles the transmission of which by parcel post is in his opinion an abuse of the privilege intended to be enjoyed by the public, or may direct that any article already accepted for transmission be returned to the sender.
- 4. (1) Prepayment of postage on foreign parcels shall be compulsory, and the postage shall be paid by means of postage stamps affixed to the parcel by the sender or his messenger.

messenger.

(2) The postage shall be at the Foreign Parcel Post rates specified in the Post Office Guide.

5. Every parcel shall be presented at the counter of a

- 5. Every parcel shall be presented at the counter of a Post Office, and shall be accompanied by a Customs declaration in such form and with such particulars as are specified in the Post Office Guide.
- 6. Receipt.—A receipt shall be given by the Post Office to the sender of a parcel at the time of posting.
- 7. Inquiries.—The sender of a parcel may have any inquiry made as to the disposal of the parcel on making payment, by means of postage stamps affixed to his application, of a fee of 5 cents in the case of a parcel addressed to India, and 20 cents in the case of a parcel addressed to any other country.
- 8. Packing and Addressing.—Every parcel for transmission by the Foreign Parcel Post shall be packed and addressed in such manner as may be specified in the Post Office Guide.
- 9. A foreign parcel shall not contain any article which is specified in the Post Office Guide as an article prohibited either generally or for transmission to any particular country.
- 10. Penalty for breach of Conditions.—No parcel which infringes any of the rules or conditions regarding prepayment, weight, size, or value, or which contains forbidden articles, or uninsured valuables for which insurance is compulsory, shall be accepted for transmission or be forwarded.

# WAREHOUSING CHARGES.

11. (1) Parcels received from India shall be held at the disposal of the addressee for 15 days following the date of receipt, the first 10 days free of warehousing charges and the subsequent 5 days subject to a charge of 10 cents per parcel per diem.

- (2) Any warehousing charges accruing shall be collected from the addressee at the time of delivery or in the event of non-delivery of the parcel to the first addressee, from such second addressee as may have been specified by the sender.
- (3) Parcels addressed Poste Restante shall in like manner be held at the disposal of the addressee free of warehousing charges for a period of 10 days following the date of receipt, and for any subsequent detention a warehousing charge shall be levied of 10 cents per parcel per diem but not exceeding in any case a sum of Rs. 2 per parcel for the total period of such detention.

(4) Value-payable articles from India, which are entitled to be paid for at letter or printed matter rates shall be

exempt from all warehousing charges.

(5) On Value-payable parcels the warehousing charges aforesaid shall be payable in addition to the fees prescribed hereafter in rule 26.

12. On parcels addressed to India and returned to Ceylon as undeliverable all warehousing charges incurred in India shall be recoverable from the sender or senders as if such charges were postage due on such parcels.

# Cash on Delivery and Value-payable Parcels. General.

- 13. Any postal article may be transmitted by the parcel post as a Value-payable or Cash on Delivery article to such countries and subject to such limits placed on the amounts to be remitted to the senders of articles, and to such other conditions in connection with the systems, as may be notified from time to time in accordance with the agreements made with those countries.
- 14. All Value-payable or Cash on Delivery articles shall be subject (a) to the general rules, rates of postage, fees, and conditions which apply to other postal articles transmitted to the country to which they are addressed, (b) to the special provisions of the following rules, and (c) to such other fresh provisions as may be specified in the Post Office Guide in accordance with the agreements made with the countries to which the system applies.
- 15. The sender of a Value-payable or Cash on Delivery parcel may insure it under the rules relating to insurance.

Note.—The value declared for insurance need not correspond with the amount specified by the sender for remittance to himself. Thus, in the case of a watch returned after repairs per value-payable post to its owner, the amount to be remitted to the sender of the watch would be only the cost of repairs, while the sum insured would represent the value of the watch itself.

- 16. If the addressee refuses or omits to take delivery of a Value-payable or Cash on Delivery parcel, it may be returned to the sender.
- 17. In the case of a Value-payable or Cash on Delivery parcel being returned to the sender in Ceylon he shall, before it is delivered to him, sign a receipt therefor.
- 18. After the expiration of six months from the date of despatch of a Value-payable or Cash on Delivery parcel no claims in respect thereof shall be entertained by the Post Office.
- 19. Cash on Delivery or Value-payable parcels received in Ceylon shall be delivered by postmen in the ordinary way: Provided that if the amount to be recovered on any parcel exceeds Rs. 25 the parcel shall be kept at the Post Office to be called for, and notice of its arrival shall be sent to the addressee.
- <sup>1</sup> 20. Until the amount to be remitted to the sender and any other charges due have been paid, no Value-payable or Cash on Delivery parcel shall be allowed to be opened for examination by the addressee.
- 21. Parcels on which the amount to be remitted to the sender has to be collected shall, in the matter of insurance and compensation and in other respects than those specified in these rules, be treated like other parcels.
- 22. After collection the amount to be remitted to the sender shall in no circumstances be refunded to the addressee.

  23. (1) The sender of a Cash on Delivery or Value-
- 23. (1) The sender of a Cash on Delivery or Valuepayable parcel may by written application addressed to the Postmaster of the office of posting request that the parcel be delivered to the addressee free of all charges, or that the sum originally specified for remittance to himself be altered.
- (2) A Postmaster may comply with such a request in regard to parcels received for delivery in Ceylon if the authority is sent through the office of exchange concerned, and is communicated to him by the Colombo Parcels Office of Exchange.
- 24. The Government shall not be deemed to have incurred any liability in respect of the sum specified for remittance to the sender of a Cash on Delivery article, until the recovery of that sum from the addressee.

#### Value-payable Articles.

- 25. (1) Every parcel intended to be transmitted by the Foreign Post as a value-payable parcel shall be presented at a Post Office with the prescribed Customs declaration
- (2) On the cover of the parcel the sender shall specify the sum intended to be remitted to himself and shall also write or impress the words "Value-payable", and his name and address clearly.
- (3) No sum specified on a parcel shall be erased or altered. Any incorrect entry shall be completely obliterated and a fresh entry made.
- 26. The following is the schedule of fees payable at the time of posting and delivery of a value-payable parcel:-

At the Time of Posting. Registration fee of 15 cents per parcel

At the Time of Delivery.

- (1) Money Order Commission 20 cents for every Rs. 10 or fraction thereof
- (2) Customs Clearance Fee 25 cents per parcel

#### Cash on Delivery Parcels.

- 27. (1) Every parcel intended to be transmitted by the Foreign Post as a Cash on Delivery parcel shall be presented at a Post Office with the prescribed Customs declaration
- (2) On the cover of the parcel the sender shall specify the Trade Charge intended to be remitted to himself and shall also write or impress the words "Remboursement" and his name and address clearly.
- (3) No sum specified on a parcel shall be erased or altered. Any incorrect entry shall be completely obliterated and a fresh entry made.
- 28. The sender shall enter in the special Trade Charge Card provided for the purpose all the particulars required in all the blank spaces except that headed "Service Instruct-ions." No erasure or alteration of the entry of the amount of the Trade Charge is allowed.
- 29. The following is the Schedule of fees payable at the time of posting and at the time of delivery of a Cash on Delivery parcel:-

At the Time of Posting.

At the Time of Delivery.

- (1) Cash on Delivery fee of (1) Delivery fee of 20 cents 15 cents for every Rs. 15 per parcel or fraction thereof
- (2) Special posting fee of (2) Customs Clearance fee 10 cents per parcel 25 cents per parcel

# REDIRECTED PARCELS.

30. (i.) (a) Fresh postage at single rates shall be payable on every parcel redirected or returned to or from Ceylon.

- (b) The fresh postage due on any parcel redirected or returned to Ceylon, if it has not been prepaid, shall be collected, together with such Customs and other charges as may be due thereon, at the time of delivery from the
- addressee.
  (c) Where a parcel is returned to the sender at his request
- or as undeliverable in the ordinary course, the postage and other charges aforesaid shall be paid by such sender.

  (d) No parcel addressed to His Majesty's ships shall be transmitted on redirection from Ceylon unless (a) fresh postage at single rates is prepaid or (b) payment of postage at destination is guaranteed irrespective of the delivery or

non-delivery of the parcel.

(e) The fresh postage due on every other parcel redirected from Ceylon shall in every case be prepaid, and no such parcel shall be transmitted unless such postage has been prepaid.

(ii.) Where a parcel or a value-payable article paid for at letter or book rate, is, after arrival in Ceylon, redirected from one address to another in the Island-

- (a) no additional postage shall be payable if the original and the second address are both within the delivery area of the same Post Office and the redirection is made within the period of free redirection; and
- (b) in every other case additional postage shall be payable at the following rates:
  - where the parcel or article does not exceed 20 lb. in weight-half the inland rates payable thereon.
  - where the parcel or article exceeds 20 but does not exceed 21 lb. in weight-Re. 1 12.
  - where the parcel or article exceeds 21 but does not exceed 22 lb. in weight-Re. 1.17.

- (iii.) Where a parcel is not claimed by the first addressee and a second addressee is mentioned by the sender, such parcel shall be forwarded to, and the additional postage and other charges recovered from, the second addressee.
- (iv.) No parcel which has been redirected and on which charges are due may be again redirected unless the charges already incurred have been paid.

#### DELIVERY TO SECOND ADDRESSEE.

- (1) The sender of a parcel may request, at the time of posting, that if the parcel cannot be delivered as addressed, it may either be treated as abandoned or tendered for delivery at a second address in the country of destination.
- (2) Every sender desiring to avail himself of this facility shall write his request on the parcel and the relative Customs Declaration Form in the following words:—
  - "If this parcel is undeliverable to the addressee it should
    - (a) Tendered for delivery to \_\_\_\_\_, finally undeliverable, it should be--, and, if
      - Treated as abandoned, or
      - (2) Returned to me at my expense.
    - (b) Considered as abandoned,

(The alternative not required should be struck out).

Name of sender —

(3) If the sender of a parcel does not wish the parcel to be redirected or if he wishes the percel to be returned to him after a shorter period of detention than the prescribed period he should make a note to that effect on the face of the Despatch Note and on the parcel.

#### CUSTOMS DUTIES ON PARCELS.

- 32, (1) The Import Customs duty charged on any parcel shall be paid before delivery.
- (2) Export duty shall be prepaid by means of postage stamps affixed to the parcel at the time of posting.

#### INSURANCE.

- Subject to the exceptions contained in the following rules Insurance shall cover all risks during transit by land
- 34. Any parcel addressed to any of the countries or places specified in the Post Office Guide, may be insured from the place of posting to its destination up to the limit of value shown against each such country or place.
- 35. (1) Whenever provision has been made for insurance, all parcels containing money, bullion or jewellery shall be insured to their destination or as far as the transmitting postal service permits.
- (2) Parcels containing other articles may be insured at the option of the senders.
- 36. (i.) On every parcel that is to be insured, an insurance fee shall, in addition to the postage, be charged at the rates set out in column 2 of the schedule to this rule for securing compensation not exceeding the respective amounts set out in column 1 of the schedule

- (ii.) The postage and the insurance fee prescribed for insured foreign parcels shall in every case be prepaid by means of postage stamps affixed to the parcel.
- (iii.) The denomination of the stamps to be used shall be so chosen as to make their number as small as possible.
- (iv.) The stamps shall not be folded over the edge of the parcel, and when two or more stamps are used they shall be affixed apart from one another so that they may not serve to conceal injuries to the parcel.

- 37. (i.) Every foreign parcel intended for insurance shall be packed, sealed, and addressed in the manner specified in the Post Office Guide.
- (ii.) No parcel shall be accepted at any Post Office for insurance if it is so small or so covered with writing or scaling wax on the address side, or is made up in such a manner, as to render it impracticable to affix to the parcel the prescribed official labels of the Post Office.
- 38. Every foreign parcel intended for insurance shall be presented at the counter of the Post Office with such Customs declaration and other written information as may be specified in the Post Office Guide.
- 39. Advice of Delivery.—The sender of an insured parcel can obtain an acknowledgment of delivery on payment of a fee at the rate prescribed in rule 7.
- 40. Responsibility of Post Office for Parcels posted in Ceylon and Insured.—(1) In the event of any loss or damage occurring within the Postal Administration of Ceylon to any parcel, or to the contents of any parcel, posted in Ceylon, and where provision for insurance has been made, insured to its destination, compensation not exceeding the amount for which the parcel has been insured may be paid to the sender; and the postage prepaid, exclusive of the insurance fee, may be refunded.
- (2) The sender of a parcel may waive his claim in favour of the addressee.
- (3) Where such loss or damage occurs outside the Postal Administration of Ceylon, the compensation shall not exceed the amount of the liability admitted by the Administration in which the loss or damage occurs.
- (4) In no case shall the compensation payable under either of the above clauses exceed the value of the article lost or the damage sustained.
- (5) No such compensation shall be payable in any of the following cases, namely—  $\,$ 
  - (a) Where the loss or damage has been caused by the fault or negligence of the sender, or arises from the nature of the article;
  - (b) Where the parcel has been fraudulently insured for a sum above the real value of the contents, or there has been any other fraud on the part of the sender or the addressee;
  - (c) Where the insured article has been duly delivered and accepted without reserve;
    (d) Where the sender or addressee has not given inti-
  - (d) Where the sender or addressee has not given intimation of the loss or damage within twelve months from the date of posting;
  - (e) Where the loss or damage was due to improper or insecure packing;(f) Where there is no visible damage to the cover or
  - (f) Where there is no visible damage to the cover or seals;
  - (g) Where the loss or damage is due to causes beyond control (e.g., tempest, ship-wreck, earthquake, war. &c.):
  - war, &c.);
    (h) Where the insured article contained anything the transmission of which by the foreign parcel post is prohibited;
  - (i) Where the insured article cannot be traced in consequence of the destruction of the relative documents through causes beyond control.
- 41. Redirection.—(1) When an insured foreign parcel is redirected or returned from Ceylon to any other country a fresh insurance fee shall be payble for each such transmission.
- (2) Where a fresh insurance fee is due on an insured foreign parcel received in Ceylon by reason of its having been redirected or returned, such fee shall be recoverable on delivery from the addressee or the sender, as the case may be, as if it were postage due.

#### Uninsured Parcels.

- 42. Computsory Insurance.—If an uninsured foreign parcel declared to contain coin or bullion or jewellery or found to contain any of these objects is received from a country with which insured parcels can be exchanged, the parcel may either be intercepted and returned to the sender or forwarded to destination and delivered to the addressee, subject to the payment of a fee of Re. 1. The receipt of this fee however shall not be deemed to impose any liability on the Government of Ceylon in respect of any such parcel.
- 43. Compensation for Loss or Damage of Uninsured Parcels.—(i.) The Postmaster-General may (not in consequence of any legal liability, but voluntarily and as an act of grace) pay to the sender, subject to the provisions of the following paragraphs of this rule, compensation for the loss or damage occurring in Ceylon of uninsured parcels sent by parcel post between Ceylon and such other countries as are specified in the Post Office Guide.

- (ii.) The compensation so paid shall not exceed:
- Rs. 5 for a parcel not exceeding 2 lb. in weight.
- Rs. 13:50 for a parcel exceeding 2 lb. but not exceeding 11 lb. in weight.
- Rs. 21.60 for a parcel exceeding 11 lb. but not exceeding 22 lb. in weight.

and shall not in any case exceed the value of the contents or the measure of the damage caused thereto.

- (iii.) No compensation for damage shall be paid-
- (a) where a parcel contains anything not legally transmissible by post or has not been packed or posted in the manner prescribed, or
- (b) where a parcel contains any liquid or semi-liquid or any article which is composed, wholly or in part, of an exceptionally fragile or brittle material, or which from its nature or construction is peculiarly liable to damage, however carefully it may be packed, or
- (c) where a parcel contains money, watches, or jewellery, or
- (d) where a parcel has been delivered to the addressee and no complaint was made at the time of delivery, or
- (e) where the damage has been caused by the fault or negligence of the sender or arises from the nature of the contents of the parcel, or is due to any tempest, ship-wreck, earthquake, war or other similar causes beyond control.
- (iv.) No compensation shall be paid for the loss of a parcel, where the parcel contained—
  - (a) Anything prohibited or legally not transmissible, or
  - (b) Money, watches or jewellery.
- (v.) No compensation shall be paid for the loss of a parcel, where the loss is due—  $\,$ 
  - (a) to any fault or negligence of the sender, or
  - (b) to tempest, ship-wreck, earthquake, war or other similar causes beyond control.
- (vi.) No compensation shall in any case be payable for injury or damage resulting from the loss of a parcel or any article contained therein or from any damage thereto.
- (vii.) The Postmaster-General may in any case of loss or damage, if he thinks fit, replace the contents of a parcel instead of giving pecuniary compensation.
- (viii.) Where compensation is given for the loss of a parcel or of any article contained therein, the Postmaster-General may in his discretion reserve to himself the right to retain and to dispose of the parcel or article in the event of its being recovered subsequently.
- (ix.) In the case of a parcel lost or damaged in any foreign country or service, the Postmaster-General will, if compensation is payable under the rules of that service or country, endeavour to obtain compensation for the sender subject always to the provisions of this rule.
- 44. Claims for Compensation.—(i.) Every application for compensation under rule 43 shall be made direct to the Postmaster-General within a reasonable time; but in no case shall any application for compensation be entertained which is made more than twelve months after the date of posting of the parcel alleged to be lost or damaged.
- (ii.) The receipt given to the sender at the time of the posting of the parcel alleged to be lost or damaged shall be produced when required.
- (iii.) Where the application is made in respect of any damage to a parcel or of damage to or loss of any article contained therein, the parcel shall be retained by the addressee for inspection as nearly as possible in the state in which it was delivered, and importance will be attached to the point whether the addressee drew attention to any sign of injury borne by the parcel at the time of delivery and whether he opened the parcel, when it was possible for him to do so, in the presence of a responsible officer of the Post Office.
- (iv.) In every case where complaint is made that the contents of a parcel have been abstracted, the empty package shall be produced in proof thereof.
  - 45. Repeal.—The following are hereby repealed—
  - (1) The rules relating to the foreign parcel post, numbered 48 to 73 of the rules dated July 22, 1909, published in the *Gazette* of August 20, 1909, and
  - (2) The schedule of fees in respect of Indian and Foreign Value-payable postal articles published by notification dated January 14, 1933, in Government Gazette No. 7,963 of January 20, 1933.

1. The Minutes of the General Meeting of May 26, 1934, were amended as regards item 5 by the addition of the words "and seconder" after the word "mover" and as regards item 6 by the addition of the following sentence at the end thereof: "Mr. Gunasekara gave a verbal undertaking to remain in the service of the Council for at least ten years".

The minutes of this meeting, as amended, and of the Special Meeting of June 9, 1934, copies thereof having been formulated to each momentum varieties are added as of the Special Meeting of June 9, 1934, copies thereof having been

furnished to each member were taken as read and confirmed.

- 2. Mr. A. C. Mohammedo presented two petitions. These were tabled and the Chairman said that they would
- 3. The Chairman moved that the Council records its sincere regret (a) at the death of Dr. S. P. Joseph, late Provincial Surgeon, Southern Province, and Nominated Member of the Council, and (b) at the death of Mr. F. de S. Abeyratna, late Chief Clerk and Accountant of the Council, and its sympathy with their relatives, and desires that a copy of this resolution be sent to them. Mr. J. E. Perera seconded.—Carried in silence, all present standing.
- 4. The next item on the agenda was the following motion which stood in the name of Mr. S. H. Dahanayaka: "That this Council requests His Excelency the Governor to be graciously pleased to appoint a commission to hold a public inquiry to ascertain whether the death of a man named Girigoris by electrocution on June 11, 1934, at Nothariswatta, Richmond Hill road, Galle, was due to any negligence on the part of the Council's Electricity Department."

  The Chairman explained that as the matter was sub judice, and as he had already written to the Manager of Electrical Undertakings requesting that an inquiry be held, there should be no discussion on the motion.

Mr. S. H. Dahanayaka then formally moved the motion standing in his name. Mr. E. M. Karunaratna seconded.—

(2) That a Market Supervisor possessing the qualifications required for a clerk in this Council be appointed on a salary of Rs. 40 per month with the usual annual increments to fill in the vacancy created by the retirement of the Market Master who in addition to such duties shall relieve the Fish Auction Shed Clerk during the current year ".
- Mr. A. C. Mohammedo objected to the motions being accepted on the ground that they were contrary to the resolution of Council contained in item 8 of the minutes of the meeting of May 26, 1934.

  The Chairman ruled that the motions were in order on the ground that they formed an interim report of the Special

Committee.

- Mr. A. M. Saheed then moved the first motion standing in his name. Mr. E. A. Paulas seconded. Mohammedo spoke against the motion. Mr. S. H. Dahanayaka and Mr. E. M. Karunatatna supported the motion. Mr. J. E. Perera also spoke. The mover then replied. The Chairman moved as an amendment that the matter be referred to the Standing Committee on Finance and Assessment (with Mr. A. M. Saheed as co-opted member (for further consideration and report as to what terms and conditions should be imposed on the renter. Mr. D. I. Durham seconded.-Carried.
- Mr. A. M. Saheed then moved the second motion standing in his name. Mr. E. A. Paulas seconded. (1) Carried. (2) Resolved that the appointment be made with effect from August 1, 1934, and that meanwhile the present arrange-



from the coconut in one chain of operations."

Abstract.—The dust from the husk is mixed with pulverized shell and a cementing agent and compressed to form fuel briquettes. The milk or emulsion obtained from the flesh of the coconut is converted into cream by the application of heat, a small amount of acid being added to hasten the coagulation. The coconut water is used for extracting the remaining sugars from the cream and thereby the sugar content of the coconut water is raised so that it may be used as a source of sugar or alchol. Oil may be extracted from the cream after this has been con-centrated to a solid mass and after extraction of the oil the residue is desiccated and yields a coconut flour.

Abstract.—An electric heating device for heating bowl-Assiract.—An electric heating device for heating bowl-shaped cooking utensils comprising a block of refractory material hollowed to correspond with the base of the cooking utensil and having concentric grooves in the hollow portion to hold the electrical heating resistances. The outer groove is provided with passages to allow liquid, which may collect in the groove, to escape. In the centre of the block is a metallic spring the upper end of which makes contact with the base of the cooking utensil while the lower end is connected with an earth terminal for the purpose of earthing the utensil.
