No. 45 of 1917.

An Ordinance to amend the Irrigation Ordinance, No. 45 of 1917.

BE it enacted by the Governor of Ceylon, with the advice and consent of the State Council thereof, as follows :--1 This Ordinance may be cited as the Irrigation Amend-

Short title.

Amondment of section 15 of Ordinance No. 45 of 1917. 2 Sub-section (1) of section 15 of the Irrigation Ordinance. No. 45 of 1917, is hereby repealed and the following subsection is substituted therefor :---

of 1934.

"(1) Any proprietor may by proxy in writing authorise any other person to represent him and to vote on his behalf at any meeting of proprietors held for the purposes of this. Chapter ; and a proprietor who is so represented at any such meeting shall be deemed to be present thereat for the purpose of determining whether the meeting is validly constituted or whether any resolution has been duly passed by a majority of proprietors."

Objects and Reasons.

The object of this Bill is to enlarge the scope of section 15 (1) of the Irrigation Ordinance, No. 45 of 1917, so as to enable any proprietor to be represented at any meeting held under Chapter III. of the Ordinance by a person authorised by proxy to vote on his behalf.

2. At present, a proxy-holder is entitled to represent a proprietor only at meetings convened for the purposes mentioned in paragraphs (b) and (c) of section 12. The amendment introduced by this Bill will enable a proxy-holder to represent a proprietor at meetings convened for the purpose of making rules under section 11 and for the exercise of all the powers conferred by section 12.
