ORDINANCE NO. 1 OF 1871.

REGULATIONS made by the Governor by virtue of the powers vested in him by section 8 of Ordinance No. 1 of 1871 and by Article 93 of the Ceylon (State Council) Order in Council, 1931.

REGULATIONS.

1. No person having in his possession any article for sale shall enter the Customs premises at Galle for the purpose of trade, whether on those premises or on board any vessel lying in the harbour, unless he is the holder of a licence issued under these regulations.

2. The grant of any licence under these regulations shall be at the absolute discretion of the Collector of Customs, Galle, and every licence issued shall be under his hand.

3. Every person whose application for a licence is allowed by the Collector, shall before the licence is issued to him

(a) deposit a cash security of Rs. 10 in the office of the Collector, and (b) sign a bond declaring the deposit liable to forfeiture

at the discretion of the Collector in the event of a breach of any of the conditions of the licence or of any of the rules or regulations of the Customs or of the Port.

4. Every licence under these regulations shall be subject to the following conditions :-

(1) The licensee shall not for any of the purposes of his trade-

(a) enter or leave the Customs premises otherwise than through Jetty No. 1, or

(b) enter the Customs premises before 6 A.M. or remain therein after 7 P.M. on any day.

(2) The licensee shall provide himself with a suitable book and enter therein a complete and reasonably descriptive list of the articles to be taken by him to the Customs premises for purposes of trade each day.

(3) The licensee shall not enter the Customs premises at any time unless the articles brought by him have first been produced for inspection before the officer on duty

at the shore-end of Jetty No. I, and the list in the licensee's book has been checked, initialled, and dated by that officer. (4) In the event of any of the articles so taken in remaining unsold on his return, the licensee shall not remove them from the Customs premises until they have been inspected, and the list checked, marked, initialled, and dated, by the officer on duty at the same point on Jetty No. 1:

(5) The licensee shall not bring ashore from any vessel in the harbour, or remove from the Customs premises, any article not included in the list checked, and initialled by the officer at the time of the licensee's entry into the Customs premises.

(6) The book required by the foregoing conditions shall remain in the possession of the licensee at all times when he is engaged in his trade, and shall be produced for inspection whenever demanded by any Customs or Police Officer.

(7) The licensee shall not bring into the Customs premises for the purposes of trade-(a) any article on which export duty is payable, or (b) any synthetic or imitation stone or culture pearl.

5. (1) Every person contravening the foregoing regulation 1, or any of the conditions of a licence, shall be guilty of an offence punishable on summary conviction with a fine not exceeding twenty-five rupees.

(2) On a second or subsequent conviction of a breach of any of the conditions of a licence the sentence may include the cancellation of the licence.

(3) It shall be lawful for the Collector in his discretion to declare the security deposited by any licensee to be forfeited in accordance with the terms of the aforesaid bond, either as an alternative to a prosecution for a breach of any of the conditions of the licence, or in addition to any fine imposed by a court on a prosecution duly entered therefor.

BY-LAWS.

1. In the event of the death or resignation of the Chairman of this Council, it shall be the duty of the Vice-Chairman within three days from the date of such death or resignation to summon a meeting of the Council for a date within seven days of the death or resignation of such Chairman for the purpose of electing a successor. Should he fail or neglect to do so or should there be no Vice-Chairman in office, the Secretary for the time being in office shall summon such meeting within forty-eight hours of the expiry of the said three days for a date within the aforesaid period of seven days.

2. After the expiry of the term of office of the members of this Council; the Secretary for the time being in office shall summon the first meeting of the new Council to be held on a day within ten days from the beginning of the year.

BY-LAWS made by the Nawalapitiya Urban District Council under sections 164 and 168 (4) (f), 173, and 175 of the Local Government Ordinance, No. 11 of 192C, and approved by the Local Government Board and confirmed by the Governor by virtue of the powers vested in him by the said section 164 and by Article 93 of the Ceylon (State Council) Order in Council, 1931.

BY-LAWS (RELATING TO THE TAX ON VEHICLES

1. The returns required to be furnished under section 179 of the Ordinance by an owner or other person whether resident within the Urban area or outside and liable or deemed to be liable to pay taxes in respect of animals or vehicles shall be made in the form supplied by the Council for that purpose and shall be filled up and returned by the person to whom such form is addressed.

2. (1) If any person, after having filled up and returned such return acquires, keeps, or uses any vehicle or animal, not mentioned in such return, he shall within one month of acquiring any such vehicle or animal, notify the Chairman in writing of the fact of such acquisition, keeping, or use, and further furnish true and correct information in respect of every such vehicle or animal so acquired, kept, or used.

of every such vehicle or animal so acquired, kept, or used. (2) Whoever fails or neglects to notify the Chairman or to furmish information as required by the foregoing paragraph of this by-law shall be guilty of an offence punishable with a fine not exceeding twenty-five rupees.

3. Subject to the provisions of section 175 of the Ordinance every person who has furnished the return referred to in by-law 1 shall without further notice be liable, in respect of every vehicle or animal entered in such return, to pay the tax for the year for which such return is furnished and every person who has sent the written notice required by by-law 2 shall be liable to pay the tax on every vehicle or animal referred to in such notice for the year in which such vehicle or animal was acquired by him or otherwise came into his possession.

4. Any person who has furnished the return required by by-law 1 or the written notice required by by-law 2 may by written notice given to the Chairman claim to be exempted from the liability to pay any tax in respect of a vehicle or an animal which has been in his possession for less than 30 days in any year and is entered in or referred to in such return or notice.

5. The annual tax prescribed under the provisions of section 175 of the Ordinance shall be paid on or before the thirty-first day of March in every year in respect of all vehicles, other than those exempted by the Ordinance, and in respect of every horse, pony, or mule kept or used within the administrative limits of the Nawalapitiya Urban District Council.

6. The annual tax aforesaid shall be paid by the persons liable to pay the same at the Office of the Nawalapitiya Urban District Council whether the same shall have been demanded or not; and any person failing or neglecting to pay such tax after it shall have become due from him shall be guilty of an offence punishable with a fine not exceeding fifty rupees.

7. On payment of the annual tax the Chairman shall issue or cause to be issued in respect of every vehicle for which such tax is paid a metal plate with distinguishing letters for the several kinds of vehicles as specified in the schedule hereto and with figures denoting the year for which the plate is issued and the corresponding number in the register of vehicles. Such plate shall be fixed on a conspicuous part of the vehicle in respect of which the plate was issued. Provided that when any plate becomes indistinct or defaced by use or otherwise, the owner shall return it to the Chairman and shall be entitled, on making a payment of 25 cents to receive a fresh plate; and provided further that the Chairman may, on his being satisfied by affidavit or otherwise that any plate has been lost or stolen, issue a fresh plate on the application of the owner and on payment by 150 cents.

8. Where the plate prescribed by these by-laws has not been duly affixed to any vehicle kept or used within the administrative limits of the Nawalapitiya Urban District Council the owner or person in charge of that vehicle shall be guilty of an offence punishable with a fine not exceeding tifteen rupees.

(State Council) Order in Council, 1931.

BY-LAWS.

Colombo, October 8, 1934.

1. In these by-laws the expression "game" means and includes sambur, spotted deer, red or barking deer, paddy field deer, peafowl, Ceylon spur fowl, water lizard, talagoya, and any wild animal or bird hunted for sport or for food.

2. Within the administrative limits of this Council, no person shall without the written permission of the Chairman obtained in addition to such licence as may be required under the Game Protection Ordinance, 1909—

- take, kill, capture, or attempt to take, kill, or capture, or in any way interfere with any game or wild birds other than the crow (corvus coronoides culminatus), and birds of prey; or
- (2) take or destroy or attempt to take or destroy the nest or the young or the eggs of any wild bird other than the crow and birds of prey; or
- (3) discharge any firearm or air gun or use a catapult, or do any act calculated to frighten or scare away game or wild birds.

3. No person shall, without the written permission of the Chairman, root out, destroy, or wilfully damage any flower-plant, or tree in any waste or public land or open space or public recreation ground within the administrative limits of this Council.

4. Any person contravening any of the provisions of the foregoing by-laws shall be guilty of an offence punish-able with a fine not exceeding fifty rupees.

- (b) For Mid-country Estates: 43 cents for a man, 35 cents for a woman, 25 cents for a child.

(2) That on all estates to which the rates are applicable clean unblended rice of good quality will also be issued free of cost at the rate of one-eighth of a bushel per month to each working man and that rice will also be issued at a similar rate to each widow employed who has one or more non-working children; provided that instead of the free issue of rice herein referred to employers may, with the consent of the Controller of Labour previously obtained and unless and until such consent be withdrawn provide one good and unstinted meal of rice and curry daily to each and every Indian child under ten years of age resident on their estates and related to the Indian labourers employed thereon.

Regulation 24 of the Table "C" is expressly excluded and the following regulation substituted therefor, namely :---

24. Subsequent General Meetings shall be held at least one in every year at such time and places as may be determined by the Directors.

3. A quorum at any General or Extraordinary General Meeting of the Company shall consist of not less than five Shareholders personally present, and Regulation 32 of Table "C" is modified accordingly.

4. Regulation 35 of the Table " C " is expressly excluded from these Articles.

39A. On a show of hands every Shareholder present in person shall have one vote. On a poll every Shareholder shall have one vote for each share of which he is the Shareholder.

B. No Shareholder shall be entitled to vote at any General Meeting unless all calls or other sums presently payable by him in respect of the shares in the Company have been paid.

 45_{Λ} . Until otherwise determined by a General Meeting only holders of 100 or more shares shall be entitled to be appointed as Directors of the Company.

B. The number of Directors shall not be less than three nor more than five, but this regulation shall be construed as being directory only and the continuing Directors or Director may act notwithstanding any number of vacancies.

c. The first Directors of the Company shall be Joseph Boniface Michael Pereira, Joseph Gabriel Charles de Silva Wijeyeratne, and Miss Sheila May do Silva, all of Colombo, who shall remain in office till the Annual General Meeting. As remuneration for their services the Directors shall be entitled to appropriate such sum as shall be provided by the Company in General Meeting.

D. A Director may with the consent of his Co-Directors be absent from the Meetings of Directors for such period or periods as the remaining Directors shall think fit.


