Pending the passing of the Ordinance allotments will be held upon permits which will include the following amongst other conditions:—

(vi.) The permit-holder shall surrender free of compensation any portion of the land allotted to him which may be required hereafter by the Government for roads, channels, or any other purpose.

(vii.) The permit-holder may nominate a person to whom he desires that the Government Agent, Province of Uva, should issue a fresh permit in the event of the death of the permit-holder during the term of the permit.

(viii.) The permit shall be personal to the permit-holder and shall terminate with his death.

(ix.) On the termination of the permit the land shall revert to the Crown and no person shall have any right to claim compensation from the Crown for any improvements made upon it.

(x.) In the event of the termination of the permit by the death of the permit-holder the Government Agent, Province of Uva, may at his discretion issue a fresh permit for the land to the person nominated by the late permit-holder, if he considers him a fit person, or to any dependent of the late permit-holder or to any other person.
