GREETING.

Whereas We deem it expedient that a Commission should issue appointing the persons named herein to visit the several provinces of the Island and, after hearing such evidence as they may deem necessary, to make recommendations for any readjustments which the Commission may consider expedient in the boundaries of the electoral districts as defined by Proclamations by the Governor dated July 4 and 29, 1930, for the election of members of the State Council, it being a condition of any recommendations which the Commission may make that the boundaries of electoral districts should coincide with those of revenue districts or of Headmen's divisions or of areas under the jurisdiction of local authorities:

Now know Ye that We, the said Governor, reposing great trust and confidence in your prudence, ability, and fidelity, have, in pursuance of the powers in Us vested by the Ordinance No. 9 of 1872, and Article 93 of the Ceylon (State Council) Order in Council, 1931, nominated, constituted, and appointed, and by these Presents do nominate, constitute, and appoint you, MAXWELL MACLAGAN WEDDERBURN, Esquire, John Christopher Wilberforce Rock, Esquire, Stanley Obeyesekere, Esquire, King's Counsel, to be Our Commissioners for the purposes aforesaid, with authority to exercise all the powers which Commissioners appointed under the said Ordinance may lawfully use and exercise:

WHIREAS the trustees of the Sri Kalyanodaya Society, Kandy (hereinafter called "The Society") hold certain moneys and property in trust for a charitable purpose, to wit, Social Service, to be rendered by providing free medical relief to the poor, by the establishment of a free vernacular reading room, and by the performance of such other acts of charity as are provided for in the rules of The Society:

have applied to the Governor for their incorporation under section 114 of "The Trusts Ordinance, No. 9 of 1917":

2. The moneys and property now held by the trustees first mentioned, and all moneys and property which may be acquired by them or by "The Trustees" at any time hereafter, shall be vested in "The Trustees" for the time being, with full authority to utilize them for the purposes of "The Society" or to invest them on such securities as are prescribed by section 20 of the aforesaid Ordinance and on no others.

In the event of a vacancy occurring among "The Trustees" by the death, the resignation, or the removal under the foregoing condition 3, of any one of them, the remaining Trustees may appoint provisionally some fit remaining Trustees may appoint provisionally some it and proper person to fill such vacancy, and every person so appointed shall be deemed for all purposes to be a duly appointed Trustee until the General Meeting of "The Society" held next after the date of his appointment, and no longer, unless his appointment be then confirmed by resolution of "The Society".

5. A General Meeting of "The Society" shall be held in June of each year when the accounts of "The Society" for the year ending 28th February next preceding, duly audited by its Auditors, shall be presented, and such accounts when passed by "The Society" shall be published in the Gazette

6. The office-bearers of "The Society" shall be a Chairman, two Vice-Chairmen, a Treasurer, and one or more Secretaries elected or appointed in accordance with the rules of "The Society".

7. A General Meeting of "The Society" may from time to time revoke or amend the rules of "The Society", and make, amend, and revoke new rules for the proper working of "The Society" and the management, regulation, and control of all its affairs, provided that no rule so made or amended shall be inconsistent with these Conditions.

8. This Order may from time to time be varied or amended by order of the Governor.

By-LAWS.

The by-laws relating to dairies published by Notification in the Gazette of January 18, 1929, are hereby amended:

- (1) by the deletion, from the heading of the part or chapter thereof numbered II., of the words "and for sale of milk"; and
- (2) by the insertion, immediately after the aforesaid part or Chapter II., of the following new part or chapter:

III.—Regulations for Sale of Milk generally

No person who is not a licensee of a dairy as aforesaid, shall himself, or by any agent or servant, sell or deliver, or expose, keep, carry, hawk, or offer for sale, any milk within the administrative limits of the Council, save in accordance with the conditions hereinafter prescribed.

2. (i.) Every such person, whether resident within or without the limits of the Council, who desires to sell or supply for money milk in any quantity to any person or persons within the limits of the Council, shall cause himself to be registered in the books of the Council as a purveyor or supplier of milk.

(ii.) Such registration shall be free of all fees or charges. 3. Every such person shall, by proper application made for that purpose, further cause registration-cards to be issued annually by the Chairman to each servant, vendor, or agent, whether paid or unpaid, employed by him in the work of selling or delivering milk.

- 4. Any contravention of, or non-compliance with, the foregoing provisions shall be an offence.
 5. (1) The Chairman may in his discretion refuse to register as a purveyor or supplier of milk under the foregoing by-law 2, any person who has not been recommended for registration, after such inspection, as may be necessary, of his premises, his animals, and his utensils and equipment generally-
 - (a) if he is a resident within the administrative limits of the Council, by the Medical Officer of Health of the Council; or
 - (b) if he is resident in any area outside the limits of the Council, by the Chairman of any duly constituted local authority there may area, or if there is none, by the Medical Officer of Health for the district in which such area lies.
- (2) The Chairman may likewise refuse to issue any registration-cards, under the foregoing by-law 3, until a Medical Officer deputed by him has examined and found each such servant, vendor, or agent to be free from any infectious or contagious disease and from diseases of the skin.
- The registration-cards so issued by the Chairman shall include the following particulars:-

(a) employer's name and number on register;

- (b) name of vendor or servant or agent, and his thumb impression.
- 7. It shall be an offence for any person to deliver milk or to carry or hawk milk for sale within the limits of the Council, unless he has in his possession a registrationcard for the current year duly issued as aforesaid.
- 8. (i.) It shall be an offence for any person delivering milk or carrying or hawking milk for sale within the limits of the Council, to refuse, or to fail for any reason, to produce for inspection a duly issued registration-card for the current year, when called upon to do so by a Sanitary Inspector or by any person specially or generally authorized by the Chairman in that behalf.
- (ii.) In the event of any person so refusing or failing to produce such card, it shall be lawful for such Sanitary Inspector or other authorized person to exercise the powers given to peace officers by section 33 (1) of the Criminal Procedure Code, 1898.

- 9. It shall be an offence for any person to sell or deliver or to expose, keep, hawk, or offer for sale, within the limits of the Council—
 - (i.) any milk from which the cream has been removed. unless such milk is contained in a vessel which is distinctly and conspicuously labelled "Skimmed milk" in English, and the equivalent term in Sinhalese and Tamil, and is sold as such.
 - (ii.) any milk adulterated with water or any other foreign substance or liquid; provided that milk, to which tea, coffee, or cacao has been added for consumption on the premises of any tea or coffee boutique or eating-house, shall not be deemed to be adulterated for the purpose of this

(iii.) any milk contained in bottles of which the mouth is not covered with paper or other impermeable material.

10. If any person found guilty of an offence under the foregoing by law 9 is proved to be the agent or servant, whether paid or unpaid, of any other person, such other person shall also be liable to be punished for the same offence, unless he proves to the satisfaction of the court that he had given all necessary instructions and used due diligence to ensure compliance, and that the offence was due to an act or default of his agent, or servant without his own knowledge, consent, or connivance.

BY-LAWS REFERRED TO.

Meetings: Notice, Agenda, Quorum, &c.

1. (a) There shall be twelve General Meetings of the Council in every year for the transaction of business.

(b) The general meetings of the Council shall be held at

the Puttalam Urban District Council Office at least once every month on such day and at such hour as the Council may from time to time resolve, or as soon after that hour as may seem expedient to the Chairman.

(c) A special meeting may be held at the place aforesaid on such date and at such hour as the Chairman shall for

each such meeting specially appoint.

(d) Notice of every such meeting and of the business to be transacted at it shall be served on each Councillor at least three daysexclusive of Sundays and Government holidays - before the meeting.

(e) No business shall be brought before or transacted at any meeting, general or special, other than the business specified in the notice of the meeting, without the permission of the Council.

(f) No business shall be transacted at any meeting unless quorum of at least four Councillors is present.

(g) If at any meeting there is not a sufficient number of Councillors present to form a quorum, the Chairman shall adjourn the meeting to such date not more than fifteen days after the date of the meeting so adjourned as he thinks fit, and the business which would have been brought before the meeting so adjourned, if there had been a quorum present, shall be brought before, and disposed of, at such adjourned meeting.

Adjournment of Meetings.

(a) The Chairman of any meeting, general or special, at which a quorum of the Council is present may, with the consent of the meeting, adjourn the meeting from time to time; but no business shall be transacted without the permission of the Council at any adjourned meeting other than the business left unfinished at the meeting from which such adjournment took place.

(b) Notice of an adjourned meeting shall be served on members at least twenty-four hours before the time fixed for such meeting unless the original meeting decides to hold the adjourned sitting within twenty-four hours.

Presence of Strangers.

Strangers, including the Press, may be present at meetings in the places set apart for them, but must withdraw when called upon to do so by the Chairman, when in the opinion of the majority of the members of the Council present at the meeting, expressed by resolution, such exclusion is deemed advisable in the public interest.

Order of Business.

- 4. The business of the Council shall be transacted in the following order:
 - (a) Confirmation of the minutes of the last preceding meeting.
 - (b) Memorials, petitions, complaints, and communications addressed to the Council shall be laid before the Council.
 - (c) Questions of which due notice has been given.

(d) Motions of which due notice has been given.
(e) Any other matter set down in the notice of the meeting in the order in which such matters are set out or in such order as the Council may for special reasons adopt.

(f) Monthly statements of receipts and disbursements, progress reports of works, and such other documents as are required by the Council, shall be submitted to the Council. Order of Precedence.

5. For all purposes connected with the Council, the precedence and seniority of Councillors shall be regulated as follows:

After the Chairman shall rank the Vice-Chairman and then the Councillors in order of the priority of their nomination or election and in the case of former Councillors re-elected or re-nominated, of the priority of their continuous membership of Council (such continuous membership being deemed to be unimpaired during the absence of a nominated member for whom a temporary successor has been nominated).

Minutes.

The minutes of each meeting shall be circulated. the next or some subsequent meeting the question shall be put that the minutes be taken as read and confirmed. In the absence of objection or correction, the minutes as recorded shall be confirmed.

Memorials, Petitions, &c.

7. (a) A member presenting a petition or memorial to the Council may state concisely the purpose of the petition or memorial.

(b) No member shall present any petition or memorial or other communication which is not respectful in tone

throughout.

(c) It shall be competent for any member to move that such petition or memorial be read. In making such motion he shall state concisely his reasons for wishing to have it

(d) No debate shall be permitted on such motion, nor shall any other member speak upon or in relation to such petition or memorial, except to second the motion formally.

(e) Such motion being seconded, the question shall be

put whether the petition or memorial shall be read.

Questions.

(a) Questions relating to the affairs of the Council

may be put to the Chairman.

(b) At least seven clear days' notice—exclusive of Sundays and Government holidays—shall be given of such questions.

(c) A written reply shall be read by the Chairman to

each question.

(d) No member shall address the Council upon any question, nor shall the terms of any question contain any argument or expression of opinion or statement of fact, except in so far as may be necessary to explain such question.

(e) Any member may put a supplementary question for the purpose of further elucidating any matter of fact

regarding which an arswer has been given.

Provided that the Chairman may disallow any supplementary question if, in his opinion, it infringes the rules as to the subject matter of questions, and in that case the question shall not appear on the record of the minutes of the Council.

Motions.

(a) Every notice of motion shall be in writing signed by the member of the Council giving the notice. Unless such notice has been in the hands of the Secretary seven clear days—exclusive of Sundays and Government holidays—before the meeting of Council, the motion may not be included in the agenda.

(b) All notices of motions shall be dated and numbered as received, and shall be entered by the Secretary upon the

agenda in the order in which they are received.

(c) Before any notice of motion is placed on the agenda paper, it shall be submitted to the Chairman, who, if he be of opinion that it is out of order, shall order that such motion shall not be included in the agenda and shall cause the giver of the notice to be so informed.

(d) Every motion of which notice is given shall be relevant to some question affecting the administration of the Council's

affairs.

(e) No motion to rescind any resolution which has been passed within the preceding six months, nor any motion to the same effect as any motion which has been negatived within the preceding six months, shall be deemed to be in order, unless notice thereof shall have been given and specified in the agenda, and the notice shall bear, in addition to the member who proposes the motion, the signatures of seven other members; and when such motion has been disposed of, it shall not be competent for any member to propose any similar motion within the period of six months next following.

(f) No motion shall be deemed to have been submitted

for debate until it shall have been proposed and seconded.

(g) Any member may second a motion or amendment by rising in his place and bowing to the Chair, without prejudice to his right to speak at a later period of the debate

(h) Before any motion of which previous notice has not been given, is moved in Council, it shall be reduced to writing

signed by the mover and handed to the Secretary.

(i) When a motion has been moved and seconded and the debate thereon concluded, the question thereupon shall be put to the vote by the Chairman.

Withdrawal of Motion or Amendment.

A member who has moved a motion or amendment may withdraw the same by leave of the Council, which shall be signified without debate, and it shall not be competent for any member to speak upon it after the mover has asked for permission for its withdrawal, unless such permission shall have been refused.

Reintroduction of Motion.

A motion which has been withdrawn may be moved again at any subsequent meeting; but no motion shall be proposed which is the same in substance as any motion which within the period of six months referred to in rule 9 (e) shall have been resolved in the affirmative or negative.

Amendments.

12. (a) Every amendment shall be in writing and handed to the Secretary by the member proposing it.

(b) Every amendment shall be relevant to the motion during the discussion of which it is moved.(c) Every amendment shall be read before being moved.

(d) No amendment shall be discussed or put to the Council

until it shall have been seconded.

(e) A member who has seconded an amendment in a formal manner shall be permitted afterwards to speak

(f) Whenever an amendment to any motion under discussion has been moved and seconded, no second or subsequent amendment shall be moved until the first amendment shall have been disposed of. If an amendment be carried, the motion as amended shall take the place of the original motion, and shall become the question upon which any further amendment may be moved.

Debate ceases when Question fully put.

13. No member may speak to any question after the same has been fully put by the Chairman. A question is fully put when the voting has been taken thereon.

Voting and Recording of Votes.

(a) The question shall be put by the Chairman, and the votes may be taken by a show of hands or by a secret ballot as the Council decides, and the result shall be declared by the Chairman; but in any case where the votes are taken otherwise than by secret ballot, any member may call for a division, and in that event the votes shall be taken by the Secretary asking each member separately, according to the order of precedence, how he desires to vote, and recording the votes accordingly.

(b) On any question being put, whether in Council or in Committee of the whole Council, every member present shall record his vote, either for the ayes or the noes.

Casting Vote of Chairman.

(c) The Chairman shall have an original vote in common with other members whether in Council or Committee of the whole Council, and also a casting vote if upon any question the votes are equal.

Members dissenting.

15. It shall be competent for any Councillor, who is in a minority, to record the reasons for his dissent from the opinion of the majority, and such written dissent, if sent to the Secretary within one week of the meeting in question, shall be entered by the Secretary at the end of his minutes of the proceedings.

Order of the Day.

16. The "Order of the Day" shall include all business, arranged according to rule No. 4. Unless otherwise resolved the business shall be taken in the order printed.

Preservation of Order.

- 17. (a) It shall be the duty of the Chairman to preserve order, and his decision on all disputed points of order shall be final.
- (b) Any member of the Council deviating from the rules may be immediately called to order by the Chairman of his own motion or on any other member of the Council rising to a point of order.

Decision of Questions of Order.

When the question of order has been stated, the member who raises it shall resume his seat, and no other member, except by leave of the Chairman, shall rise till the Chairman has decided the question, after which the member who was addressing the Council or Committee of the Council at the time the question was raised shall be entitled to proceed with his speech, if he conforms to the Chairman's ruling. If he does not conform, the Chairman may refuse to allow him to proceed with his speech.

Member not explaining or retracting.

Any member who fails to explain or to retract any objectionable words used by him, or to offer apologies for the use thereof to the satisfaction of the Council, may be censured or otherwise dealt with as the Council thinks fit.

Chairman speaking.

20. When the Chairman is addressing the Council or Committee of the Council, any member then standing shall immediately resume his seat.

Naming of Members.

- (a) The Chairman may name any member immediately after the commission of the offence of disregarding the authority of the Chair, or of abusing the rules of the Council by persistently and wilfully obstructing the business of the Council, and the Chairman may forthwith put the question on a motion being made by any member or from the Chair (no amendment, adjournment, or debate being allowed) "that such member be suspended from the service of the Council".
- (b) If any such motion be carried and any member be suspended under this rule, his suspension on the first occasion shall continue for one month, on the second occasion for two months, and on the third or subsequent occasion for three months.

(c) Not more than one member shall be named at the same time, unless several members present together have jointly disregarded the authority of the Chair.

(d) If any member or members acting jointly, who have been suspended under this rule from the service of the Council, shall refuse at any time during the period of suspension to obey the directions of the Chairman to withdraw from the precincts of the Council Chamber, the Chairman may direct such steps to be taken as are required to enforce his decision. required to enforce his decision.

Irrelevance or Tedious Repetition.

22. The Chairman after having called the attention of the Council or Council in Committee to the conduct of a member who persists in irrelevance or tedious repetition, either of his own arguments or of the arguments used by other members in debate, may direct the member to discontinue his speech.

Disorderly Conduct.

23. (a) The Chairman may order members whose conduct is grossly disorderly to withdraw immediately from the Council Chamber during the remainder of the meeting, and may direct such steps to be taken as are required to enforce his order.

(b) If on any occasion the Chairman deems that his powers under this rule are inadequate he may name such

member or members in pursuance of rule 21.

Duty to obey Order of Suspension or Withdrawal.

24. Members who are suspended under rule 21, or are directed to withdraw under rule 23, shall forthwith withdraw from the precincts of the Council Chamber.

Power to adjourn.

An adjournment of the discussion of any question may be moved by a Councillor at any time, and, if seconded,

shall be forthwith put to the vote.

In the event of grave disorder arising at any meeting of the Council or Committee of the Council, the Chairman may, if he thinks it necessary to do so, adjourn the meeting without putting the question of adjournment to the house, or suspend the meeting for a time to be named by him.

Rules for Members speaking.

- 27. In speaking to any proposition under consideration of the Council or a Committee of the whole Council, the following rules shall be strictly observed:
 - (a) Every member shall address his observations to the Chairman, and shall speak standing except in Committee.
 - (b) He shall not be interrupted unless he is out of order.

(c) When he has finished his observations he shall resume his seat, and any other member wishing to address the Council may rise.

(d) A member shall not read his speech, but he may read extracts from written or printed papers in

support of his argument.

(e) If two members rise at the same time, the Chairman shall call on the member who first catches his eye.

(f) Every member shall confine his observations to the

subject under consideration.

(g) No member shall impute improper motives to any other member.

All remarks of a personal nature shall be avoided (i) A member may speak to the question before the Council or any amendment proposed thereto.

(j) No member shall speak more than once on any proposition before the Council, except in explanation or to order, or when the Council is in Committee, or as is provided by rule 12 (e).

(k) By the indulgence of the Council, a member may

explain matters of a personal nature, although there be no question before the Council, but such matters may not be debated, and he must confine himself strictly to the vindication of his own conduct.

(1) The mover of any resolution or motion may reply after all the members present have bad an opportunity of addressing the Council and before the question is put, but he shall strictly confine himself to answering previous speakers, and shall not introduce any new matter into the debate. The right of reply shall not extend to the mover of an experient. of an amendment.

Committee of Council.

28. The Council may at any time resolve themselves into a committee of the whole Council, and, on their resuming, the result of their deliberations shall be dealt

with by the Council.

29. It shall be competent for any member at any stage of any discussion in a committee of the whole Council to move that the Council do resume. The question shall be put to the vote by the Chairman, and if the motion carried, the Council will immediately resume from Committee.

Special Committees.

30. (a) The Council may from time to time appoint from among their own number such special or standing committees, consisting of such number of Councillors as they think fit for the purpose of inquiring into and reporting upon any matters connected with the purposes of the Local Government Ordinance.

(b) No such committee shall take any proceedings after the close of the year during which it shall have been so

appointed as aforesaid.

(c) The quorum for the meetings of every such committee

shall be three, unless otherwise specially fixed.

(d) In the absence of the Chairman at a meeting of any Committee, the members present shall choose one of their own members to preside, and such member shall for that meeting have all the powers of the Chairman. (e) When a committee shall have agreed to a report the

same shall be signed by each of the members thereof and shall, together with the minutes of proceedings, be submitted

to the Council.

.

- (/) In the event of any division taking place in a committee, a record thereof shall be entered in the minutes together with the motion or resolution proposed, the name of the proposer, and the respective votes of the members present, and such minutes shall be submitted with the report of such committee.
- The Press shall be excluded from all meetings of special and standing committees.

REPEAL.

The by-law regarding the time and place of meetings of the Council published in the Gazette of February 24, 1933, and the by-law regarding the quorum at meetings of the Council published in the Gazette of March 31, 1933, are hereby repealed.

BY-LAWS.

The by-laws relating to dairies published by Notification in the Gazette of October 29, 1926, are hereby amended—

(i.) by the deletion, from the heading of the part or chapter thereof numbered II., of the words "and for sale of milk"; and

(ii.) by the insertion, immediately after the aforesaid part or Chapter II., of the following new part

or chapter :-

III.—Regulations for Sale of Milk generally.

1. No person who is not a licensee of a dairy as aforesaid, shall himself, or by any agent or servant, sell or deliver, or expose, keep, carry, hawk, or offer for sale, any milk within the administrative limits of the Council, save in accordance with the conditions hereinafter prescribed.

2. (i.) Every such person, whether resident within or without the limits of the Council, who desires to sell or supply for money milk in any quantity to any person or persons within the limits of the Council, shall cause himself to be registered in the books of the Council as a purveyor

or supplier of milk.

or supplier of milk.

(ii.) Such registration shall be free of all fees or charges.

3. Every such person shall, by proper application made for that purpose, further cause registration-cards to be issued annually by the Chairman to each servant, vendor, or agent, whether paid or unpaid, employed by him in the work of selling or delivering milk.

4. Any contravention of, or non-compliance with, the

5. (1) The Chairman may in his discretion refuse to register as a purveyor or supplier of milk under the foregoing by-law 2, any person who has not been recommended for registration, after such inspection, as may be necessary, of his premises, his animals, and his utensils and equipment generally.

(a) if he is a resident within the administrative limits of the Council, by the Medical Officer of Health of

the Council; or

- (b) if he is resident in any area outside the limits of the Council, by the Chairman of any duly constituted local authority there may be in such area, or if there is none, by the Medical Officer of Health for the district in which such area lies.
- (2) The Chairman may likewise refuse to issue any registration-eards, under the foregoing by-law 3, until a Medical Officer deputed by him has examined and found each such servant, vendor, or agent to be free from any infectious or contagious disease and from diseases of the
- The registration-cards so issued by the Chairman shall include the following particulars:

(a) employer's name and number on register,

- (b) name of vendor or servant or agent, and his thumb
- 7. It shall be an offence for any person to deliver milk or to carry or hawk milk for sale within the limits of the
- Council, unless he has in his possession a registration-card for the current year duly issued as aforesaid.

 8. (i.) It shall be an offence for any person delivering milk or carrying or hawking milk for sale within the limits of the Council, to refuse, or to fail for any reason, to produce for inspection a duly issued registration-card for the current year, when called upon to do so by a Sanitary Inspector or by any person specially or generally authorized by the Chairman in that behalf.

(ii.) In the event of any person so refusing or failing to produce such card, it shall be lawful for such Sanitary Inspector or other authorized person to exercise the powers given to peace officers by section 33 (1) of the Criminal Procedure Code, 1898.

9. It shall be an offence for any person to sell or deliver or to expose, keep, carry, hawk, or offer for sale, within the limits of the Council—

(i.) any milk from which the cream has been removed, unless such milk is contained in a vessel which is distinctly and conspicuously labelled "Skimmed milk" in English, and the equivalent term in Sinhalese and Tamil, and is sold as such.

- (ii.) any milk adulterated with water or any other foreign substance or liquid, provided that milk, to which tea, coffee, or cacao has been added for consumption on the premises of any tea or coffee boutique or eating-house, shall not be deemed to be adulterated for the purpose of this by-law.
- (iii.) any milk contained in bottles of which the mouth is not covered with paper or other impermeable material.
- 10. If any person found guilty of an offence under the foregoing by law 9 is proved to be the agent or servant, whether paid or unpaid, of any other person, such other person shall also be liable to be punished for the same offence, unless he proves to the satisfaction of the Court that he had given all necessary instructions and used due diligence to ensure compliance, and that the offence was due to an act or default of his agent, or servant without his own knowledge, consent, or connivance.

BY-LAWS REFERRED TO.

1. No pension, gratuity, or long service allowance shall be granted to any officer of the Gampola Urban District Council without the authority of the Governor, in order to obtain which a certificate of good conduct from the Chairman setting out the length of service, age, and ground of retirement must be forwarded, together with the application for pension, gratuity, or retiring allowance, and the computation thereof, through the Commissioner of Local Government to the Controller of Establishments.

2. Subject to the provisions of by-law l and the following by-laws, every officer of the Gampola Urban District Council on the fixed establishment drawing a salary of Rs. 360 per annum and upwards who shall have had service of ten years or more including any service which may be reckoned under the proviso to by-law 7 may be awarded

a pension as follows:

For the first one hundred and twenty months of such service a pension equal to 120/720ths of his annual salary and for each additional completed month of service an additional 1/720th of such salary, but no officer shall be entitled to draw more than 480/720ths of his final salary as pension.

The above-mentioned rates shall only be granted in cases of faithful and meritorious service, but when the testimony as to fidelity, diligence, and merit is in any respect defective, a deduction from such rates may be made. Where there has been obvious negligence, irregularity, or misconduct, the grant of a pension may be altogether

Where service of peculiar and extraordinary merit has been rendered by an officer distinctly outside the duties in respect of which his salary is paid, a special rate of pension may be recommended for sanction, but in ordinary cases the maximum pension or retiring allowance grantable

o an officer under these by-laws, or to an officer entitled or ension also in respect of service not under the Council from all services combined, shall not exceed two-thirds of the highest salary drawn by such officer at any time in the course of his service.

In the case of officers on the fixed establishment of the Council drawing a salary of Rs. 360 per annum and upwards retiring on account of illness or age before com-pleting one hundred and twenty months' gross service a gratuity may be granted calculated at the rate of one-twelfth of a month's pay of the permanent office or offices held at the time of retirement, for each completed month of

5. Officers of the Gampola Urban District Council shall have no absolute right to any pension, gratuity, or long service allowance under these by-laws, and the Gampola Urban District Council retains power and authority to dismiss any such officer without any compensation.

6. No pension, gratuity, or long service allowance shall be granted to any officer of the Gampola Urban District Council who shall be under fifty-five years of age, except upon a certificate from the Chairman and two medical practitioners that he is incapable from infirmity of mind or body of discharging the duties of his office, nor unless he shall have discharged such duties theretofore with diligence and fidelity to the satisfaction of the Council.

7. The claim of an officer of the Gampola Urban District Council to pension, gratuity, or long service allowance shall be considered to have commenced from the date of his first permanent appointment to the fixed establishment of the Council after January 1, 1933, or its predecessor the Gampola Local Board.

Provided that an officer transferred from the provisional and temporary establishment to the fixed establishment may be allowed to count his provisional and temporary service when it has been continuous with his subsequent permanent service.

Service under sixteen years of age however will not

count for pension.

The service in respect of which pensions, gratuities, or long service allowances are granted under these by-laws must in all cases be continuous, unless interrupted by abolition of office or other temporary suspension of employment not arising from misconduct or voluntary resignation of the officer.

9. The pension or gratuity shall be computed upon the salary of the permanent office held by the officer of the Council at the time of his retirement provided he shall have held such appointment for at least three years: otherwise the pension shall be calculated upon the average of salaries attached to the permanent office held by such person during the three years next preceding the commencement of such pension.

10. In case of abolition of office, if the officer has completed 120 months' gross service, he may be granted a pension of 1/720th of his salary for each month of his service counting for pension with an addition to such service of one month for each completed period of two months'

one month for each completed period of two months service, the addition in no case exceeding 60 months.

If the officer has not completed 120 months' gross service he may be granted a gratuity of 1/12th of a month's salary for each month of service counting for pension, plus an addition of 50 per cent. thereon. In no case shall the number of months to be added to the actual service exceed that which, if added to the age of the retiring officer, would

make that age up to sixty.

11. If any person being in receipt of any pension or long service allowance from the Gampola Urban District Council shall be convicted of any offence in any Court of Justice in the Island for which he shall be sentenced to death or to any terms of imprisonment with hard labour exceeding six months such pension or long service allowance shall forthwith determine and cease to be payable, unless such person shall, within three months after his conviction, receive free pardon or unless the Council shall otherwise order.

12. Officers on the fixed establishment of the Gampola Urban District Council may be required to retire on or after attaining the age of fifty-five, upon the receipt of twelve months' notice to that effect, but they may continue in office till sixty years of age with the consent of the Council.

13. (1) Every officer who is transferred to or from the service of the Council from or to any other public service and whose aggregate service would have entitled him, had it been wholly under the Council, to a pension under these rules, shall on his ultimate retirement from service, if he has served for a period of at least 12 months under the Council, be entitled to a pension which shall bear the same proportion to that to which he would have been entitled had the whole of his service been under the Council as the aggregate* amount of the salary which he has drawn from the Council bears to the total sum made up of such aggregate. gate amount and the aggregate of the amounts received by him in the course of his public service elsewhere than under

Provided, however, that in the case of an officer who is transferred to the service of the Council after other public service in which the rules regulating pensions do not offer the same privileges to an officer transferred from the Council to such public service as are accorded under these rules to an officer transferred from such public service to the Council and whose aggregate public service under the Council and elsewhere would have entitled him, had it been wholly under the Council, to a pension under these rules, such officer may with the sanction of the Council on his ultimate

^{*} The term "aggregate" salary is to be interpreted as the amount of the aggregate salary of the substantive post held by an officer in the course of his career, disregarding extra emoluments such as duty allowances, and regarding leave on half pay or without pay as leave on full salary.

retirement from public service (provided such retirement takes place from the Council and that he has served for a period of at least five years under the Council) be entitled to receive from the Council, in lieu of a pension calculated in the manner prescribed in the preceding paragraph, a pension representing the difference between the pension or pensions earned by such officer in respect of his public service elsewhere and a pension calculated as if his public service had been wholly under the Council.

(2) For the purposes of this section, the expression "public service" includes employment under the Crown or any Local Government public body or bodies.

14. Should an officer who retires on pension find after takes place from the Council and that he has served for a

Should an officer who retires on pension find after such retirement an employment under the Council or under the Government or under another semi-official body on a salary equal to or higher than that which he drew from the Council at the time of his retirement, his pension shall be suspended so long as such employment continues. If he draws a less salary he shall be entitled to only so much of his pension as when added to the salary of the new appointment will make his total emoluments equal to the salary

last drawn by him previous to his retirement.

15. Employees on the fixed establishment of the Gampola Urban District Council drawing salaries of less than Rs. 360 per annum and retiring on account of age or infirmity after serving continuously for a period of fifteen years and upwards may, if the Council be satisfied that they are unfit, owing to age or infirmity of body or mind, further to discharge efficiently the duties of their offices, be granted such long service allowances not exceeding Rs. 7.50 per-mensem in each case as the Council may award. Persons in receipt of daily pay, who have completed a period of fifteen years of continuous service, retiring under similar circumstances may be awarded gratuities calculated at the rate of one-eighteenth of a month's pay drawn at the time of retirement for each completed month's service.

16. If any case not covered by these by-laws shall arise which in the opinion of the Council merits the award of a pension, retiring allowance, or gratuity, the circumstances of such case should be reported together with the recommendation of the Council to the Commissioner of Local Government for transmission to the General Treasury (Establishments Division) for submission to the Governor, who will decide whether any and, if so, what award shall be granted.

THE IRRIGATION ORDINANCE, No. 45 of 1917.

THE IRRIGATION ORDINANCE, No. 45 OF 1917.

RULES under section 11 of the Irrigation Ordinance, No. 45 of 1917, made by the prescribed majority of the proprietors within the Sangilikanadarawa and Maha Madawachchiya Irrigation District in Kadawat korale of Nuwaragam palata of the North-Central Province, at a meeting held on January 4, 1933, and approved by the Governor by virtue of the powers vested in him by section 19 of the said Ordinance and by Article 93 of the Ceylon (State Council) Order in Council 1931.

RULES.

Irrigation Meetings.

(1) Before the commencement of each season meeting of the proprietors shall be held, as far as possible in the following months:

for the maha cultivation in September,

for the meda cultivation in December,

for the yala cultivation in April.

(2) Any proprietor may attend any such meeting either in person or by representative.

Any such meeting may among other matters relating to the cultivation for the approaching season determne the following:

1) The nature and extent of the lands to be cultivated.

(2) The date for the completion of each of the works of-

(a) clearing channels,

(b) fencing fields,

(c) sowing,
(d) erection of watch-huts, and

(e) reaping.

(3) The description of paddy to be sown.(4) The place and manner in which black cattle and buffaloes are to be confined during cultivation.

(5) The last date for issue of water.

In the event of any matter mentioned in the foregoing rule 2 remaining undetermined by reason of the failure of the majority of the proprietors either to attend a meeting of which due notice is given or to arrive at a decision thereon, such matter may be decided by the Government Agent or an officer authorized by him in that behalf, and every decision of the Government Agent or such officer under this rule shall be binding on all the proprietors.

Field Fences.

4. (1) Before the date fixed for the completion of the work of fencing fields, every proprietor shall construct or repair the portion of the fences marked out by the Irrigation Headman as the share proportionate to the extent of such proprietor's fields, whether such portion adjoins such field or not; and he shall thereafter, whether he cultivates such field or not, maintain such portion of the fences in good repair, so as to be capable of keeping out cattle, until the crop on all the fields in the tract is reaped.

(2) No extension of time shall be allowed for completing any work of fencing, if any proprietor has sown his field by the date determined under the foregoing rule 2.

5. If the whole field or a distinct tract called " be cultivated, the fences at the two ends of the field called respectively the "ihala, and pahala elapat, fences" shall be put up by the respective proprietors at those ends.

6. (1) Where two adjoining fields are both cultivated, the proprietors of both shall jointly erect the common fence.

(2) If only one of such fields is cultivated, the proprietors of that field shall erect the fence, and may remove it after reaping, unless the proprietors of the other field wish to retain it and are prepared to pay half the cost thereof.

Cultivation.

7. (1) If for any reason it is not possible to commence cultivation on the date determined under the foregoing rule 2, or if the supply of water is likely to be insufficient to irrigate the whole area decided on originally, a further date, or the proportion of the tracts to be abandoned, shall be determined at a meeting of the proprietors duly convened for the purpose; provided that, if the meeting so convened is not able to arrive at a unanimous decision as regards the area to be abandoned, the Government Agent or such officer as may be deputed by him shall have power to determine the control of the control mine the area that is to be abandoned.

(2) Each of the proprietors of the area which it was originally decided to irrigate, shall have a right to cultivate

a proportionate share of the reduced area.

Watching of Fields.

Before the date fixed for finishing the erection of watch-huts under the foregoing rule 2, each proprietor of fields where watch-huts are necessary shall erect a proper watch hut in such place as may be indicated to him by the Irrigation Headman, and shall continue to keep watch until the date fixed for completion of reaping fixed under the said rule.

Channels.

9. (1) All field channels, dams, amunams, or watercourses whether outside or inside any field, which are not in charge of the Director of Irrigation, shall be repaired eleared and kept in good order throughout the season by the proprietors whose lands are irrigated thereby.

- (2) Each proprietor shall be responsible for such proportionate share of the channels, dams, amunams or water-courses as may be demarcated with pegs or blocks by the Government Agent or such officer as may be deputed by him for the purpose.
- 10. (1) Applications for permission to construct any new channel, dam or other work decided on by the majority of the proprietors in any tract shall be made in writing to the Cultivation Officer or Irrigation Superintendent appointed by the Government Agent under section 20A of the Ordinance.
- (2) Any work, the construction of which is permitted, shall be carried out in such manner and within such time and along such alignment as may be specified by the Government Agent or any officer deputed by him for the purpose.

(3) For the construction of such work, every proprietor of fields within such tract shall be liable to contribute labour in proportion to his holding.

11. (1) Every proprietor or lessee of new lands, which have been surveyed and demarcated by landmarks with reservations for field channels for irrigating such lands, shall construct his proportion of such field channels in accordance with alignments approved by the Divisional

Irrigation Engineer.

- (2) If any proprietor of such lands is unable to obtain water for irrigation owing to any default on the part of any other proprietor in constructing his share of the field channels, after notice from the Cultivation Officer or Irrigation Superintendent appointed by the Government Agent under section 20A of the Ordinance calling upon him to do the necessary work, the Irrigation Headman may with the approval of the Cultivation Officer or Irrigation Superintendent cause the work to be done and recover the cost thereof from the defaulter in accordance with section 23 of the Ordinance.
- 12. (1) Every proprietor shall grant way-leave for such channels, dams or other works even though his own lands may not be benefited thereby.
- (2) All proprietors whose lands are benefited by any such work, shall be liable under this rule to pay to the owners of lands, which suffer damage by the construction of such work, compensation for any land taken or damage done, in proportion to the area of the holdings benefited, and according to such rates of compensation as may be determined by the Government Agent: Provided that unless the Government Agent otherwise directs no compensation shall ordinarily be payable in respect of lands lying within the fields or tract of fields benefited.

Irrigation and Distribution of Water.

- 13. No proprietor or cultivator or any other person under any pretence whatsoever shall interfere with any canal, water passage, sluice or dam without the permission of the Cultivation Officer or Irrigation Superintendent appointed by the Government Agent under section 20a of the Ordinance.
- 14. In the order beginning with the field furthest from the tank and ending with the nearest, each proprietor shall take his supply of water strictly in turn and only in proportion to the extent of his holding, at such intervals and for such number of hours as the Irrigation Headman may fix.
- 15. No proprietor who neglects to utilize his share of water in his proper turn, shall be allowed any supply until his next turn comes round.
- 16. Any proprietor who takes water out of his turn or for a longer period than he is entitled to, or who after having had his full share allows the water to run to waste through negligence, or who misappropriates his neighbour's water through the boundary ridges, shall forfeit the right to his share in the turn next following, and shall be guilty of an offence punishable under Chapter V. of the Ordinance.
- 17. When water is in transit through a water-course to irrigate any particular tract, no person shall divert the water from such water-course to the fields through which it passes or obstruct or otherwise interfere with it.
- 18. When there is a deficiency of water in the tank, no proprietor who has neglected to commence cultivation at the proper time or who has sown paddy of a kind other than that determined under the foregoing rule 2 by the majority, shall take or be allowed any water for his cultivation.

Cattle.

- 19. During the cultivation season—
- (1) buffaloes shall be kept at such distance from the fields as may be fixed at the cultivation meeting held under rule 2.
- (2) black cattle shall be tended by day and folded at night outside the fields cultivated.

- 20. (1) No owner of a paddy field forming part of a tract under cultivation shall drive in, graze or tether cattle in his own field till all the fields in the tract have been reaped and crops removed.
- (2) No cattle shall be tethered in or near any irrigation-channel.

Threshing-floors.

- 21. All the proprietors who stack paddy on a common threshing-floor shall—
 - (1) be jointly responsible for the erection of a strong fence round such floor, and
 - (2) keep watch in turn over the paddy so stacked until all the paddy is threshed and removed.
- 22. (1) No paddy shall be removed from the fields during any harvest, until the shares due to the Headmen have been paid, and in the case of fields cultivated for a share of the produce, until all dues have been paid to the landlord.
- (2) In any case where there is any serious risk of damage to any paddy left on the threshing-floor, such paddy may be removed with the consent of the other party concerned, or if consent is not given, the cultivator shall leave sufficient paddy on the threshing-floor to settle the claim and remove only the remainder.

Enforcement of Ancient Customs.

23. Any existing custom relating to any matters not provided for in these rules, and not inconsistent with them, shall have the force of these rules and be considered part of them.

Irrigation Headmen.

- 24. It shall be the duty of every Irrigation Headman elected or appointed under Chapter IV. of the Ordinance—
 - (a) to reside within three miles of the area for which he is elected or appointed;
 - (b) to operate and maintain in good order all sluices, regulators and other structures placed in his charge;
 - (c) to supervise all works of irrigation and paddy cultivation within his area, subject to instructions from, and under the control of, the Government Agent or the officer deputed by him;
 - (d) to report the occurrence of any damage to any bund, spill, sluice or any other work connected with the irrigation work or of any leak at the sluice, to the Cultivation Officer or Irrigation Superintendent appointed by the Government Agent under section 20A of the Ordinance; and
 - (e) to enforce these and all other irrigation rules and to bring all breaches thereof to the notice of the Cultivation Officer or Irrigation Superintendent.
- 25. (1) Every such Irrigation Headman shall be entitled to receive from each proprietor 1½ per cent of the produce of all lands cultivated by such proprietor.
- (2) Subject to the provisions of the foregoing rule 22 (2), the aforesaid percentage shall be handed over on the threshing-floor before any of the produce is removed therefrom.

Maintenance, Conservation, Protection and Management of Irrigation Works.

- 26. After the sowing, in each cultivation season, every proprietor who does not himself cultivate his fields shall furnish a list of his cultivators to the Irrigation Headman, setting out their names and addresses and stating whether such cultivators are andakarayo, lessees or hired labourers.
- 27. The cultivator of any land shall be liable to perform all duties imposed by these rules or by custom on the proprietor of such land.

General.

- 28. Any act or omission in contravention of these rules shall be an offence punishable under Chapter V. of the Ordinance.
- 29. Any Irrigation Headman wilfully neglecting any duty imposed on him by these rules shall be guilty of an offence punishable under Chapter V. of the Ordinance.
- 30. The rules dated December 29, 1868, published in the Gazette of January 2, 1869, and deemed to be in force by virtue of the provisions of section 2 of the Ordinance, are hereby repealed.

VITAL STATISTICS.

Registrar-General's Report on Vital Statistics of the City of Colombo for the Week ended August 12, 1933.

Births.—The total births registered in the city of Colombo in the week were 178 (1 European, 9 Burghers, 98 Sinhalese, 40 Tamils, 23 Moors, 4 Malays, and 3 Others). The birth rate per 1,000 per annum (calculated on the estimated population on July 1, 1933, viz., 294,400) was 31.5, as against 23.6 in the preceding week, 30.1 in the corresponding week of last year, and 30.3 the weekly average for last year.

Deaths.—The total deaths registered were 155 (4 Burghers, 98 Sinhalese, 22 Tamils, 24 Moors, 5 Malays, and 2 Others). The death rate per 1,000 per annum was 27.5, as against 23.6 in the previous week, 25.4 in the corresponding week of last year, and 24.5 the weekly average for last

Infantile Deaths.—Of the 155 total deaths, 27 were of infants under one year of age, as against 21 in the preceding week, 38 in the corresponding week of the previous year, and 29 the average for last year.

Still Births.—The number of still births registered during the week was 16.

Principal Causes of Death .--1. (a) Twenty from Pneumonia were registered, 10 in Maradana hospitals including 5 deaths of non-residents), 2 each in Kotahena North, Kotahena South, and Wellawatta North, and 1 each in St. Paul's, New Bazaar, Slave Island, and Wellawatta South, as against 19 in the previous week and 15 the weekly average for last year.

- (b) Seven deaths from *Influenza* were registered, 4 in Slave Island, 2 in San Sebastian, and 1 in Maradana North, as against 3 in the previous week and 8 the weekly average for last year.
- (c) Five deaths from *Bronchitis* were registered, 2 in Maradana South, and 1 each in New Bazaar, Maradana hospitals, and Maradana North, as against 7 in the previous week and 3 the weekly average for last year.
- 2. Seventeen deaths from *Phthisis* were registered, 11 in Maradana hospitals (including 4 deaths of non-residents), 3 in New Bazaar, and 1 each in St. Paul's, Maradana North, and Maradana South, as against 11 in the previous week and 11 the weekly average for last year.
- 3. Two deaths from *Enteric Fever* were registered in Maradana hospitals (including 1 death of a non-resident), as against 4 in the previous week and 3 the weekly average for last year.
- 4: One death from Suspected Plague, of a resident of Colombo town, occured at the Infectious Diseases Hospital, Angoda, during the week. No deaths were registered within the city.
- 5. Ten deaths from Debility were registered, 8 from Diarrhoea, 7 from Enteritis, 6 from Worms, 3 each from Dysentery and Infantile Convulsions, 2 each from Homicide, Puerperal Septicaemia, and Accidents, and 61 from Other Causes.
- 6. Reported Cases.—Seven cases of Small pox, 5 each of Chicken pox and Enteric Fever, 2 of Mumps, and 1 each of Measles and Whooping Cough were reported during the week, as against nil, 6, 2, 1, 2, and 1, respectively, of the preceding week.

State of the Weather.—The mean temperature of air was 80·3°, against 79·7° in the preceding week and 81·1° in the corresponding week of the previous year. 
