## DRAFT ORDINANCE.

## MINUTE.

The following Draft of a proposed Ordinance is published for general information:—

**An Ordinance to amend the Village Communities Ordinance, No. 9 of 1924.**

BE it enacted by the Governor of Ceylon, with the advice and consent of the State Council thereof, as follows:

Short title.

1 This Ordinance may be cited as the Village Communities (Amendment) Ordinance, No. of 1933.

Amendment of section 6A of the principal Ordinance.

2 (1) Section 6A of the Village Communities Ordinance No. 9 of 1924 (hereinafter referred to as "the principal Ordinance") is renumbered section 6A (1).

(2) After section 6A (1) of the principle Ordinance the following is added as section 6A (2):—

"(2) Where any town or village has been brought under the operation of both this Ordinance and the Small Towns Sanitary Ordinance, 1892—

(a) no inhabitant therein shall have power either to sign requisitions under section 8 of this Ordinance for meetings of the inhabitants of the sub-division within which it is situated or to attend or vote at any such meeting, or to be elected on the committee of any such sub-division;

(b) section 34 of this Ordinance shall not apply to any property whatsoever belonging to the Sanitary Board; and

(c) rules made under section 95 of this Ordinance or in operation by virtue of section 96 shall have force therein notwithstanding section 36 of the Small Towns Sanitary Ordinance, 1892."

*Objects and Reasons.*

Where any town or village is under the operation of both the Small Towns Sanitary Ordinance, 1892, and the Village Communities Ordinance, No. 9 of 1924, the inhabitants therein may now take part in the elections and other activities under the latter Ordinance while by virtue of section 36 of the former Ordinance the rules framed by the village committee will not bind them. This Bill seeks to confine to those who will be really affected by the activities of a village committee the rights given by the Village Communities Ordinance, No. 9 of 1924. Provision however has been made so that the existing jurisdiction of village tribunals over the areas in question is nevertheless preserved.
