DRAFT ORDINANCE.

MINUTE.

The following Draft of a proposed Ordinance is published for general information:—

An Ordinance to amend the Ceylon Post Office Ordinance, 1908.

BE it enacted by the Governor of Ceylon, with the advice and consent of the State Council thereof as follows:—

Short title.

1 This Ordinance may be cited as the Ceylon Post Office Ordinance, No. of 1933.

Amendment of section 12 of the principal Ordinance. 2 Section 12 (3) of The Post Office Ordinance, 1908, is amended by the substitution of the words "determine and adequately notify the terms, conditions and requirements to be observed in respect of "for the words" make rules for "in line 3.

Objects and Reasons.

For the local enforcement of the terms of any arrangement that the Postmaster-General may enter into with other countries concerning the transmission of mails under section 12 (3) of The Ceylon Post Office Ordinance, 1908, depends at present on the making of suitable rules for the coming into force of which publication in the Gazette is made essential by section 11 (1) (e) of The Interpretation Ordinance, 1901. And for any change in such rules similar publication is necessary. It is not always possible, however, to postpone the bringing into operation of such rules and their amendments till they can be published in the Gazette; and in practice they have been enforced after publication in the Post Office Guide and Daily List.

2. The purpose of this Bill is to legalize the current practice.
