LAND SETTLEMENT ORDINANCE, 1931.

The lessee shall also permit the Director of Agriculture or any Officer of his Department authorized by him to enter upon the land and collect seeds and/or budwood from the rubber trees standing thereon.

(9) The lessee shall not sublet, sell, donate, mortgage, or otherwise dispose of or deal with his interest in the lease or any portion thereof without the written consent of the lessor or of the Land Commissioner and every such sublease, sale, donation, or mortgage without such consent shall be absolutely void.

(10) The lessee shall at his own expense keep the Crown land marks which define the boundaries of the land in good repair, and shall within three months from the date of the lease cause the said boundaries to be defined in the following manner; that is to say, according to the limits laid down in the Crown survey, such boundaries to be 10 feet wide and cleared of all roots, trees, and brushwood, and as far as possible from all other impediments; when the boundaries run along open ground a small ditch 1 foot in depth and 2 feet in width is to be excavated, and such boundaries shall be further marked by occasional boundary pillars, posts, or stones at the principal angles of the land; if in cultivated ground, by a fence, wall, paling, bank, or boundary posts, and he shall maintain and preserve the boundaries so defined, and in failure of his defining the boundaries as aforesaid, or so maintaining and preserving them as aforesaid the same shall be done by the Surveyor-General after notice to the lessee and the costs and charges thereof shall be recoverable from the said lessee.

(11) The lessee shall not remove or disturb any Government trigonometrical station, or beacon, or boundary pillars, or marks. Such disturbance or removal will render the lessee liable to all expenses incurred in refixing and restoring such objects.

(12) At the expiration of the term of the lease as specified in clause (1) above or of any further period or periods for which the said term shall have been extended or on the sooner determination of the said term or the said further periods the lessee shall yield up and surrender to the lessor the premises demised with all buildings erected thereon and with all improvements effected thereto during the said term and/or any period or periods for which the said term shall have been extended and he shall not be entitled to payment of any compensation in respect of the said buildings or improvements or on any account whatsoever.

(13) In the event of any instalment of rent being in arrears for the space of more than one year, whether the same shall have been lawfully demanded or not, the said Assistant Government Agent shall be at liberty to declare the lease forfeited to the Crown, and the said land and premises, together with its plantations and improvements shall revert to and become the absolute property of the Crown, without any claim to compensation thereon on the part of the lessee.

(14) The lessee shall not without the written consent of the lessor or of the said Assistant Government Agent or otherwise than in accordance with the conditions of such consent, erect any buildings upon the said land, other than structures which may be necessary for the proper cultivation of the said land with the products provided for in clause (3) above.
