 - (d) at the expiry of the term of the lease or on its sooner determination surrender the demised premises to the Lessor, together with all buildings erected thereon and all additions, improvements, and fixtures, in good repair and condition, and not be entitled to any payment of any compensation in respect of the said buildings, additions, improvements or fixtures, or on any account whatever;

 (e) preserve all timber and timber-like growths that may be marked by the Forest Officer of the district and pay the liquidated and agreed sum of Fifty Rupees (Rs. 50) for every tree that may be cut or injured.
