The extent of such remission shall be determined by the number of marks he or she shall earn in accordance with the follow-ing rules ".

(i.) By the substitution, in line 2 of rule 300, of the words "calendar month" for the word "year"; and by the contentuar month" for the word "year"; and by the substitution, in line 4 of the same rule, of the words "30 days (calendar month)" for the words "365 or 366 (leap year) as the case may be".

(j) By the deletion of the existing rule 306 and the substitution of the following new rule therefor :—

"306. (A) The name of every prisoner with an aggre-gate sentence of imprisonment for a period exceeding one year, who is due for discharge on remission shall be submitted through the Inspector-General of Prisons to the Minister for Home Affairs, in the case of a male prisoner when he has to earn 480 of the total number of marks required, and in the case of a female prisoner when

she has to earn 540 of the total number of marks required ". "(B) In all cases where the aggregate sentence of imprisonment is for a period exceeding one calendar month but not exceeding one year, the Superintendent of a prison is hereby empowered, subject to the approval of the Inspector-General of Prisons, to discharge such prisoners when they have earned the required remission, their names being submitted in advance on Form Prisons 15 to the Inspector-General of Prisons for such approval on the 15th and 30th respectively of each month: Provided that in any case where the prior approval of the Inspector-General of Prisons cannot conveniently be obtained the Superintendent may authorize the discharge of the prisoner and obtain thereafter the approval of the Inspector-General of Prisons as early as possible ".

# "THE LOCAL GOVERNMENT ORDINANCE, No. 11 of 1920."

#### BY-LAWS.

(Conditions for the issue of Licences for Dangerous and Offensive Trades as defined under the General By-laws relating to Licensed Trades, published in the Govern-ment Gazette of December 9, 1927, and amended by the Notification dated April 7, 1933, published in the Government Gazette of April 12, 1933.)

1. All materials required for the purpose of carrying on any dangerous or offensive trade as defined in by-law 1 of the general by-laws relating to licences shall be so stored as to prevent the diffusion of effluvia or other similar nuisance; and all such materials which have to be brought along any public thoroughfare, and which are likely to give off effluvia or be otherwise offensive shall be transported in non-absorbent covered receptacles or in such other manner as the Chairman may direct, so as to obviate the creation of any nuisance.

2. All offensive vapours or gases emitted during any process or manufacture, shall either be discharged into the external air in such manner and at such a height as to ensure their absorption into the upper air without injurious or offensive effects upon the neighbourhood or be passed directly through a fire into a condensing apparatus.

3. (1) All premises shall be adequately drained and the drains kept in efficient order and washed daily.

(2) Floors shall be maintained in a proper state of repair and cleansed daily, and when so ordered by the Chairman shall be reconstructed of any impermeable material he may specify.

may specify. (3) Walls shall be kept in good order so as to prevent the absorption of filth, and whitewashed twice at least annually and at such other times as the Chairman or the Medical Officer of Health may by written notice specify.

4. (1) All apparatus including implements and vessels shall be kept clean, and where possible they shall be cleansed daily.

daily. (2) All refuse, sweepings, and scrapings, together with waste and bye-products, shall be removed daily from the premises in covered receptacles, unless intended to be forthwith subjected to further trade purposes on the premises.

5. All tanks, used for washing or soaking skins or any other similar materials, shall be emptied and cleansed as often as may be necessary to prevent the creation or diffusion or effluvia.

6. No person carrying on any dangerous or offensive trade, and no owner or occupier of any land or premises upon which such dangerous or offensive trade is carried on, shall pollute any river, stream, canal, channel, well, tank, or open piece of water, by discharging thereinto or suffering to flow thereinto, any foul, ill-smelling, or offensive water or other fluid, or by throwing thereinto, or suffering to be washed thereinto, any offensive substance, nor shall he in any other way pollute or contaminate such river, stream, canal, channel, well, tank, or open piece of water.

7. The owner of occupier of any land from which clay, earth, stone, gravel, cabook, or any other material is cut for the manufacture of bricks or tiles, or for building, or for any other purpose, shall take all necessary steps to ensure that proper drainage is provided, and that the pits or trenches cut are afterwards so filled as to prevent the collection of stagnant water therein.

8. Any person who contravenes any of the provisions of the above by-laws shall be guilty of an offence and shall be liable on conviction to a fine not exceeding Rs. 25 for any such offence, and in the case of a continuing offence to an additional fine not exceeding Rs. 5 for every day during which the offence is committed after conviction, or after written notice from the Chairman of such contravention.

#### Membership of the Fund.

1. All employees (not being pensionable officers of the Government seconded for service with the Scheme) of the Board of Management of the Research Scheme drawing a salary of Rs. 50 per mensem or over shall as a condition of their employment by the Board become members of the Fund as from the date of their joining the service of the Board.

#### Members' Contributions.

2. (i.) Each member shall contribute monthly to the Fund from the date on which he is admitted a member thereof a sum equivalent to 5 per cent. of his salary. "Salary" for this purpose includes personal allowance equivalent to salary, but no other emolument whatever. (ii.) The recovery shall be made by way of abatement on

(ii.) The recovery shall be made by way of abatement on pay sheets and any abatement so made shall be deemed for purposes of computing the interest due upon such contributions to have been credited to the Fund on the last day of the month for which the salary was due.

(iii.) In the event of such abatement not being made the member shall pay to the Secretary of the Board the sum due from him as his contribution within 15 days after the receipt by him of his salary, and for the purpose of computing the interest due upon such contribution it shall be deemed to have been paid on the last day of the month in which it was received by the Secretary.

(iv.) The contribution shall be computed on the actual salary payable, whether the member shall be on full pay, half pay, or otherwise; but no contribution shall be due in respect of any period of leave without pay.

(v.) Any member who may be temporarily transferred or lent to a Government Department or local public body (including a Research institution) may continue to contribute to the Fund at the same rate as he would have contributed if he had not been so transferred or lent. No bonus under rule 3 shall be payable in respect of any contribution made under this rule.

#### Contributions of the Board of Management.

3. (i.) On the first day of the Board's financial year there shall be placed to the credit of each member a bonus equal to the sum contributed by such member during the preceding 12 months.

(ii.) In the event of a member ceasing to contribute on death or retirement the bonus shall be placed to the member's credit on the date on which he so ceases to contribute and shall be equal to twice the sum contributed by such member in the Board's current financial year.

For the purpose of this rule retirement shall include, in the case of officers who are employed on contracts having effect for a defined term—

- (a) The quitting of service on satisfactory completion of the full term of the officer's contract, and
- (b) The quitting of service before the expiry of the officer's contract, when such quitting is necessitated by ill-health for which the officer is not responsible,

and in the case of an officer not serving on a written contract effective for a defined term,

- (c) The quitting of service on or after the completion of his 55th year of age, and
- (d) The quitting of service before he completes his 55th year of age, when such quitting is necessitated by ill-health for which the officer is not responsible.

#### Investment of Contributions.

4. (i.) All money at the credit of a member whether on account of his own contributions or of bonus, shall be invested with the Board of Management and shall bear interest at the rate of  $4\frac{1}{2}$  per cent. per annum. (ii.) The interest shall be made up on the first day of the

(ii.) The interest shall be made up on the first day of the Board's financial year and shall be computed on the minimum sum standing at the credit of each member throughout each month of the year. No interest shall be payable in respect of broken periods of a month.

(iii.) The sum accruing as interest shall be added to the capital sum standing at the credit of each member on the first day of the Board's financial year.

(iv.) The interest accruing under this rule shall be payable from the revenue and other funds of the Scheme.

#### Member's Accounts and Closing thereof.

5. (i.) A separate account shall be kept for each member and shall be divided into two parts. The first part shall show the amount of the member's own contributions to the Fund with interest thereon as it accrues. The second part shall show the bonus credited to the member with interest thereon as it accrues.

(ii.) As soon as possible after the close of each financial year of the Scheme the Secretary to the Board of Management shall furnish each member with a statement of his account.

(iii.) When a member leaves the service of the Board the amount standing to his credit shall be paid to him or if he dies to the person legally entitled thereto, subject to the provisions of rules 5 (iv.), (v.), and (vi.) below. (iv.) On quitting the service of the Board by voluntary

(iv.) On quitting the service of the Board by voluntary resignation after giving the notice required by the terms of his appointment before the expiry of the term of a written contract or before the completion of the 55th year of age, as the case may be, a member shall be entitled to receive the whole sum standing to his credit, with interest thereon, but not including any bonus not yet credited to his account. In the event of such premature termination of a member's appointment by the Board other than on discharge for misconduct or negligence in the performance of his duties, a member shall be entitled to receive the whole sum standing to his credit, with interest thereon, together with a bonus equal to the sum contributed by such member in the Board's current financial year. ### VITAL STATISTICS.

Registrar-General's Report on Vital Statistics of the City of Colombo for the Week ended September 30, 1933.

Births.—The total births registered in the city of Colombo in the week were 162 (12 Burghers, 103 Sinhalese, 20 Tamils, 17 Moors, 5 Malays, and 5 Others). The birth rate per 1,000 per annum (calculated on the estimated population on July 1, 1933, viz., 294,400) was 28 7, as against 29 9 in the preceding week, 31 6 in the corresponding week of last year, and 30 3 the weekly average for last year.

Deaths.—The total deaths registered were 135 (4 Burghers, 85 Sinhalese, 22 Tamils, 16 Moors, 3 Malays, and 5 Others). The death rate per 1,000 per annum was 23.9, as against 25.5 in the previous week, 20.7 in the corresponding week of last year, and 24.5 the weekly average for last year.

Infantile Deaths.—Of the 135 total deaths, 30 were of infants under one year of age, as against 26 in the preceding week, 19 in the corresponding week of the previous year, and 29 the average for last year.

Stillbirths.—The number of stillbirths registered during the week was 9.

Principal Causes of Death.--1. (a) Nineteen deaths from Pneumonia were registered, 14 in Maradana hospitals (including 5 deaths of non-residents) and 1 each in New Bazaar, Maradana South, Slave Island, Kollupitiya, and Wellawatta North, as against 14 in the previous week and 15 the weekly average for last year.

(b) Six deaths from *Influenza* were registered, 2 each in New Bazaar and Slave Island and 1 each in St. Paul's and Wellawatta South, as against 11 in the previous week and 8 the weekly average for last year.

(c) Three deaths from *Bronchitis* were registered in Maradana hospitals, as against 6 in the previous week and 3 the weekly average for last year.

2. (a) Thirteen deaths from *Phthisis* were registered, 5 in Maradana hospitals (including 2 deaths of non-residents), 3 in New Bazaar, 2 in Maradana South, and 1 each in Fort, St. Paul's, and Slave Island, as against 14 in the previous week and 11 the weekly average for last year.

(b) Three deaths from *Phthisis*, of residents in Colombo town, occurred at the Anti-Tuberculosis Hospital, Ragama, during the week.

3. Two deaths from *Enteric Fever* were registered in Maradana hospitals (including 1 death of a non-resident), as against 7 in the previous week and 3 the weekly average for last year.

4. Nine deaths from *Enteritis* were registered, 7 from *Debility*, 6 from *Puerperal Septicaemia*, 5 each from *Infantile Convulsions* and *Worms*, 4 from *Diarrhoea*, 3 from *Dysentery*, 2 from *Homicide*, 1 from *Tetanus*, and 50 from *Other Causes*.

5. Reported Cases.—Five cases of Enteric Fever, 4 of Chickenpox, 3 of Measles, and 1 of Diphtheria were reported during the week, as against 9, 7, 5, and 1, respectively, in the preceding week.

State of the Weather.—The mean temperature of air was  $78 \cdot 9^{\circ}$ , against  $80 \cdot 7^{\circ}$  in the preceding week and  $80 \cdot 0^{\circ}$  in the corresponding week of the previous year. The mean atmospheric pressure was  $29 \cdot 880$  in., against  $29 \cdot 901$  in. in the preceding week and  $29 \cdot 894$  in. in the corresponding week of the previous year. The total rainfall in the week was  $2 \cdot 05$  in., against  $0 \cdot 29$  in. in the preceding week and  $1 \cdot 88$  in. in the corresponding week of the previous year.

#### General Specification for Wooden Water Boats fitted with Independent Fresh Water Tanks.

The hulls to be strongly constructed in a manner suitable to their needs, and in accordance with approved plans and scantlings.

The tanks must be constructed of steel and shall be of sufficient 'strength to suit their requirements, and in accordance with the approved plans, and finished sound and water-tight.

They must be built into the hull in such a manner as to prevent displacement or sagging. The cross section of the fresh water tanks must be such

as to insure proper drainage and the pumping out of the entire contents.

The vessels must be able to float with all fresh water tanks full, with a reasonable free board. They must be decked their entire length fore and aft

without interruption (the fresh water tank tops counting as deck).

The tanks must be so arranged as to be easily lifted out for inspection and repairs.

All openings and hatches must be protected with suitable

coarnings and nationes must be protected with suitable coarnings and covers of approved design. The hatches giving access to fresh water tanks must be provided with water-tight covers capable of being securely closed and clamped down.

Permanent suction and filling connections must be provided of approved pattern, each fitted with a screw cover capable of excluding sea spray, dirt, &c., and with screw connections to fit hoses.

A sounding opening or openings must be provided of

approved design fitted with a water-tight screw cap. No huts or shelters for the accommodation of stores or crew may be erected on the decks in way of the fresh water tanks.

Baffle plates must be provided to prevent undue surging of the fresh water in the tanks, and equalizing pipes or limber holes must be provided at the bottom of all tanks large enough to ensure an equal level of water in all com-

arge enough to ensure an equilibrium rever of water in an com-partments while pumping. manship for vessels of this class. They must not exceed the following dimensions :— Length 100 feet, beam 26 feet, and draught 7 feet.

The cross section of the vessels must be such as to insure proper drainage and the pumping out of the entire contents of the fresh water spaces.

They must be able to float with a reasonable free board with all fresh water spaces full. They must be decked their entire length, and all openings

and hatches must be protected with suitable coamings and covers.

The hatches giving access to the fresh water spaces must be provided with water-tight covers capable of being securely closed and clamped down. Permanent suction and filling connections must be provided of approved pattern, each fitted with a screw cover capable of excluding sea spray, dirt, &c., and with screw connections to fit hoses.

A sounding opening or openings must be provided of approved design fitted with a water-tight screw cap. No huts or shelters for the accommodation of stores or crew may be erected on the decks in way of the fresh water spaces.

water spaces. Baffle plates must be provided to prevent undue surging of the contents of the fresh water spaces, and equalizing pipes or limber holes must be provided at the bottom of all spaces, large enough to ensure an equal level of water in all compartments while pumping. The fresh water spaces must be so constructed that no sea water can leak into them in any way whatsoever either through bottom sides or deak

either through bottom sides or deck.

The fresh water spaces must be so constructed that all their interior is readily accessible for cleaning and inspection, and fixed iron ladders or their equivalent must be provided leading from the hatches to the bottom of the fresh water spaces where required.

All sharp and inaccessible corners must be rounded out with cement and the entire interior, of the fresh water \* spaces coated with cement wash.


