IT is hereby notified that the following regulations relating to Inventions by Public Officers have been added as Appendix F to the Public Service Regulations published by Notification dated June 30, 1931, in *Government Gazette Extraordinary* No. 7,865 of June 30, 1931 :—

1. The attention of Public Officers is hereby directed to the rights that the Crown has in inventions made by them in the course of their official duties, or with the knowledge and skill acquired, and the facilities placed at their disposal, as a result of their employment.

2. Any Public Officer who wishes to obtain a Patent for any invention made by him, may make an application to the Registrar of Patents in terms of sections 5 and 6 of the Patents Ordinance, 1906 ; but he shall forthwith forward a copy of such application to the Head of his Department who shall submit it to the Executive Committee or Officer of State under whose general control his Department has been placed.

3. The nature and the extent of the rights that may be allowed to, and the conditions that may be imposed on, a Public Officer so applying for a Patent (hereinafter to be called "the applicant") will be considered and settled in the manner following :—

(1) The Executive Committee or Officer of State concerned will make a recommendation to the Chief Secretary, after considering the invention and its possibilities in consultation with the Patents Advisory Committee consisting of the Solicitor-General as Chairman and of one or more members of each of the scientific Departments interested in the invention, selected from a panel of Departmental representatives to be nominated from time to time by the Governor.

(2) The Chief Secretary will place the application before the Board of Ministers which will make a recommendation to the Governor.

(3) The Governor's decision upon such recommendation will be communicated to the applicant normally within three months from the date of receipt of the copy of his application.

4. Pending the decision of the Governor, all rights in the applicant's invention will be deemed to belong to the Crown and to be held in trust for the Crown.

5. An applicant whose invention is in all essential matters alien to his employment or official duties, will normally be permitted to retain full controlling rights in the invention ; and where full controlling rights are so allowed, the applicant shall himself bear all the expenses of taking out a Patent.

6. (1) In other cases, any controlling rights allowed to an applicant will be subject to conditions and limitations in imposing which a wide discretion will be exercised, and which may include either (a) the reservation of rights of user by the Crown free of royalty, or (b) the reservation to the Crown of a share of any commercial proceeds likely to be realized, or both such reservations.

(2) A reservation to the Ceylon Government of user of the invention free of royalty may include a like reservation to His Majesty's Government in the United Kingdom, or the Government of any British Colony or

Protectorate or any territory in respect of which His Majesty's Government in the United Kingdom exercises a mandate.

(3) An agreement embodying the reservations so made shall thereupon be signed by the applicant on the one part and the Chief Secretary on behalf of His Majesty on the other.

7. If it is decided that no controlling rights of any kind should be allowed to an applicant, he shall forthwith assign by a duly executed document all his rights in, and all the benefit of, the invention to the Chief Secretary on behalf of His Majesty ; but he may be allowed a share of the commercial proceeds of the invention and the State Council will be asked to provide funds out of the general revenue to meet all expenses incurred in taking out the Patent.

8. Where only limited controlling rights, or no controlling rights, are allowed, or where a reservation of any rights in favour of the Crown has been made and only a share of the commercial proceeds is allotted to the applicant or when the Government reserves the right to use the invention free of royalty, he will have the right to claim an award.

9. Such claim shall be made by way of application forwarded by the Head of the applicant's Department, in the same manner as the copy of the original application for a Patent, to the Executive Committee or Officer of State as the case may be.

10. A claim for an award will be dealt with only after the acceptance of the complete specification by the Registrar under the provisions of section 11 of the Ordinance.

11. (1) In making the award all reasonable expenses incurred in connection with the invention will be taken into consideration ; but at the same time a set-off or deduction will be made in proportion to the value of any share allowed to the applicant in the commercial proceeds of the invention and the award will in no case exceed the sum of Rs. 100,000.

(2) The reservation of a right of user free of royalty to His Majesty's Government in the United Kingdom or the Government of any other territory mentioned in rule 6 (2) shall not be taken into account, but if and when such right shall be exercised by any such Government, a material change shall, for the purpose of rule 12, be deemed to have taken place.

12. Any award decided upon, and any allocation made to the applicant of a share in the commercial proceeds, will be subject to modification by the Governor of his own motion, or at the request of the applicant, in the event of any material change in the circumstances that existed at the time of such award or allocation, provided that in any such modification of the original decision the amount of an award which has been paid shall not be reduced.

13. (1) If a Public Officer fails to take within a reasonable time steps for obtaining a Patent in respect of any invention made by him, the Governor may if so advised order him to make application for a Patent in the prescribed manner.

(2) The expenses of any application so made will in the first instance be met out of funds provided by the State Council from the general revenue ; but if the applicant is eventually allowed full controlling rights in the invention, he shall refund all moneys so advanced, unless the Governor is satisfied that such controlling rights have no commercial value.

(3) In all other respects the foregoing regulations shall apply to a Public Officer ordered to make application for a Patent, in the same manner as if he had made the application on his own initiative.

14. Any Public Officer who acts in contravention of these regulations, or who, after the assignment of all his controlling rights in any invention to the Chief Secretary as set out in paragraph 7 of these regulations, communicates at any time, any information, document, sketch or model connected with the said invention to any person to whom it ought not to be communicated, shall be deemed to be guilty of misconduct punishable with dismissal from the Public Service.

THE ORDINANCE RELATING TO PILGRIMAGES,
No. 13 OF 1896.

REGULATIONS under section 1 of Ordinance No. 13 of 1896 entitled "An Ordinance relating to Pilgrimages" as amended by Ordinance No. 7 of 1897, made by the Officer Administering the Government by virtue of the powers vested in him by Article 93 of the Ceylon (State Council) Order in Council, 1931, in anticipation of the customary pilgrimage to Kataragama for the Ilmaha Kachchi Festival, 1933.

REGULATIONS.

1. (a) The duration of the Kataragama Ilmaha Kachchi Festival, 1933, and of the stay of pilgrims at Kataragama shall be and it is hereby limited to three days, namely, November 30 to December 2, 1933, inclusive.

(b) Pilgrims arriving before the day first named or staying beyond the period here prescribed shall be guilty of an offence.

2. The camp shall be under the general control of the Government Agent, Province of Uva, and under the immediate supervision of an officer designated the "Supervising Officer" who shall be assisted by a Medical Officer and by a Police Officer.

3. In the event of an epidemic breaking out at Kataragama during the festival, it shall be lawful for the Supervising Officer to declare the festival at an end, and to direct pilgrims at once to leave the village and proceed to their homes, and to prescribe the roads by which they have to travel.

4. The Supervising Officer shall have power on the line of march to and from Kataragama and at Kataragama—

- (a) To appoint particular places to be exclusively used by the pilgrims for washing and bathing, for drawing water and drinking and for natural offices;
- (b) To appoint places for the occupation of each class of pilgrims;
- (c) To prescribe routes for the journey of any body of pilgrims;
- (d) To regulate the distribution of all food given to pilgrims;
- (e) To fix separate places of abode for pilgrims who fall ill, to prohibit communication with them and to detain them if unfit to travel.

Any person disobeying any lawful order given for any of these purposes by the Supervising Officer shall be guilty of an offence.

5. For the purpose of these rules camp shall mean the area within half a mile of the Maha Dewala in every direction.

6. The police are empowered and required to seize and destroy all food condemned as unwholesome on the march or in the camp, by the Supervising Officer or by the Medical Officer or in their absence by the chief officer of Police; and any person resisting or obstructing the Police in the discharge of this or of any other duty prescribed by these rules shall be guilty of an offence.

7. Any person bringing any cattle or cart-bulls within one quarter of a mile of the camp without a permit from the Supervising Officer or any person authorized by him to issue such permits shall be guilty of an offence.

8. The issue of such permits shall be subject to compliance by the permit-holder with such conditions as may be imposed by the Supervising Officer for the purpose of enforcing sanitation, maintaining the health of the camp, and regulating traffic.

9. (1) (a) Any person exposing commodities of any description for sale in camp in any other place than that assigned for the purpose by the Supervising Officer shall be guilty of an offence.

(b) Any person selling food condemned as unwholesome by the Supervising Officer or by the Medical Officer, or in their absence, by the chief officer of Police shall be guilty of an offence.

(2) (a) All eating-houses and tea and coffee boutiques shall be kept clean and sanitary to the satisfaction of the Supervising Officer.

(b) No waste tea, coffee or milk, or remnants of food, cooking waste or refuse shall be thrown on the ground but shall be collected in a proper receptacle ready for removal by the sanitary authorities.

(c) No foodstuffs shall be exposed to the contamination of flies.

10. Any person who shall, during the occupation of the camp, use any other place for offices of nature than that provided for the purpose by Government, or shall fail to cover the deposit with earth or sand, and any person who shall during the same period bathe in or enter the river above the spot appointed by the Supervising Officer shall be guilty of an offence.

11. Any person suffering from an infectious or a contagious disease and not reporting the same to the Supervising Officer, to the Medical Officer or the chief officer of Police, and any person aiding or abetting in the concealment of such disease shall be guilty of an offence.

12. All persons shall take up the quarters assigned to them by the Supervising Officer or the chief officer of Police at the halting places and in the camp, and any person declining or neglecting to do so shall be guilty of an offence.

13. Any person who, without the previous sanction of the Supervising Officer, constructs any booth or extend any building so as to encroach on the main streets of the camp shall be guilty of an offence.

PENSION RULES.

1. (a) No officer shall be deemed to have an absolute right to any pension, gratuity, or allowance under these rules, and the Board reserves to itself the power to dismiss an officer without compensation.

(b) No pension, gratuity, or retiring allowance shall be granted on retirement to any officer without the authority of the Governor, in order to obtain which a certificate of good conduct from the Chairman setting out the length of service, age, and ground of retirement must be forwarded together with the application for pension, gratuity, or retiring allowance, and the computation thereof, through the Commissioner of Local Government to the Controller of Establishments.

2. (1) Subject to the provisions and exceptions hereinafter contained every officer holding a permanent office in the service of the Board and drawing a salary of not less than Rs. 400 per annum may be granted a pension calculated at the rate of 1/720th of the salary of the office or offices held by him at retirement for each month of service counting for pension, provided that he has completed not less than 120 months' gross service, and provided further that no pension awarded under these rules shall exceed 480/720ths of the salary upon which the pension is computed.

(2) If such an officer retires on account of illness or age before completing 120 months' gross service, he may receive a gratuity calculated at the rate of 1/12th of a month's salary of the office or offices held by him at retirement for each month of service.

3. Any officer may be required to retire from the service of the Board on or after attaining the age of fifty-five years; but retirement shall be compulsory on his attaining the age of sixty years, unless the Governor decides that his services shall be retained.

4. No pension shall be granted to an officer retiring before he attains the age of fifty-five years, unless a Medical Board, consisting of two Medical Practitioners nominated by the Chairman, certifies that the officer is unfit to discharge the duties of his office owing to infirmity either of mind or body, and unless he shall have theretofore discharged such duties to the satisfaction of the Chairman.

5. The Chairman may call upon an officer, who is below the limit of age entitling him to retire on pension, to retire from the service on the ground of his inability to discharge efficiently the duties of his office. In such a case the Board may by special resolution, subject to the approval of the Governor, grant such retiring allowance or gratuity as is considered just and proper, but in no case exceeding the amount for which the length of service of the officer would qualify him.

6. In the case of the abolition of any pensionable office, the pension or gratuity grantable to the officer holding such office will be that which would have been payable to him had he retired on grounds of ill-health.

7. No pension or gratuity granted under these rules shall be assignable or transferable.

8. (1) The service to be reckoned for pension shall be calculated from the date on which the officer commences to draw salary in respect of his first permanent appointment, whether pensionable or not. Acting service in an office carrying claims to pension shall, when continuous with permanent employment, count as service for pension, provided no other officer was earning pension for the same period in respect of the same office. The service of an officer under 16 years of age shall not in any case count for pension.

(2) An officer is entitled to reckon as service for pension the whole period of absence on vacation leave and half the period of absence on leave with half salary. Absence without salary will not count as service for pension.

9: (1) The pension or gratuity awarded to an officer shall be computed upon the salary drawn by him, at the time of his retirement in respect of the permanent office or offices then held by him, provided that he shall have held such office or offices, to which the same fixed salary or incremental scale of salary is attached, for at least three years, otherwise the pension or gratuity shall be calculated upon the average of the salaries attached to the permanent offices held by such officer during the three years next preceding the date of his retirement.

(2) For the purposes of these rules, salary will include in addition to the salary of the permanent office or offices held by him, any allowance voted to him by resolution of the Board as a pensionable allowance, but no other emolument whatsoever.

10. The rates of pension, retiring allowance, and gratuity above set forth shall be granted only in cases of faithful and meritorious service. Where the testimony as to good conduct is in any way defective, a deduction may be made from the pension or gratuity, and where the misconduct of an officer has been of a serious nature, the pension or gratuity may be entirely withheld.

11. The service in respect of which pensions or gratuities are granted ought in all cases to have been continuous, unless interrupted by abolition of office or by temporary suspension of employment not arising from misconduct or voluntary resignation. Service prior to a break of service may, however, be allowed to count for pension together with service subsequent to such break if the whole of the intervening period has been spent in some employment under Government or under another statutory Local Authority.

12. If any person in receipt of a pension or retiring allowance is convicted of any offence in any court in the Island and sentenced to death, or to any term of rigorous imprisonment exceeding six months, the payment of such pension or allowance shall be forthwith discontinued, unless such person shall within three months of such conviction receive an unconditional pardon, or unless the Board with the approval of the Governor in any case for special reasons otherwise decides.

13. If any person to whom a pension, annuity, or allowance has been granted under these rules becomes a bankrupt, such pension, annuity, or allowance shall forthwith cease; but it shall be lawful for the Board, with the approval of the Governor, from time to time during the remainder of such person's life or during such shorter period or periods whether continuous or otherwise as may be necessary, to pay all or any part of such pension, annuity, or allowance to, or to apply the same for the maintenance and personal support or benefit of, such person and his wife and children jointly, or any one or more of them exclusively, as may in the circumstances of each case be necessary or expedient.

14. (1) Every officer who is transferred to a post under Government or under another statutory Local Authority with the approval of the Board shall be entitled on ultimate retirement to pension for the service rendered to the Board, provided that he retires from the latter service in circumstances which would entitle him to pension under these rules. In all such cases the amount contributed by the Board by way of pension shall be based only on the service under the Board and the final salary drawn from the Board.

(2) An officer who has been transferred to the service of the Board from some other employment under Government or under another statutory Local Authority may, if he retires from the service of the Board after completing ten years' public service in all, but before completing ten years' service under the Board, be awarded, in lieu of a gratuity, an annuity based on service and salary under the Board calculated in the manner prescribed by rule 2 (1).

15. No person may at any time draw from the funds of the Board an amount of pension which, when added to the amount of any pension or pensions drawn in respect of other public service, exceeds two-thirds of the highest

pensionable emoluments drawn by such person at any time in the course of his service under the Board or in such other public service.

16. If any person in receipt of a pension or retiring allowance from the Board returns to the service of the Board he may be allowed to retain his pension or retiring allowance during the period of his re-employment, in which case he shall receive on his ultimate retirement no award whatever under these rules; or he may be required to forego the pension or retiring allowance then drawn by him, in which case he shall receive on his ultimate retirement a pension or retiring allowance based on his aggregate service and the highest salary drawn by him at any time during that service. The Chairman shall decide the terms on which a former servant of the Board may be re-employed in any particular case.

17. Any employee of the Board drawing a salary of less than Rs. 400 per annum, retiring on account of illness after serving continuously for a period of 15 years and upwards may, if the Board be satisfied from the report of a Medical Board that he is unfit to discharge efficiently the duties of his office owing to infirmity of body or mind, be awarded such long service allowance not exceeding Rs. 750 per mensem as the Board may think just and proper. In the case of employees who retire after attaining the age of 55 years or over, no Medical Board need be appointed. Any employee in receipt of daily pay, who has completed not less than 20 years' service, retiring in similar circumstances, may be awarded a gratuity calculated at the rate of 1/36th of a month's pay for each month's service.

18. In the event of any officer or servant, whether in a pensionable or non-pensionable office or on daily pay dying while in the service of the Board, it shall be competent to the Board, subject to the approval of the Governor, to grant to the widow or next-of-kin of such officer or servant a gratuity not exceeding three months' pay, and in addition one month's pay for each minor child.

19. If any case not covered by these rules shall arise which in the opinion of the Board merits the award of a pension, retiring allowance, or gratuity, a report setting out the circumstances of such case, together with the recommendation of the Board, shall be forwarded through the Commissioner of Local Government and the Controller of Establishments, General Treasury, to the Governor for his decision as to the nature and the amount of the compensation, if any, that may be awarded.

BY-LAW REFERRED TO.

1. (a) Whenever any tree within the administrative limits of this Council or the branch, fruit, or leaf of such a tree is in the opinion of the Chairman either likely to fall upon any house or building or likely to be dangerous to its occupants or whenever such tree, branch, fruit, or leaf overhangs any street, the Chairman may, by a notice in writing served on the owner or the occupier of the land upon which the tree stands, require him to cut down the tree, branch, fruit, or leaf as the case may be; and if such owner or occupier fails within twenty-four hours of receiving the notice to comply with its requirements, any officers or workmen authorized in writing by the Chairman may enter upon such land and at the expense of the owner or occupier do what the owner or occupier was required to do by the notice.

(b) The owner or occupier who fails to comply with the requirements of a notice issued under paragraph (a) above shall be liable on conviction to a fine not exceeding fifty rupees.

BY-LAWS REFERRED TO.

By-laws regarding the Tax on Vehicles and Animals.

1. In these by-laws—

"Chairman" means the Chairman of the Trincomalee Urban District Council.

"Ordinance" means the Local Government Ordinance, No. 11 of 1920.

2. The returns required to be furnished under section 179 of the Ordinance by an owner or other person whether resident within the urban area or outside and supposed to be liable to pay taxes in respect of animals or vehicles, shall be made in a schedule which shall be supplied by the Council and shall be filled up and returned by the person to whom such schedule is addressed.

3. If any person after having filled up and returned such schedule, shall acquire, keep, or use any vehicle or animal not mentioned in such schedule, he shall, within one month of acquiring any such vehicle or animal, notify the Chairman in writing of the fact of such acquisition and further furnish true and correct information in respect of every such vehicle or animal so acquired, kept, or used. Whoever fails or neglects to notify the Chairman or to furnish such information as aforesaid, shall be liable to a fine not exceeding twenty-five rupees.

4. Subject to the provisions of section 175 of the Ordinance, any person who has furnished the schedule referred to in by-law 2 shall without further notice be liable, in respect of vehicles or animals entered in such schedule, to pay the tax for the year for which such schedule is furnished and any person who has sent the written notice required by by-law 3, shall be liable to pay the tax on vehicles or animals referred to in such notice for the year in which such vehicles or animals were acquired by him or otherwise came into his possession.

5. Any person who having furnished the schedule required by by-law 2 or the written notice required by by-law 3, claims to be exempt from the liability to pay any tax in respect of a vehicle or an animal which has been in his possession for less than 30 days in any year and is entered in or referred to in such schedule or notice shall forthwith give notice in writing to the Chairman of his claim for such exemption, specifying the grounds on which such claim is made.

6. The annual tax prescribed under the provisions of section 175 of the Ordinance shall be paid on or before the Twenty-eighth day of February in every year in respect of all vehicles, other than those exempted by the Ordinance, and in respect of every horse, pony, or mule kept or used for the purpose of drawing vehicles within the limits of the Trincomalee Urban District Council.

7. On payment of the annual tax the Chairman shall issue or cause to be issued in respect of every vehicle for which such tax is paid a metal plate as specified in the schedule hereto with figures denoting the year for which the plate is issued and the corresponding number in the registers of vehicles. Such plate shall be fixed on a conspicuous part of the vehicle in respect of which the plate was issued.

Provided that when any plate becomes indistinct or defaced by use or otherwise, the owner shall return it to the Chairman and shall be entitled, on making a payment of 25 cents to receive a fresh plate; and provided further that the Chairman may, on his being satisfied by affidavit or otherwise that any plate has been lost or stolen, issue a fresh plate on the application of the owner and on payment by him of 50 cents.

8. Where the plate prescribed by these by-laws has not been duly affixed to any vehicle kept or used within the limits of the Trincomalee Urban District Council, the owner or person in charge of any such vehicle in respect of which the prescribed plate should have been so affixed shall be guilty of an offence and shall be liable to a fine not exceeding fifteen rupees.

VITAL STATISTICS.

Registrar-General's Report on Vital Statistics of the City of Colombo for the Week ended October 28, 1933.

Births.—The total births registered in the city of Colombo in the week were 210 (4 Europeans, 11 Burghers, 119 Sinhalese, 31 Tamils, 29 Moors, 7 Malays, and 9 Others). The birth rate per 1,000 per annum (calculated on the estimated population on July 1, 1933, viz., 294,400) was 37.2, as against 30.6 in the preceding week, 28.5 in the corresponding week of last year, and 30.3 the weekly average for last year.

Deaths.—The total deaths registered were 145 (7 Burghers, 87 Sinhalese, 25 Tamils, 18 Moors, 3 Malays, 1 Veddah, and 4 Others). The death rate per 1,000 per annum was 25.7, as against 29.8 in the previous week, 21.8 in the corresponding week of last year, and 24.5 the weekly average for last year.

Infantile Deaths.—Of the 145 total deaths, 29 were of infants under one year of age, as against 42 in the preceding week, 16 in the corresponding week of the previous year, and 29 the average for last year.

Stillbirths.—The number of stillbirths registered during the week was 9.

Principal Causes of Death.—1. (a) Ten deaths from *Pneumonia* were registered, 3 in New Bazaar, 2 each in Kotahena South and Maradana hospitals (including 1 death of a non-resident), and 1 each in Maradana North, Maradana South, and Slave Island, as against 29 in the previous week and 15 the weekly average for last year.

(b) Eight deaths from *Influenza* were registered, 3 in Slave Island, 2 each in New Bazaar, St. Paul's, and 1 in San Sebastian, as against 10 in the previous week and 8 the weekly average for last year.

(c) Seven deaths from *Bronchitis* were registered, 3 in Maradana hospitals (including 1 death of a non-resident), 2 in Maradana North and 1 each in St. Paul's and New Bazaar, as against 7 in the previous week and 3 the weekly average for last year.

2. (a) Thirteen deaths from *Phthisis* were registered, 3 in Maradana hospitals (of non-residents), 2 each in San Sebastian, Maradana North, Maradana East, and Slave Island, and 1 each in Kotahena North and Kollupitiya, as against 18 in the previous week and 11 the weekly average for last year.

(b) Two deaths from *Phthisis* of residents of Colombo town occurred at the Anti-Tuberculosis Hospital, Ragama, during the week.

3. (a) One death from *Enteric Fever* was registered in Kollupitiya, as against 2 in the previous week and 3 the weekly average for last year.

(b) One death from *Enteric Fever* of a resident of Colombo town occurred at the Infectious Diseases Hospital, Angoda, during the week.

4. Nine deaths from *Debility* were registered, 7 each from *Dysentery* and *Worms*, 5 from *Diarrhoea*, 3 from *Enteritis*, 2 from *Tetanus*, 1 each from *Infantile Convulsions*, *Suicide*, and *Accidents*, and 70 from *Other Causes*.

Reported Cases.—Six cases of *Chickenpox*, 4 of *Enteric Fever* and 1 of *Diphtheria* were reported during the week, as against 1, 10, and 3, respectively, in the preceding week.

State of the Weather.—The mean temperature of air was 79.2°, against 79.0° in the preceding week and 80.2° in the corresponding week of the previous year. The mean atmospheric pressure was 29.957 in., against 29.845 in. in the preceding week and 29.875 in. in the corresponding week of the previous year. The total rainfall in the week was 0.72 in., against 2.15 in. in the preceding week and 11.18 in. in the corresponding week of the previous year.

Abstract.—A process for the utilization of waste vegetable products resulting from a wet treatment for the extraction of fibres, consisting in rolling or compressing the mass with or without the addition of various agglutinants. Filling materials may also be added. When latex is added the material may also be vulcanized by the addition of sulphur and pressing or moulding with or without heat.

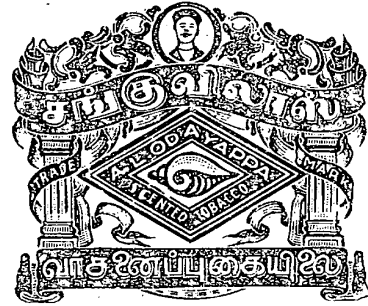
