**DRAFT ORDINANCES.****MINUTE.**

The following Draft of a proposed Ordinance is published for general information :—

B 978

**An Ordinance to amend The Local Government Ordinance,  
No. 11 of 1920.**

BE it enacted by the Governor of Ceylon, with the advice and consent of the State Council thereof, as follows :—

Short title.

1 This Ordinance may be cited as the Local Government Amendment Ordinance, No. of 1933.

Amendment of section 192 of the principal Ordinance.

2 Section 192 (1) of The Local Government Ordinance, No. 11 of 1920, (hereinafter referred to as "the principal Ordinance") is amended by the addition of the following words at the end

"and every Council shall pay Government towards the cost of each half-yearly audit a sum equal to one per centum on the total revenue of the Council during the half-year for which the accounts are audited."

Amendment in section 2 given retrospective effect.

3 The principal Ordinance shall be construed as if from the time of its passing section 192 had read as now amended.

*Objects and Reasons.*

Section 192 of The Local Government Ordinance, No. 11 of 1920, requires that the accounts of every District Council shall be audited by Government twice every year. There is no provision requiring or authorizing the payment of any fee by the District Council to meet the cost of such audit though it has been usual to recover on this account a sum equal to one per cent. on the total revenue of the District Council. The purpose of this Bill is to legalize the present practice and to validate past recoveries.

**An Ordinance to amend the Municipal Councils  
Ordinance, 1910.**

BE it enacted by the Governor of Ceylon, with the advice and consent of the State Council thereof, as follows :—

Short title.

1 This Ordinance may be cited as the Municipal Councils Amendment Ordinance, No. of 1933.

Amendment of section 131 of principal Ordinance.

2 Section 131 (2) of the Municipal Councils Ordinance, 1910, is amended by substituting the words "one thousand five hundred" for the words "five hundred" occurring at the end.

*Objects and Reasons.*

The stamp duty payable on the certificates of admission of advocates and of proctors is paid to the Municipal Council of Colombo by virtue of section 131 (1) (c) of the Municipal Councils Ordinance, 1910, and the Municipal Council has to pay Rs. 500 out of such moneys to the Committee of the Colombo Law Library.

2. The purpose of this Bill is to increase the above contribution to Rs. 1,500.

The following Draft of a proposed Ordinance is published for general information :—

**An Ordinance to amend " The Land Resumption Ordinance, 1887 "**

BE it enacted by the Governor of Ceylon, with the advice and consent of the State Council thereof, as follows :—

1 This Ordinance may be cited as the Land Resumption (Amendment) Ordinance, No. of 1933. Short title.

2 Section 1 of The Land Resumption Ordinance, 1887, is amended as follows :— Amendment of section 1 of the principal Ordinance.

(a) The section is renumbered as section 1 (1).

(b) For the words " in the English, Singhalese and Tamil languages to be published six times at least in the Government Gazette and in any two local newspapers and to be posted on such land " in lines 10, 11, 12 and 13, the words " to be published and to be posted on such land in the manner provided in sub-section (2) " are substituted.

(c) The following new sub-section (2) is added at the end :—

" (2) Every notice under sub-section (1) shall be published twice at least (a) in English, Singhalese and Tamil in the Government Gazette, (b) in English in a local newspaper published in English, (c) in Singhalese in a local newspaper published in Singhalese and (d) in Tamil in a local newspaper published in Tamil; and every such notice shall also be posted in all three languages on the land to which it refers."

*Objects and Reasons.*

1. Section 1 of The Land Resumption Ordinance, 1887, requires that as a preliminary to resuming possession of lands which have been alienated by the Crown and which have since been abandoned by the owners, a notice should be published at least six times in the English, Singhalese and Tamil languages in the Gazette and in any two local newspapers.

2. This Bill provides (a) that the said notice should be published in a local English newspaper in English, in a local Singhalese newspaper in Singhalese and in a local Tamil newspaper in Tamil, and in all three languages in the Gazette, and (b) that the notice need appear only twice in each of the said publications.
