No. 36 of 1933.

081/1 (S.B.)

An Ordinance to continue the temporary increase in the export duty on tea made by the Tea Cess (Temporary Increase) Ordinance, 1930.

BE it enacted by the Governor of Ceylon, with the advice and consent of the State Council thereof, as follows:—

Short title.

1 This Ordinance may be cited as the Tea Cess (Temporary Increase Continuation) Ordinance, No. 36 of 1933.

Section 3 of the Tea Cess (Temporary Increase) Ordinance 1930 to be in force until 31st December, 1934. 2 The provisions of section 3 of the Tea Cess (Temporary Increase) Ordinance 1930 shall continue in force until the 31st day of December 1934, and accordingly section 2 of the said Ordinance shall be construed as if the figure "1934" were substituted for the figure "1933" occurring therein.
