THE TEA PROPAGANDA ORDINANCE, No. 19 OF 1932.

It is hereby notified that the following resolution under section 8 of the Tea Propaganda Ordinance, No. 19 of 1932, passed by the State Council at its public session on March 29, 1935, has been sanctioned by the Governor:—

“This Council resolves under the provisions of section 8 of the Tea Propaganda Ordinance, No. 19 of 1932, that in lieu of the export duty now charged, levied and paid in pursuance of the resolution under the said section published in the *Gazette* of November 4, 1932, there shall be charged, levied and paid from and after midnight of March 31/April 1, 1935, a duty of seventy-five cents per one hundred pounds of tea exported from the Island and so in proportion for any less weight”.
