KNOW Ye that by virtue of the powers vested in Us by section 3 of the Seashore Protection Ordinance, 1911, and by Article 93 of the Ceylon (State Council) Order in Council, 1931, We, the Governor of Ceylon, do hereby proclaim those parts of the seashore of this Island which are specified and defined in the schedules hereto as areas from or over which no sand, stone, coral, or other substance shall be removed from and after the date hereof.

### SCHEDULE A.

That part of the sea and seashore lying between a point 150 yards west and a point 440 yards east of the Keerimalai spring at Keerimalai in the Valikamam North and East division of the Jaffna District, and bounded as follows :—

On the east by a straight line drawn from a point on the high water mark of the sea 440 yards east of the Keerimalai spring due northward to a distance of 1 mile.

On the south by the high water mark of the sea from the said point 440 yards east of the Keerimalai spring westward to a point 150 yards west of the same spring.

On the west by a straight line drawn from the said point on the high water mark of the sea 150 yards west of the Keerimalai spring due northward to a distance of 1 mile.

On the north by a straight line joining the northern extremities of the eastern and western boundaries.

### SCHEDULE B.

That part of the sea and seashore lying between a point 100 yards west of the Infectious Diseases Hospital and a point 100 yards east of the Resthouse at Kankasanturai in Valikamam North and East division, Jaffna District, and bounded as follows :—

On the east by a straight line drawn from a point on the high water mark of the sea 100 yards east of the Kankasanturai Resthouse due northward to a distance of 1 mile.

On the south by the high water mark of the sea from the said point 100 yards east of the Kankasanturai Resthouse westward to a point 100 yards west of the Infectious Diseases Hospital at Kankasanturai.

On the west by a straight line drawn from the said point on the high water mark of the sea 100 yards west of the said Infectious Diseases Hospital due northward to a distance of 1 mile.

On the north by a straight line joining the northern extremities of the eastern and western boundaries.

### SCHEDULE C.

That part of the sea and seashore lying between the channels running northward from culvert No. 13/1 and culvert No. 13/2 on the Point Pedro-Punnalai road, adjoining the Kankasanturai Sanatorium in Mayiliddi Coast in the Valikamam North and East division of the Jaffna District, and bounded as follows :—

On the east by a straight line drawn from the point where the channel running from culvert No. 13/1 meets the high water mark of the sea due northward to a distance of 1 mile.

On the west by a straight line drawn from the point where the channel running down from culvert No. 13/2 meets the high water mark of the sea due northward to a distance of 1 mile.

On the south by the high water mark of the sea between the said points where the channels running from culverts Nos. 13/1 and 13/2 meet the high water mark of the sea.

On the north by a straight line joining the northern extremities of the eastern and western boundaries.

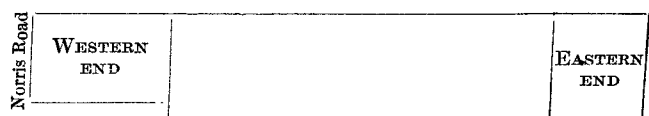

## Rule.

The rules for the management and regulation of the Post Office Savings Bank published by Notification dated December 29, 1893, in *Government Gazette* No. 5,264 of December 29, 1893, as amended by Notification dated September 26, 1913, in *Government Gazette* No. 6,583 of October 3, 1913, and Notification dated April 8, 1931, in *Government Gazette* No. 7,841 of April 10, 1931, are hereby further amended as follows:—
