Lease of a Crown Building Site in Nuwara Eliya.

NOTICE is hereby given that the Assistant Government Agent, Nuwara Eliya, will on Monday, July 15, 1935, at 10 A.M. at the Kachcheri, Nuwara Eliya, put up for auction the lease of the under-mentioned Crown Building Site, situated within the administrative limits of the Urban District Council, Nuwara Eliya, on St. Andrews drive, within a distance of about $\frac{1}{2}$ a mile from the town on the following conditions,—*inter alia* :—

1. The officer conducting the sale may, before accepting any bid, satisfy himself of the *bona fides* of the person or persons making it and of his or their ability immediately to make a deposit of ten per centum of the amount of such bid, and should he be unable so to satisfy himself may refuse to accept such bid and may continue the sale as if no such bid had been made.

(2) The lessee will be required to covenant with the lessor that he will—

- erect and complete upon the demised premises within two years from the commencement of the lease and in accordance with plans approved by the lessor or his agent a residential building, expending thereon not less than Rs. 12,000 ;
- not sub-let, sell, donate, mortgage, or otherwise dispose of or deal with his interest in the lease without the written consent of the lessor or of the Land Commissioner on the lessor's behalf ;
- maintain all buildings erected by him upon the demised premises in good repair, pay all rates and taxes, and erect and keep in good repair a substantial fence or boundary wall round the demised premises ;
- at the expiry of the term of the lease or on its sooner determination surrender the demised premises to the lessor, together with all buildings erected thereon and all additions, improvements, and fixtures, in good repair and condition, and not be entitled to any payment of any compensation in respect of the said buildings, additions, improvements, or fixtures, or on any account whatever ;
