THE following revised regulations governing the General Clerical Service Examination, which supersede those set out at present in Appendix A to the Public Service Regulations, are published for general information.

### REGULATIONS.

#### *General Clerical Service Examination.*

1. Information regarding examinations for the General Clerical Service can be obtained from the Deputy Chief Secretary.
2. An examination for candidates wishing to enter the General Clerical Service will be held as required. The examination will be confined to British subjects whose families are permanently resident in Ceylon.
3. Applications for admission to the examination by persons not in the Public Service must be addressed to the Director of Education, must bear a duly cancelled revenue stamp of Rs. 10 and must be in the proper form. Forms are to be obtained at the office of the Director of Education on application.
4. A certificate of the registration of the candidate's birth showing him to be not less than 18 nor more than 22 years of age on August 1 in the year in which the examination is held, and a certificate of good character signed by a responsible person, to the satisfaction of the Director of Education, must be attached to the form of application.
5. If the candidate has been educated at a Government or Assisted School, the certificate must be from the Principal of the last Government or Assisted School which he has attended; otherwise it may be from the candidate's teacher or school master by preference, or a member of the Public Service, a Justice of the Peace, Minister of Religion, Advocate, Proctor, or Notary, or, generally speaking, some person whose name is known and to whom reference can readily be made.
6. Affidavits will in no circumstances be accepted as a substitute for birth certificates.
7. In the case of candidates who submit certificates of registration in the register of past births, the certificates will only be accepted after consideration of the evidence by which the dates of birth were established. If the name appearing in the birth register differs, either by alteration or addition, from the name by which a candidate is known, (a) the parent or guardian, in the case of a candidate under the age of 21 years, should, before obtaining a certificate, apply to the Registrar-General or his Assistant for such alteration in the manner set forth in section 21 of Ordinance No. 1 of 1895, and (b) in the case of a candidate over the age of 21 years, he should produce evidence to the satisfaction of the Director of Education that the certificate of birth forwarded applies to him.
8. Certificates of birth issued for the purposes of the Code for Assisted Schools will not be accepted for this examination.
9. Candidates other than those eligible under Regulation 11 must also furnish proof when forwarding their applications that they have previously passed at least the Cambridge Senior, the London Matriculation, or the Senior School Certificate (English) Examination.
10. Clerks who are paid directly from "Personal Emoluments" Votes in the Government Estimates (other than members of the Customs, Postal, Survey, Harbour Engineer's or Railway Departments, Draughtsmen and

Stenographers), if within the age prescribed in these Regulations, will be admitted without fee, but they must have passed the examination or examinations prescribed by Regulation 9 above.

11. Clerks in Class III. of the General Clerical Service who shall have completed three years' service before the date of the examination, and whose service has been throughout satisfactory, are eligible for examination irrespective of age and without fee, and although they may not have passed the examination or examinations prescribed by Regulation 9 above. Their applications (in the same form) for admission to the examination must be forwarded to the Director of Education through the Heads of their Departments.

12. Clerks of the description given in Regulation 11 who fail to secure places in Class II. in the general competition will be allowed to compete amongst themselves for seven out of every thirty of the appointments offered for competition.

13. The examination will be held under the supervision of the Director of Education in the places which will be notified to the candidates. Heads of Departments are required to grant to officers of their Departments, whose applications have been returned to them approved by the Director of Education, leave to present themselves at the examination.

14. The examination will be competitive. The number of places in Class II. assigned for competition will be notified in the *Gazette*, together with the number of places in Class III. to be filled from those who fail to be selected for Class II. Appointments will be made by the Chief Secretary. The names of the successful candidates will be published in the *Gazette* and they will be given appointments as suitable vacancies occur.

15. The successful candidates will be required to pass a medical examination as to their physical fitness for service in any part of the Island.

16. The subjects for examination are as follows:—

17. The examination is held in two parts. The written examination is first held and on the results of the written examination candidates are selected competitively to attend the *Vivá Voce*. The number to be called for the *Vivá Voce* examination will be fixed by the Deputy Chief Secretary in consultation with the Director of Education. In all written papers marks will be deducted for bad writing and mistakes in spelling. Candidates whose writing is illegible are liable to be disqualified. The *Vivá Voce* examination will be held in Colombo.

18. Competitive examinations for the selection of Class III. clerks only will be held as required at the discretion of the Deputy Chief Secretary. These examinations will normally be as follows:—

- (a) As in Regulation 16.
- (b) For touch typists as required. This form of examination will consist of tests in dictation, type-writing and shorthand. Only touch typists will be eligible to compete. The examination will be competitive. Candidates must be between the ages of 17 and 21 on the 1st of the month in which each examination is held. Candidates must have passed the Junior School Certificate (English) or the Cambridge Junior Certificate Examinations. Final selection for appointment will be made by the Deputy Chief Secretary after interview. The number of vacancies to be filled in this way is limited and depends entirely on the requirements of Departments.

19. At the discretion of the Deputy Chief Secretary any other form of competitive selective test may be held for the selection of candidates for Classes II. and III. of the General Clerical Service. Such tests will be arranged as necessary to meet special requirements of clerks with special knowledge or experience. These examinations will be held only as required. The number of vacancies is small.

THE following regulations for entry and training of Naval Cadets at the Royal Naval College at Dartmouth, and training afloat are published for general information. It is hereby notified that the Government of Ceylon is included among the Governments of certain Dominions and Colonies which are allowed to recommend a certain number of candidates annually for entry as Naval Cadets into the Royal Naval College, Dartmouth, *vide* regulation 9.

### NAVAL CADETS.

#### Regulations for Entry and Training at the Royal Naval College at Dartmouth, and Training afloat.

1. No nomination is required by a candidate for a Naval Cadetship. All that is necessary is to send an application to the Private Secretary to the First Lord of the Admiralty. *Applications should not be made until the Candidate has reached 12½ years of age.*

#### Conditions of Entry and Service.

2. Candidates must be British subjects of pure European descent, and the sons either of natural-born or naturalized British subjects. In doubtful cases, the burden of clear proof will rest upon the parent or guardian of the candidate.

Candidates who possess a foreign, as well as British nationality may, in certain cases, be regarded as ineligible for entry into the commissioned ranks of the Royal Navy and Royal Marines. Parents or guardians are therefore advised to seek an early decision from the Admiralty as to the eligibility for entry of prospective candidates possessing double nationality.

3. All Naval Cadets entered under these regulations are trained together, but after passing for the rank of Lieutenant or at an earlier stage, they may be required to serve as general service officers, or in one of the specialist branches (*e.g.*, Gunnery, Torpedo, Navigation, &c.) or as Engineer Officers, or be employed on other special duty.

As far as possible officers selected for special service will be allowed to choose the branch in which they will qualify, subject to the proviso that all branches are satisfactorily filled.

Parents or guardians of candidates for appointment as Naval Cadets must undertake for them that they are prepared to serve in any branch if required.

4. Parents or guardians are required to declare in writing their intention that the candidate, if he obtains a Cadetship, shall adopt the Navy as his profession in life; and it is subject to this undertaking that candidates are selected for Cadetships. Every Cadet who enters the Royal Naval College must therefore be prepared to continue his training so long as the Admiralty are satisfied with his progress, and parents are not at liberty to withdraw their sons at will.

On the entry of a Cadet, parents or guardians will be required to undertake that, in the event of his withdrawing or being withdrawn from the College, or from the Navy before being confirmed as a Sub-Lieutenant or Sub-Lieutenant (E.) or before reaching the age of 21 whichever is the earlier, they will pay to the Admiralty, if demanded, the sum of 40*l.* per term in respect of each term passed by him at the R.N. College, Dartmouth, from the date of his entry to the date of his withdrawal, as a contribution towards the balance of the cost of his training and maintenance not covered by the annual payment of the fees mentioned in paragraph 15.

This undertaking does not apply to Cadets withdrawn at the request of the Admiralty.

5. Entries take place three times a year, in January, May and September.

Candidates for entry in—

January must be more than 13 years and 4 months, but not more than 13 years and 8 months of age on the preceding 1st December.

May must be more than 13 years and 4 months, but not more than 13 years and 8 months of age on the preceding 1st April.

September must be more than 13 years and 4 months, but not more than 13 years and 8 months of age on the preceding 1st August.

The Qualifying Examinations are held in December, March and July, and the appointments of successful candidates date from approximately the 15th January, 15th May and 15th September following respectively.

All candidates (except those being educated in the Dominions or Colonies who have received special recommendations from the Dominion or Colonial authorities under paragraph 9) will be required to present themselves before a Committee, which will interview each applicant separately about one month before the date of the qualifying examination. The applications must be received at the Admiralty:—

For the January entry before 16th October.

„ May entry before 16th January.

„ September entry before 16th May.

Appointments to Naval Cadetships are made by the First Lord from among candidates recommended by the Committee, and all such appointments are subject to the candidate passing a Medical Examination (*see* paragraph 7) and a Qualifying Examination in educational subjects (*see* paragraph 8).

The fact, however, of a candidate being invited to appear before this Committee is not to be understood as in any degree implying that he will necessarily be chosen to attend the Qualifying Examination.

Travelling and other expenses incurred in connection with interview and medical examination cannot be recovered from the Admiralty.

\* Candidates are eligible only for one Interview and Qualifying Examination.

#### Physical Standard.

7. Every candidate must be in good health, and free from any physical defect of body, impediment of speech, defect of sight or hearing, and also from any predisposition to constitutional or hereditary disease or weakness of any kind, and be in all respects well developed and active in proportion to his age. Before undergoing the Qualifying Examination he is required to pass the Medical Examination according to the prescribed regulations, and must be found physically fit for the Navy.

The Medical Examination includes dental examination. If remediable dental defects are discovered, the parents or guardians of successful candidates are required to arrange for necessary treatment to be undertaken, at their own risk and expense, before the Cadet is due to join the Royal Naval College, Dartmouth, where a further examination of the teeth will be made.

\* Should any case occur where a selected candidate is prevented by illness from attending the Qualifying Examination, the Admiralty will consider whether special arrangements can be made for him to be examined by the Head Master of the Royal Naval College, Dartmouth, either at the end of the current term or at the beginning of the ensuing term.

It should be particularly noted that full normal vision—as determined by Snellen's tests—is required. Details of the physical requirements of candidates are shown on page 1076.

In the event of the rejection on medical grounds of a candidate who would otherwise have been selected for the Qualifying Examination, the parent or guardian will at once be informed that, subject to the payment of a fee of four guineas, the candidate may present himself for re-examination by an Appeal Board. This Appeal Board will consist of the Medical Director-General of the Navy, together with a physician or a surgeon or a specialist nominated by the Medical Consultative Board, according to the nature of the alleged disqualification or disqualifications.

#### Syllabus of Qualifying Examination.

8.\* The Qualifying Examination is in the following subjects :—

- (1) English (including writing from dictation and reproduction of the gist of a short passage twice read aloud to the candidates).
- (2) History and Geography, with special reference to the British Empire.
- (3) Arithmetic and Algebra (two-thirds of the questions in this paper will be on Arithmetic. The use of algebraic symbols and processes will be allowed).

*Arithmetic.*—The simple and compound rules, avoirdupois weight, linear and square and cubic measures, the elementary mensuration of rectangular surfaces and volumes, measure of capacity (pints, quarts, gallons), the metric system (the metre, gramme and litre, with their multiples and sub-multiples), money (including the relationship of the cent to the dollar, and the centime to the franc), reduction, factors, the addition, subtraction, multiplication, division, and simplification of vulgar fractions, non-recurring decimal fractions, simple proportion, ratio and percentage, simple interest.

*Algebra.*—The meaning of algebraic symbols, substitution of values, easy identities, equations of the first degree including simultaneous equations, verification of the solution of equations, problems leading to simple equations, multiplication and division by binomial operator, easy factors (excluding sum and difference of cubes), fractions with numerical denominators.

- (4) Geometry. The paper will consist of questions both on Practical and on Theoretical Geometry.

All candidates must be provided with a ruler graduated in inches and tenths, and also in centimetres and millimetres, a small set square, a protractor, pencil compasses, and a hard pencil.

Any proof of a proposition will be accepted which appears to the Examiner to form part of a systematic treatment of the subject. Simple deductions from specified theorems will be set.

Proofs of the validity of constructions will not as a rule be expected but they may be asked for.

Practical Geometry. The constructions shown in the appended Schedule A, 1-7. See page 1077.

Theoretical Geometry. See appended Schedule B, page 1077. The facts stated in the following theorems, together with riders on them, but without formal proofs of the theorems :—B, 1-11. Formal proofs of the following theorems, together with riders on them :—B, 12-19.

*Note.*—The numbers in the Schedules correspond to those in the Geometry Schedule of the Common Examination for entrance to Public Schools as reprinted from the Cambridge University Ordinances.

- (5) French, with an oral examination to which importance will be attached.
- (6) Latin (easy passages for translation from Latin into English and from English into Latin, and simple grammatical questions).

The list of successful candidates will be published in alphabetical order.

#### Applications from certain Dominions and Colonies.

9. The Governments of certain Dominions and Colonies are allowed to recommend specially (through the Secretary of State for Dominion Affairs and the Colonies), a certain number of candidates annually from among boys belonging to families resident in the Dominions and Colonies.

Unless such candidates, however, actually reside and receive their education in their own Dominion or Colony, they must be also recommended by the Interview Committee, and they must in any case pass the Qualifying Examination and the Medical Examination.

#### King's Cadetships.

10. Successful candidates who are the sons of officers of the Royal Navy, Royal Marines, Army, or Royal Air Force who have been killed in action, or have died of wounds received in action, whether afloat or ashore, or have died through the destruction of their ship, or have been drowned or have suffered other violent death due directly and wholly to war service, or have died of disease attributable to active service, may be appointed as King's Cadets.

King's Cadets will be entitled to the following privileges in cases where the Admiralty are of opinion that substantial help is needed towards the expenses of their naval training :—

- (1) The grant of an Outfit Allowance of 40*l.* on first entry.
- (2) The remission of fees at Dartmouth.
- (3) The remission of supplementary allowances mentioned in paragraph 18.

In cases where the above conditions are fulfilled by Cadets, already in the Service, the Admiralty may, at their discretion, authorise the remission of all future payments in respect of training fees and supplementary allowance.

King's Cadets will be eligible for Children's Allowances as prescribed by the regulations, but will not receive Educational Allowances.

Applications for King's Cadetships must be received a month before a Cadet is due to join Dartmouth.

#### Duration of Course, Terms, &c.

11. Naval Cadets will undergo a course of instruction at the R.N. College, Dartmouth, extending over eleven terms, or 3½ years. On passing out of Dartmouth, they will be sent to sea for a further period of training as a Naval Cadet before being rated Midshipmen.

12. The following are the approximate dates for the beginning and end of the three terms at the College, and the lengths of the vacations :—

13. The friends of the Cadets must be prepared to receive them during all the vacations.

14. All Naval Cadets, while at the Royal Naval College, Dartmouth, and while serving with the Fleet, shall be subject to the regulations respecting Cadets in force for the time being.

Naval Cadets will each undergo a trip in a submarine once during their course at the College.

\* Papers set at the examination may be obtained on payment from the following :—

Oxford University Press at Amen House, London, E.C.4, or 116, High Street, Oxford; Cambridge University Press, Fetter Lane, London, E.C.4; and Deighton, Bell & Co., Trinity Street, Cambridge.



**Financial Arrangements.**

15. For Cadets entering under these regulations, payment will be at the rate of 150*l.* per annum for the period under training at the College, to be paid in sums of 50*l.* every term IN ADVANCE on receipt of a claim from the Director of Navy Accounts, to whom cheques, crossed "Bank of England," should be made payable. But the Lords Commissioners of the Admiralty reserve the power of selecting from among the Cadets entered on each occasion, a number with respect to whom reduced fees will be allowed. The reduced scales will be allowed only in cases where the pecuniary circumstances of the parents are, in the opinion of the Lords Commissioners of the Admiralty, such as to justify it. Forms of application for admission at the reduced scales will be issued in respect of all candidates who are selected\* after the interview to attend the Qualifying Examination, and when duly filled in should be returned as soon as possible *by such parents as desire to make application for the reduced scale.* If the parents or guardians of a Cadet are resident abroad, arrangements should be made with an agent in Great Britain to pay claims for fees, &c.

Parents or guardians who may find especial difficulty in meeting the initial cost of outfit may, at Admiralty discretion, be granted an outfit allowance of 40*l.* with a corresponding increase in the rate of fees which would otherwise have been charged. Special application should be made to the Admiralty when the application for reduced fees is forwarded, if parents or guardians desire to avail themselves of this arrangement.

If a Cadet is absent at home on sick leave for a period of 21 days or more in any one term, an abatement of half the normal fee for the period of his absence is made from the claim for the following term, when the full duration of his absence is known. No such abatement is granted when a Cadet is sick in a Naval Hospital.

16. In addition to the above payments, any expenses incurred by a Cadet for clothing, sports, books, instruments, washing, &c., as well as the allowance of 1*s.* a week paid as pocket money are included in the account sent to the parent by the Director of Navy Accounts.

17. No pay is allowed to the Cadets in the College, except in the case of Cadet Captains, who receive a small weekly allowance.

18. The fees specified in paragraph 15 will cease on the Cadet leaving Dartmouth, when he will normally be sent to a Cadets' training-ship, for a period of approximately eight months, to complete his training before being appointed Midshipman. During the period of training in the Cadets' training-ship he will be paid at the rate of 1*s.* a day and an allowance at the rate of £36 a year, payable in advance, will be required from his parent or guardian to cover his expenses. This allowance together with the Cadet's pay of 1*s.* a day and the allowance for messing, should normally be sufficient to meet his expenses during the cruise, but should this not be the case, the deficit, which would probably be of small amount would be chargeable to the parent or guardian. In the event, however, of a Cadet being sent to a seagoing ship of the Fleet (not a training-ship) his naval pay will be at the rate of 4*s.* a day and his parent or guardian will be required to pay in advance an allowance at the rate of 1*s.* a day, which will be used to supplement his naval pay. The allowances will be claimed periodically by the Director of Navy Accounts.

18A. It is undesirable that young officers should have control of considerable sums of money. The pay of Midshipmen is sufficient to enable them to meet their normal current expenses afloat, and it should therefore not be necessary for parents or guardians to make them personal allowances, except as may be required to meet the cost of uniform and of travelling expenses on leave. If the parent or guardian of one of these officers desires that he should have greater means to enable him to visit places of interest whilst serving abroad, he may remit a sum, not exceeding £20 per annum, to the Director of Navy Accounts, to be placed by him under the Control of the Captain, to be expended for the purpose stated and at such times as the Captain may approve.

19. The parent or guardian of every Cadet is required to provide outfit under the regulations in force.

20. All travelling expenses for Cadets are advanced by the Paymaster of the College, who will charge the sum to the Cadet's personal account.

**Medical and Dental Treatment.**

21. While at the R.N. College, Cadets may receive free of expense such treatment as can be afforded by the Naval Medical Staff, or in the Sick Quarters, of the College. They are admitted to Naval Hospitals for treatment only in exceptional circumstances. When so admitted, no charge for treatment is made, but the normal College fees continue to be payable. Cadets are not eligible for medical treatment at the public expense whilst on leave.

22. Cadets while at the R.N. College are not eligible to receive dental treatment at the public expense and parents or guardians should arrange for Cadets to receive necessary dental treatment during vacations. Should urgent dental treatment be found necessary during term, the Cadet will be referred to a local civilian dental surgeon, the cost of treatment\* being defrayed by the parent or guardian.

23. Cadets borne for pay for service afloat (see paragraph 17) are eligible for medical and dental treatment at the public expense, under the regulations applicable to officers generally.

**General Regulations at Dartmouth.**

24. Inasmuch as the Cadets have a weekly allowance paid to them as pocket money, and a charge is made to pay the expenses attending their amusements, it is unnecessary that their friends should give them any money, except on joining or on their return from the vacations, and the amount should then be reasonable. Such money as may be required by a Cadet for any special circumstance will be advanced by the Paymaster under the authority of the Captain.

25. Any valuable gold watches or chains brought by the Cadets to the College will be taken from them and placed in security until the Cadets return home. Silver watches may be used.

26. Instructions to Cadets joining the College for the first time will be sent by the Commanding Officer. Cadets rejoining the College will be expected to make their own arrangements for doing so.

27. Cadets are to bring their linen clean, and clothes and boots in good order, when they join the College, and also when they return from leave, and the outfit must be complete. A list of the clothes left behind will be sent with Cadets when they go on leave.

28. Cadets are not permitted to open accounts with tradesmen. Parents or guardians are requested not to allow their sons' outfitters to supply clothes or other articles without their authorisation.

29. Each Cadet on joining and on returning after the vacations is required to produce a health certificate—signed by his parent or guardian *not earlier than the day before the Cadet's return*—to the effect that, so far as is known, he has not, for at least three weeks immediately preceding his return, been exposed to any infectious disease, or entered any house where such disease had existed. A certificate, drawn up in the necessary form, is sent to each parent, and failure on the part of the Cadet to produce this certificate, duly filled up and signed, on his return may entail his *not being received.*

In the event of a Cadet being placed on the sick list, information is always sent to his parents or guardians, who are also kept informed of the progress of the patient should the illness be in the slightest degree serious.

With a view to dealing with possible scarlet-fever outbreaks in the College, all new entry Cadets will, subject to parents' consent, undergo the Dick test to ascertain their susceptibility to the disease.

30. Letters relative to the Cadets should be addressed to "The Commanding Officer, Royal Naval College, Dartmouth," if the Cadet is in Dartmouth, or "The Commanding Officer, H.M.S. . . . ., c/o G.P.O., London," if the Cadet is serving afloat, and not to the Captain by name.

Parents or guardians of Cadets must inform the Admiralty and the Commanding Officer of the College or the ship in which the Cadet is serving of any permanent change of residence without delay.

\* Note.—Parents abroad will, however, be furnished with forms of application, prior to this selection if they so desire.

**31. Curriculum.**

While the course at the College is designed to meet the special needs of a naval officer, it is far from being purely vocational. The allocation of class periods to subjects is approximately as follows:—

Also one period a week during the first seven terms is given up to lectures on "Special Subjects" outside the ordinary curriculum.

32. A Cadet's place in his term is decided partly by marks for current work and partly by examination at the end of term. After examination at the end of the eighth term, the ablest Cadets are selected to take during their last year a course of study different in some respects from that given to all other Cadets. This group of selected Cadets, called the Alpha Class, is organised to afford greater opportunities for private study together with a limited choice of subjects in which rather more advanced work may be attempted. Cadets in the Alpha Class do not take the ordinary papers in the Passing-out Examination except in Seamanship, Navigation and Engineering, but if their work in all subjects proves satisfactory, they are awarded First Classes.

**Passing Out.**

33. The Passing-out Examination is representative of all subjects studied at the College, with the exception of Religious Knowledge and the "Special Subjects," which do not form part of the official examination. Marks for work done during previous terms are combined with the marks directly awarded in the examination.

First, Second and Third Classes will be awarded, and the class obtained in passing out from the College counts afterwards towards promotion to the rank of Sub-Lieutenant, promotion being accelerated according to the following scale:—

The amount of time awarded is subject to revision.

**Admiralty Prizes.**

34. The following is a list of the Admiralty prizes for Cadets at Dartmouth:—

*Robert Roxburgh Prize.*—Books, accoutrements, &c., to the value of about 14*l.*, awarded each term to the Cadet who obtains the highest place in his term on passing out.

*Graham Naval History Prize.*—Books, instruments, accoutrements, &c., to the value of £6 : 6 : 0, awarded to the Cadet of the 8th, 9th or 10th Term who obtains the highest place in a voluntary examination (usually held in the Easter Term) on a special book or period of Naval History.

*Harold Tennyson Prize.*—Books to the value of about 3*l.* 10*s.*, awarded each term of the Cadet of the 9th Term who comes out first in an examination in English Literature.

*Passing Out.*—Two prizes each, one for the Alpha Class and one for the rest, for Mathematics, French, Science, History and English; one prize each for Scripture, Engineering, Navigation and Seamanship.

*Tenth Term.*—One prize for Scripture Repetition.

*Ninth Term.*—One prize for Navigation.

*Eighth and Seventh Terms.*—One prize each for Mathematics, French, Engineering, Science, Scripture Seamanship, History and English.

*Sixth and Fifth Terms.*—One prize each for Mathematics, French, Science, History, English, Scripture Repetition, Grand Aggregate and Geography.

Special prizes may be awarded at the discretion of the Headmaster for work of outstanding merit during the course.

**Withdrawal.**

35. Cadets may be required to withdraw at any time, if, in the opinion of the Lords Commissioners of the Admiralty—

- (1) They fail to reach a satisfactory standard, or
- (2) Their conduct is unsatisfactory, or
- (3) They are unsuitable for the naval service.

36. It is to be distinctly understood that the period of training, including the time spent as a Cadet in a seagoing ship, is a time of probation, and that the parent or guardian of a Cadet is required to withdraw him immediately, on the receipt of an official request for his withdrawal.

37. When a Cadet is found to be making insufficient progress, a letter is sent to his parent or guardian, warning him of the possibility of having to withdraw the Cadet unless a marked improvement takes place. This warning is generally issued a term in advance, to enable the parent provisionally to make other arrangements for continuing the boy's education in case his withdrawal should become necessary.

**Physical Requirements for Candidates for Commissions in the Royal Navy.**

With a view to preventing candidates who may be physically unfit for His Majesty's Service from incurring the inconvenience and expense of preparing for commissions in the Royal Navy, it is suggested that they undergo examination by the medical adviser of the family, or any other qualified medical practitioner, to whom the following list of defects which cause rejection may be submitted for guidance.

It is to be understood that this private examination is merely suggested as a guide for intending candidates and to lessen the chances of disappointment, and that it is by no means intended to take the place of, or to influence in any way the regular official physical examination.

1. A weak constitution, imperfect development, physical weakness, either hereditary or from chronic disease wounds or injuries.
2. Skin disease, unless temporary or trivial.
3. Malformation of the head, deformity from fracture or depression of the bones of the skull, impaired intellect, epilepsy, paralysis, or impediment of speech.
4. Blindness or defective vision, squint, imperfect perception of colours, fistula lachrymalis, or any chronic disease of the eyes or eyelids.



Candidates for Naval Cadetships at the Royal Naval College, Dartmouth, must possess full normal vision, viz. :— 6/6, and be able to read D = 5, as determined by Snellen's Test types, each eye being separately examined without glasses. A high degree of hypermetropia will disqualify.

5. Impaired hearing, or discharge from one or both ears, or any disease of the external, middle, or internal ear.
6. Disease of the bones of the nose, or if its cartilages, nasal polypus, or disease of the naso-pharynx.
7. Disease of the throat, tongue, palate, or tonsils; many unsound or functionless teeth,\* deformity of the jaws resulting in inefficient occlusion of the teeth, unhealthy gums, disease of the glands of the throat or neck, external cicatrices, if at all extensive, and especially if adherent.
8. Functional or organic disease of the heart or blood vessels, deformity or contraction of the chest, or any symptom of lung disease or tendency thereto.
9. Undue swelling or distension of the abdomen, obesity, disease or enlargement of the abdominal organs. Rupture, weakness or distension of the abdominal rings: any disease of the bladder or incontinence of urine.
10. The existence of any serious defect of the genital organs, or of varicocele, when it clearly forms or is likely to form a serious impediment to the efficient performance of duty, e.g., when it is associated with varicose veins or piles.
11. Paralysis, weakness, impaired motion, or deformity of the upper or lower extremities, from whatever cause; a varicose state of the veins, especially of the leg. Bunions, distortion or malformation of the hands, feet, fingers or toes.
12. Distortion of the spine, of the bones of the chest, or pelvis, from injury or constitutional defect.

No person will be admitted into His Majesty's Service unless he has been vaccinated or re-vaccinated during the last five years.

### Schedules of Geometry in the Qualifying Examination.

#### A.—PRACTICAL GEOMETRY.

1. Bisection of angles and of straight lines.
2. Construction of perpendiculars to straight lines.
3. Construction of an angle equal to a given angle.
4. Construction of parallels to a given straight line.
5. Simple cases of the construction from sufficient data of triangles and quadrilaterals.
6. Division of straight lines into a given number of equal parts or into parts in any given proportion.
7. Construction of a triangle equal in area to a given polygon.

#### B.—THEORETICAL GEOMETRY.

##### *Angles at a Point.*

1. If a straight line stands on another straight line, the sum of the two angles so formed is equal to two right angles; and the converse.
2. If two straight lines intersect, the vertically opposite angles are equal.

##### *Parallel Straight Lines.*

3. When a straight line cuts two other straight lines, if
  - (i) pair of alternate angles are equal,
  - or (ii) a pair of corresponding angles are equal,
  - or (iii) a pair of interior angles on the same side of the cutting line are together equal to two right angles,
 then the two straight lines are parallel; and the converse.
4. Straight lines which are parallel to the same straight line are parallel to one another.

##### *Triangles and Rectilinear Figures.*

5. The sum of the angles of a triangle is equal to two right angles.
6. If the sides of a convex polygon are produced in order, the sum of the angles so formed is equal to four right angles.
7. If two triangles have two sides of the one equal to two sides of the other, each to each, and also the angles contained by those sides equal, the triangles are congruent.
8. If two triangles have two angles of the one equal to two angles of the other, each to each, and also one side of the one equal to the corresponding side of the other, the triangles are congruent.
9. If two sides of a triangle are equal, the angles opposite to these sides are equal; and the converse.
10. If two triangles have the three sides of the one equal to the three sides of the other, each to each, the triangles are congruent.
11. If two right-angled triangles have their hypotenuses equal, and one side of the one equal to one side of the other, the triangles are congruent.
12. The opposite sides and angles of a parallelogram are equal, each diagonal bisects the parallelogram, and the diagonals bisect one another.
13. If there are three or more parallel straight lines, and the intercepts made by them on any straight line that cuts them are equal, then the corresponding intercepts on any other straight line that cuts them are also equal.

##### *Areas.*

14. Parallelograms on the same or equal bases and of the same altitude are equal in area.
15. Triangles on the same or equal bases and of the same altitude are equal in area.
16. Equal triangles on the same or equal bases are of the same altitude.
17. Illustrations and explanations of the geometrical theorems corresponding to the following algebraical identities:—

$$\begin{aligned}
 k(a + b + c + \dots) &= ka + kb + kc + \dots, \\
 (a + b)^2 &= a^2 + 2ab + b^2, \\
 (a - b)^2 &= a^2 - 2ab + b^2, \\
 a^2 - b^2 &= (a + b)(a - b).
 \end{aligned}$$

##### *Loci.*

18. The locus of a point which is equidistant from two fixed points is the perpendicular bisector of the straight line joining the two fixed points.
19. The locus of a point which is equidistant from two intersecting straight lines consists of a pair of straight lines which bisect the angles between the two given lines.

\* *i.e.*—Seven teeth missing or irreparable in persons under 17 years of age on the date of entry, ten missing or irreparable in persons above the age of 17; a tooth is considered irreparable if it cannot obviously be made permanently serviceable by dental repair. Credit may be given for teeth which have not erupted, provided failure to erupt is not due to abnormality. Candidates must, however, possess a sufficient number of sound opposing molars and incisors to ensure an efficient masticating area. The numbers given above are intended as a general guide only.

## THE DEFENCE FORCE ORDINANCE, 1910.

REGULATION under sections 9 and 12 of the Defence Force Ordinance, 1910, made by the Officer Commanding the Troops after consultation with the Commandant and approved by His Excellency the Officer Administering the Government.

## THE QUARANTINE AND PREVENTION OF DISEASES ORDINANCE, 1897.

REGULATIONS for the area comprised within the Municipality of Galle, made by the Officer Administering the Government in pursuance of the powers vested in the Governor by sections 4 and 5 of the Quarantine and Prevention of Diseases Ordinance, 1897, and by Article 93 of the Ceylon (State Council) Order in Council, 1931.

## REGULATIONS.

1. In these regulations unless the context otherwise requires—

"Owner" in relation to any premises shall include—

- the person in possession thereof or claiming to be entitled thereto,
- any person receiving the rent thereof, whether on his own account, or as agent or trustee for any other person, or who would receive such rent if the premises were let to a tenant,
- the lessee, and
- the person in charge of the premises in any capacity whatsoever;

"Municipality" shall mean the area within the Municipal limits of Galle;

"Chairman" shall mean the Chairman of the Municipal Council of Galle.

2. (1) It shall be lawful for the Chairman at any time by notice in writing to direct all such measures to be taken in respect of any house, building, or premises within the Municipality, as may in his opinion be necessary or expedient for preventing the introduction and the spread of plague in any area within the Municipality.

(2) Such notice may be given, in the case of a place of worship, to the trustee thereof, or if there is no duly appointed trustee, to the manager of the affairs of such place of worship, or to the principal custodian thereof, and in the case of any house or building whether used as a place of residence or as a place of trade or business, to the chief occupant; or if distinct portions of such house or building are in separate occupation, to the chief occupant of each such portion, or where such house or building is unoccupied, or the owner or lessee is bound to carry out repairs, to such owner or lessee.

3. (1) Every such notice shall specify a reasonable period within which the directions or requirements therein set out are to be complied with.

(2) Service of any such notice may be effected—

- upon an occupier, either personally or by leaving the notice with some adult inmate of the building or premises to which the notice relates, and by putting up the notice on some conspicuous part of such building or premises;
- upon an owner or trustee or a manager or a principal custodian or a lessee, either personally, and by leaving the notice at the place of residence or of business of such owner or trustee or manager or principal custodian or lessee or his authorized agent, or by posting a registered letter addressed to such owner or trustee or manager or principal custodian or lessee or agent at his last known place of residence or of business.

4. The notice aforesaid may extend to all such matters of construction, renovation, repair, or maintenance or cleaning, disinfecting, or limewashing, or removal or demolition, as may be deemed necessary by the Chairman, and may include among others, any or all of the following directions and requirements :—

- the erection across doors, windows, drains, and similar openings of screens, barriers, or traps, whether of cement concrete, expanded metal or wire netting, of any design or type that may be approved by the Chairman as adequate for the purpose of preventing the entry of rats into such building or premises;
- the effective filling up with broken glass and cement of all holes in walls and floors which may afford harbourage or breeding places for rats;
- the alteration, removal, or demolition of walls or partitions affording or likely to afford harbourage or breeding places for rats;
- the filling up and closing of disused drains and drains inside a house or building;

- (v.) the conversion or diversion of underground drains into open air surface drains ;
- (vi.) the erection of mesh barriers or metal traps in the underground drains so as to prevent the entry of rats through such drains into the building ;
- (vii.) the providing of sufficient light and ventilation—
- (a) in the case of rooms with one or more walls abutting on the open air, by means of windows or both doors and windows in such walls, of an aggregate opening of one-seventh of the floor area of the room, the windows not being less than one-fifteenth of the floor area in the event of both doors and windows being provided ;
- (b) in the case of rooms which do not and cannot be made to abut on the open air, by means of dormer windows and glass tiles equal in the aggregate to one-fifteenth of the floor area ;
- (viii.) the cleansing and disinfecting of the house, building, or premises, both externally and internally, the limewashing of walls, the cementing of the floor and the like ;
- (ix.) the removal or demolition of any loft or structure, fixture, or other thing, which obstructs or is likely to obstruct the proper cleansing of, and the maintenance of sanitary conditions in, any house, building, or premises.

5. No person served with any notice as aforesaid shall refuse or fail or neglect for any reason whatsoever, to comply with the terms of such notice within the period specified therein.

6. Every house, building, or premises of any kind, whether used as a place of residence or as a place of trade or business or worship, shall at all times be kept by the occupier, and in the case of a place of worship, by the trustee or trustees, or manager or principal custodian, in a clean and sanitary condition to the satisfaction of the Chairman.

7. No rubbish, manure, or waste or decaying matter shall be dumped, or left, or permitted to remain, or to accumulate upon the floor, courtyard, or garden of any house, building, or premises of any kind. The chief occupant of such house, building, or premises shall be liable for any breach of this regulation.

8. Any failure or neglect to sweep with reasonable regularity and to keep clean and free of rubbish and of weeds any yard, court, or garden, or passage, path, or backlane common to several houses, buildings, or apartments which are in separate occupation shall be an offence for which the chief occupant of each of the said houses, buildings, or apartments in separate occupation, shall be severally liable.

9. Every building, structure, or premises used as a place of trade or business shall be provided with a metal dust bin not less than  $4\frac{1}{2}$  cubic feet in capacity in which shall be stored all the garbage and waste matter of the said premises and, except when garbage or waste matter is being deposited or taken from the said metal bin, it shall at all times be covered with a metal cover.

10. The ground floor of all buildings used for trade purposes and as stores shall be of cement concrete not less than 4 inches thick, and the cementing shall be carried over the lower end of the walls to a height of 3 feet.

11. (1) No articles of food or drink whether raw or cooked or other similar goods or merchandise, shall be kept in any building used for purposes of trade, except on platforms as hereinafter specified.

(2) Such platforms shall be not less than 18 inches in height and shall be open on the sides, and so constructed as not to interfere with the lighting and the ventilation or the cleaning and sweeping of such building, and shall be so placed as to allow of a clear space of at least 18 inches on all sides.

(3) No goods or articles of any kind whatsoever shall be placed or stored either under the platforms or within 4 feet of the roof or ceiling.

(4) One-fourth of the floor area of any room or hall or enclosed space, where any of the aforesaid goods or articles are stored, shall be left free and unoccupied.

12. Once during each of the months of March, June, September, and December in each year, every occupier of any building or premises used for purposes of trade, shall take out all goods and merchandise stored therein, and before replacing them cause all rat-holes in walls and floor to be filled up with broken glass and cement and every part of such building to be thoroughly cleaned and repaired or renewed when necessary : Provided that the Chairman may exempt from the provisions of this regulation any building or premises, the goods stored in which are incapable of attracting rats or affording them harbourage or breeding places.

13. No person shall remove, or cover up, or in any other way interfere with, any rat traps or poison baits laid in any building or premises by any officer authorized by the Chairman.

14. (1) It shall be the duty of the occupier of any house, building, or premises in which any rat, other than a rat caught or killed in a trap, dies or is found dead, to remove the body with a pair of tongs or such other contrivance and place it in a vessel containing kerosene oil and forthwith to report the fact of such death to the Chairman.

(2) No person shall place or throw the body of any rat so dying or found dead into or upon any drain, street, path, garden, or other place or open space or dispose of such body in any way other than that aforesaid.

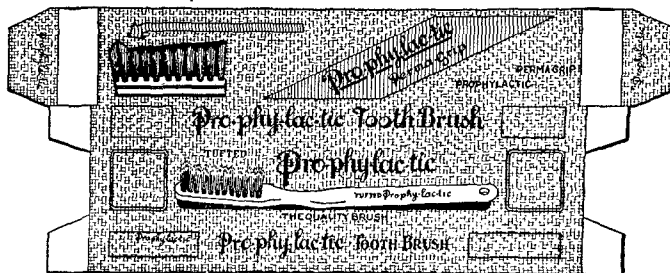
