## ABSTRACT OF SEASON REPORTS FOR THE MONTH ENDED AUGUST 31, 1895.

## WESTERN PROVINCE

## COLOMBO DISTRICT.

**Paddy :** yala crops are ripening and will be harvested during next month, and there is prospect of a fairly good maha.

**Dry grain :** no cultivation to report.

**Other products :** the supply of fruit and vegetables is good, and prices are moderate.

**Prices of staple products :** rice from Rs. 3 to Rs. 4 a bushel ; coconuts, from Rs. 30 to Rs. 40 per 1,000.

**Rainfall :** during the month rainfall was below the average.

**Remarks on harvest prospects generally :** the prospects of a fairly good yala harvest continue to be favourable.

## NEGOMBO DISTRICT.

**Paddy :** the prospects of the crops of the yala harvest are good, but in Hapitigam korale some fields have suffered from drought. **Maha harvest :** fields have been sown and are thriving well, except in Hapitigam korale, where, owing to the drought, their appearance is not very promising.

**Dry grain :** crops are good and partly harvested.

**Other products :** vegetables are scarce throughout the district ; the fruit season is drawing to a close.

**Prices of staple products :** rice, Rs. 3.25 to Rs. 4 per bushel ; paddy, Re. 1.50 to Rs. 2 per bushel ; coconuts, Rs. 30 per 1,000.

**Rainfall :** scarce.

**Remarks on harvest prospects generally :** good.

## KALUTARA DISTRICT.

**Paddy :** the reaping of the yala harvest has commenced ; a fairly good crop is expected.

**Dry grain :** harvesting is going on in Rayigam and Pasdun korales. There is no dry grain cultivation in the Kalutara and Panadure Totamunes.

**Other products :** fruits and vegetables are scarce in the Pasdun korale and Totamunes, and not abundant in the Rayigam korale.

**Prices of staple products :** imported rice, Rs. 3 to Rs. 4 a bushel ; country rice, Rs. 3 to Rs. 4 a bushel ; coconuts, Rs. 3 to Rs. 5 per 100.

**Rainfall :** light throughout the district, except in Pasdun korale west, where rain was abundant.

**Remarks on harvest prospects generally :** fair.

## CENTRAL PROVINCE.

## KANDY DISTRICT.

**Paddy, maha :** fields being ploughed and sown ; crop or prospects : too early to form an opinion. **Yala :** crops blossoming and ripening, a few fields in Pata Hewaheta are harvesting ; crop or prospects : fair.

**Dry grain, maha :** hill paddy chenas in Tumpane are being transplanted, Harispattu are in small plants, Pata Dumbara being sown, Uda Dumbara and Pata Hewaheta chenas being cleared ; crop or prospects : too early to form an opinion. **Yala :** kurakkan in Harispattu and Uda Dumbara blossoming, Tumpane and Pata Hewaheta ripening and harvesting, Udapalata sowing ; crop or prospects : bad in Pata Hewaheta, fair in other districts.

**Rainfall :** sufficient in Uda Dumbara, Pata Hewaheta, Udapalata, and Uda Bulatgama ; insufficient in the other divisions.

**Prices :** paddy per bushel, Re. 1.50 ; kurakkan, Re. 1.25 ; coconuts per 100, Rs. 4.

## NUWARA ELIYA DISTRICT.

**Paddy :** Kotmale, maha sowing continued from last month ; Uda Hewaheta, one to two months' old paddy ; Walapane, yala sowing continued.

**Dry grain :** Kotmale, kurakkan plants still young ; Uda Hewaheta and Walapane, kurakkan cultivation commenced.

**Rain :** Kotmale and Uda Hewaheta, rain sufficient.

**Prices of staple articles :** paddy, Re. 1.50 per bushel ; kurakkan and Indian corn, Re. 1.25 to Re. 1.37 a bushel ; coconuts, Rs. 6 to Rs. 7 a hundred.

**Fruits and vegetables :** there was a good supply of fruits and vegetables.

## MATALE DISTRICT.

**Matale South :** the rainfall was better than that of the preceding month. The yala fields are being harvested in some korales and are ripening in others ; prospects are fair. The recent rains have enabled the villagers to begin operations for the maha sowing in some places.

**Matale North :** the rainfall was fair, and has done much good to the country in filling the wells, which were fast drying up owing to the drought. The yala fields are in different stages of maturity. Chenas are being cleared for kurakkan cultivation.

**Matale East :** the yala fields are being reaped with good returns. Chenas are being cleared.

## NORTHERN PROVINCE.

## JAFFNA DISTRICT.

**Weather :** there was heavy rain, accompanied by thunder and lightning, almost throughout the district on the 23rd and 30th, and some partial showers on the 11th and between the 17th and 22nd and again between the 24th and 29th. The rainfall registered at the Public Works Department Office, Jaffna, was 4.67 inches.

**Paddy, kalapokam, of 1896 :** advantage was taken of the rains to continue the ploughing and manuring of the paddy fields in the district, and in some divisions sowing was commenced, particularly in low lands.

**Dry grain crops :** sowing of varaku commenced. Other dry grains, panichami and tinaichami, were reaped, and the outturn is reported good. Kurakkan and payaru in plants, and prospects reported good, having been much benefited by the rains.

**Palmirah fruit :** the crop of palmirah fruit was gathered in during the month.

**Prices of staple articles :** paddy, Re. 1.75 per bushel ; rice, Rs. 3.50 per bushel ; kurakkan, Re. 1.50 per bushel ; tinaichami, Re. 1.25 per bushel ; panichami, Re. 1.20 per bushel ; varaku, Re. 1.25 per bushel ; and pinaddu, Rs. 3.75 per kudai.

## MULLAITTIVU DISTRICT.

Threshing of paddy still going on in maritime pattus; fields are being prepared for cultivation throughout the district; some sowing took place in Puthukkudiyurpu and Odduchuddan.

Prices of food articles: paddy per bushel, Re. 1.50; rice per bushel, Rs. 3.60; kurakkan per bushel, Re. 1.25; varaku per bushel Re. 1; manioc per lb., 4 cents.

Good rain throughout the district about the middle of the month.

## MANNAR DISTRICT.

The maha crops in Mantai pattu are still being threshed, and the fields manured and fenced for next maha crop. Preparations are being made for maha cultivation in beds of tanks in Muchali and Nanaddan pattus.

Jungle is being cleared for dry grain cultivation in Mantai pattu and Mannar island.

Paddy sells at Re. 1.62 per bushel; kurakkan at Re. 1.50 per bushel.

Health of people fair: There are a few cases of fever and dysentery. The outbreak of cholera was arrested at the latter part of the month.

Health of cattle: cattle generally suffer greatly for want of water and pasture.

Sea-fishing poor, south-west wind being very strong.

Rainfall: 0.11.

## VAVUNIYA DISTRICT.

1. Slight and partial showers of rain throughout the district during third week. Heat great and wind moderate in early part of month.

2. A few kalapokam paddy stacks were threshed during the month in Melpattu. The small yala crop raised in the tank beds of Pumadu and Mahamailankulam are in course of reaping, and those raised in Madukanda and Kudakachnakodiya were harvested. Steps are being taken generally for the cultivation of tank beds. Fences are being put up for dry sowing under tanks in some villages.

3. Prices of grain as last month; price of gingelly in the Sinhalese villages is slightly on the increase.

4. Cattle disease in the Sinhalese villages died out among buffaloes, but has appeared among black cattle in a different form. The disease has broken out in Suduventhapila in Chinnacheddikulam West, Chalampaikulam and Velankulam in Nducheddikulam, and Averankulam in Metkumulai.

5. A few cases of cholera among the immigrant coolies at Kallar and Mankulam and Public Works Department coolies at Parayanalankulam on the Mannar-Madawachchi road in early part of month. The disease has disappeared.

## SOUTHERN PROVINCE.

## GALLE DISTRICT.

Paddy, yala: crop in Four Gravets and Akmimana reaped, and the return favourable. In all the other pattus except Bentota, also reaped, but the harvest in Gangaboda and Hinidum pattus poor, and in Talpe and Wellaboda pattus middling, owing to damage done by flies. Reaping commenced at Bentota, and the return in the interior is poor, crop having been fly-blown owing to early rain. The return of Dedduwa lands is expected to be favourable, although in some parts damaged by flies.

Dry grain, yala: hill paddy crop poor, but amu, mederi, and kurakkan gave a good return.

Miscellaneous: jak, plantains, potatoes, breadfruit, and other vegetables scarce, but cocoanuts plentiful; price per 1,000 cocoanuts from Rs. 25 to Rs. 30.

Price of staple products: rice from Rs. 3 to Rs. 3.50 per bushel; paddy, Re. 1.25; mederi and kurakkan Re. 1.25 to Re. 1.50; amu, Re. 1.

Rainfall at Galle: 5.67 inches.

Health unfatisfactory; fever has been prevalent in Gravets and there have been many deaths. There was some fever in Talpe pattu; also a few cases of dysentery, chickenpox, and measles. In Gangaboda pattu, Wellaboda pattu, and Bentota-Walallawiti korale there have been cases of dysentery, and in Hinidum pattu measles.

Cattle free from disease.

## HAMBANTOTA DISTRICT.

*Magam Pattu.*—Paddy: no cultivation for yala at Tissa. Maha muddings are just commencing. Western Walakada crops are ripening, and the harvest is expected to prove successful. The crop of the second maha in Eastern Walakada has already been threshed and removed. The first maha cultivation is not likely to be taken in hand owing to the scarcity of water. The second maha will very likely be taken up.

Dry grain: no dry grain to be had in the district at present, except what is sold by traders.

Staple products: prices of articles remain the same as last month.

*Girawa Pattu West.*—Paddy: the occasional showers which fell during the month have to some extent been beneficial to the paddy crops. Under the Mandaduwa channel, Kirama-ela, and Arachchi amuna the crop is reported to be bad, and under the Udukiriwila irrigation works the crop middling.

Dry grain: applications are still being made to clear chenas for maha. Complaints have been submitted to the court for illicit cultivation.

Miscellaneous: jak, breadfruit, sweet potatoes, and dry grain are scanty, and the yield of the coconut tree is also poor.

Prices of staple products: paddy per bushel, from Re. 1.62½ to Re. 1.75; rice per bushel, Rs. 4.25; kurakkan per bushel, Re. 1.50; breadfruit per 100, Rs. 5; sweet potatoes per cwt., Rs. 2; plantain bunches per 100, Rs. 50; Indian corn per 100 pods, 75 cents; cocoanuts per 1,000, from Rs. 30 to Rs. 40; jak fruits per 100, from Rs. 30 to Rs. 37.50; pumpkins per 100, Rs. 25.

Rainfall: there have been a few showers of rain in the month; the wells of the town have some water.

Health: fever to some extent, and a few cases of dysentery, have been reported.

Cattle are still not quite free from hoof-and-mouth disease.

*Girawa Pattu East.*—Paddy: the crops in this pattu referred in last month's report have been reaped and threshed, and the yield is reported to be good. The crops at Hatagala and Hewalgala are now in blossom, and since the issue of water to the amuna there the crops are good. They were dying owing to the drought, as the water in the amuna was daily decreasing.

Weather: the village tanks are all dry. There was no rain, except on the 12th ultimo, when there was a good shower of rain.

Health of inhabitants: the health of the people during the month was fair, but great hardships are felt by the inhabitants of the interior divisions for want of water.

Price of provisions: the price of an amunam of paddy is reported to be Rs. 8.50; kurakkan per amunam, Rs. 8; cocoanut per 1,000, Rs. 35.

## MATARA DISTRICT.

Paddy : sowing for maha is not yet over ; the young crop is looking well.

Dry grain ; prospects fair.

Prices : the price of paddy is the same as last month, viz., Re. 1.62 per bushel.

## EASTERN PROVINCE.

## TRINCOMALEE DISTRICT.

Rainfall : 6.31 inches.

Paddy : the pinmari crops in Koddiyar and Kaddukulam failed for want of rain ; in Tamblegam crops are fair.

No dry grain cultivation.

The outturn of tobacco crops is reported fair.

Manioc crops are reported bad, except in the Tamblegam division, where it is said to have yielded a fair return.

Fisheries moderate.

## NORTH-WESTERN PROVINCE.

## KURUNEGALA DISTRICT.

In divisions this side of the Deduru-oya maha cultivation was practically brought to a close.

The yala crop generally approached ripening, and harvesting was commenced.

The clearing of chenas for maha was in active operation.

In areas beyond the Deduru-oya cultivation of fields for maha was commenced.

Occasional and very welcome showers fell all over the Seven Korales during the latter half of the month.

Health of people and cattle, generally speaking, good.

## CHILAW DISTRICT.

Northern division : sowing for balawi cultivation in villages south of Deduru-oya progressing.

Central division : dewareddiri and balawi crops cultivated for yala earing and maturing. Fine grain being harvested. About 4,262 bushels mawi sown for maha. Cultivation nearly over. Crop young ; prospects good. No rain ; only .40 in. for the month.

Southern division : about 375 bushels paddy sown for maha. Standing crops good, except those of Kammal pattu, which are affected for want of rain.

Many fields in Kammal pattu abandoned for want of rain. Fine grain crops partly gathered.

## PUTTALAM DISTRICT.

Paddy : yala crop in Demala hatpattu ripening and being reaped ; condition, fair. No cultivation in the other divisions.

Dry grain : scarcely any cultivation for want of rain. Chenas being prepared for maha.

Staple products : rice from Rs. 3.50 to Rs. 4 ; cocoanuts Rs. 4 to Rs. 5 per 100.

Rainfall : weather very dry during the month.

## NORTH-CENTRAL PROVINCE.

## ANURADHAPURA DISTRICT.

1. A rainfall of 4.39 has been registered during the month at Anuradhapura. There has been slight rain all over the Province.

2. The condition of the crops generally is fair, and the crops have been for the most part reaped.

3. There was tavalu cultivation only in Nuwaragampalata and Hurulupalata. The crops have been reaped.

4. Chenas are being cleared for kurakkan cultivation in Hurulupalata.

5. Some tanks are still a quarter full, others are either dry or contain only sufficient water for drinking purposes.

6. Cattle murrain is on the decrease.

## PROVINCE OF UVA.

## BADULLA DISTRICT.

Paddy : in Udukinda the maha crop returns have been poor, owing to wind and dry weather ; in Yatikinda the crop has been fair ; in Wiyaluwa the crops were good ; and in Wellassa middling ; in Buttala and Wellawaya good crops have been gathered : in Bintenna flies have caused much damage. Yala cultivation is in active progress.

Chenas are being got ready for dry grain cultivation in the lower divisions. The weather has been dry, and the public health bad.

Cholera, dysentery, and fever have prevailed.

## PROVINCE OF SABARAGAMUWA.

## RATNAPURA DISTRICT.

Paddy : the yala crop throughout the district is ripe, and is being harvested. Returns good, except in Meda and Kolonna korales, where the crops have suffered damage by drought. Maha cultivation in progress ; prospects, fair, except in the Kuruwiti korale, where, owing to rain, the sowing is delayed, and unfavourable results are anticipated.

Dry grain : in Kuruwiti, Nawadun, and Kukululu korales the crops on the yala chenas and owitas are being reaped ; the present wet weather is unfavourable for reaping operations. In the Meda and Pannil pattus of Atakalan korale el-wi chenas are still in blossom, and their condition is satisfactory. In the Bintenna of Atakalan, Kolonna, and Meda korales maha chenas are being cleared, and in the Kukululu korale operations for amu cultivation have commenced.

No cattle disease has been reported.

## KEGALLA DISTRICT.

Paddy, yala : prospects are fair. Balawi sown in Three Korales and Lower Bulatgama is being reaped, and the crop is fair. Ploughing and sowing for maha are still in progress.

Dry grain : hill paddy, kurakkan, and irungu prospects are fair. Some of the chenas in Galboda and Kinigoda korales have been damaged owing to the want of sufficient rain. Amu sowing is in progress. Mun sown in Four Korales is thriving well, except in Galboda and Kinigoda korales, where it has been partly damaged owing to drought. Menari is being sown in Beligal korale. Gingelly and tana sown in Beligal korale have been harvested, and the crop is good. Tana prospects in Parnakuru korale are middling.

Prices : paddy, Re. 1.25 to Re. 1.50 per bushel ; hill paddy, Re. 1.12 per bushel ; kurakkan, Re. 1 to Re. 1.25 per bushel ; amu Re. 1 per bushel.

Rainfall registered at Ambanpitiya 7.8, at Ruwanwella 11.76.

Foot-and-mouth disease is prevailing in parts of Kandupita pattuwa in Beligal korale and in the village Karandupona in Kinigoda korale. It has also appeared in parts of Three Korales and Lower Bulatgama, but the outbreak is not of a serious character. Health of the people has been generally good during this month.

SIR,—I HAVE the honour to transmit to you copies of "The Colonial Boundaries Act, 1895," 58 and 59 Vic., ch. 34.

The Law Officers of the Crown having recently reported that where an Imperial Act has expressly defined the boundaries of a colony, or has bestowed a constitution on a colony within certain boundaries, territory cannot be annexed to that colony so as to be completely fused with it as, e.g., by being included in a province or electoral division of it without statutory authority, it followed that certain annexations of territory to colonies falling within the above category which had been effected by Order in Council and Letters Patent, accompanied by Acts of the Colonial Legislatures, were of doubtful validity, and this Act has been passed to validate these annexations, and to remove all doubts as to Her Majesty's powers in future cases.

An Act to provide in certain Cases for the Alteration of the Boundaries of Colonies.

CHAPTER 34.

[July 6, 1895.]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:—

Alteration of boundaries of colony.

1 (1) Where the boundaries of a colony have, either before or after the passing of this Act, been altered by Her Majesty the Queen by Order in Council or letters patent, the boundaries as so altered shall be, and be deemed to have been from the date of the alteration, the boundaries of the colony.

(2) Provided that the consent of a self-governing colony shall be required for the alteration of the boundaries thereof.

(3) In this Act "self-governing colony" means any of the colonies specified in the schedule to this Act.

Short title.

2 This Act may be cited as "The Colonial Boundaries Act, 1895."

Self-governing Colonies.

Canada, Newfoundland, New South Wales, Victoria, South Australia, Queensland, Western Australia, Tasmania, New Zealand, Cape of Good Hope, Natal.
