**An Ordinance for making provision for the Public,
Railway and Colombo Electricity Supply Services
for the financial year 1935-36.**

BE it enacted by the Governor of Ceylon, with the advice
and consent of the State Council thereof, as follows :

| Short title. | 1 This Ordinance may be cited as the Appropriation Ordinance, No. 27 of 1935. |
| Appropriation for the financial year 1935-36. | 2 Without prejudice to any other law authorizing any expenditure, sums not exceeding eighty-eight million four hundred and twenty-seven thousand seven hundred and sixty-five rupees, twenty-one million nine hundred thousand rupees, and two million one hundred and twenty-two thousand five hundred rupees are hereby declared to be payable for the financial year beginning on October 1, 1935, and ending on September 30, 1936, out of the revenue and other funds of the Island, the Ceylon Government Railway, and the Colombo Electricity Supply respectively ; and the said sums may be expended as specified in the Schedules to this Ordinance. |
