MISCELLANEOUS.

Tenders for the Right to Gem in Crown Land, Kandy District.

NOTICE is hereby given that the Government Agent, Central Province, will receive sealed tenders for the right to

gem for a period of one year in the under-mentioned Crown land situated in the Kandy District of the Central Province.

2. The tenders which must be enclosed in sealed envelopes superscribed "Tender for the Right to Gem" will be received at the Kandy Kachcheri until 11 A.M. on October 30, 1935, when they will be opened, and all persons making tenders will be required to be present or satisfy the Government Agent, Central Province, by some duly accredited agent or agents that the tender is bona fide.

3. The person whose tender is accepted by the Government Agent will be required to deposit the full amount of his tender at once in cash, and to sign a gemming permit on form G.A.—A 133 for the due fulfilment of the

conditions on which the tender is accepted.

4. The amount deposited is liable to forfeiture if the successful tenderer fails to sign a gemming permit within three months from the date of acceptance of the tender.

5. The permit holder shall be liable to pay for any trees

in the land damaged, felled, or uprooted during his occupancy of the said land.

No tender below Rs. 20 for the aforesaid right will be accepted.

tenders and the right of accepting any portion of a tender.
8. The successful tenderer should deposit a sum of Rs. 100 as security for filling up pits and against breaches of the conditions of the permit. This amount will be refunded when pits are closed to the satisfaction of the Government Agent, at the termination of the gemming operations.

9. The permit holder should notify the Government Mineralogist, Colombo, the date on which he commences to gem or proposes to stop work and give him or his officers

access to the workings at any time for inspection.
