## GOVERNMENT NOTIFICATION.

THE CEYLON (STATE COUNCIL ELECTIONS) ORDER IN COUNCIL, 1931.

Revision of Registers of Voters, 1935.

IN pursuance of Article 13 of the Ceylon (State Council Elections) Order in Council, 1931, it is hereby notified by His Excellency the Officer Administering the Government that every person, who is qualified to be registered and is not already registered in any register of voters and is desirous of having his name inserted in any such register, or who is registered in respect of a qualification which has ceased to have effect and is desirous of having his name entered in the register in respect of some other qualification, should forward his application to the registering officer of the electoral district in which the applicant resides so as to reach that officer on or before September 15, 1935.

The officers mentioned in the second column of the schedule hereto are the respective registering officers for the electoral districts mentioned in the first column of that schedule.

# NOTICE.

WITH reference to the Notification under Article 13 of the Ceylon (State Council Elections) Order in Council, dated July 27, 1935, it is hereby notified for general information—

(1) that the Government is taking steps to register all persons qualified for registration under Article 7 of that Order by reason of their domicile in Ceylon; and

(2) that application for registration need not be made by any such person; but that after notice is given under Article 16 of the completion of any register, any person so qualified whose name is omitted from that register, may apply under Article 17 to have his name inserted in the register.
