## GOVERNMENT NOTIFICATIONS.

THE CEYLON (STATE COUNCIL ELECTIONS) ORDER IN COUNCIL, 1931.

No. 4—Minuwangoda Electoral District.

NOTICE is hereby given that the revised register of voters relating to the above-named electoral district has been completed, and that such register is open for inspection at the Colombo Kachcheri during office hours.

Every person who is qualified in accordance with the Ceylon (State Council Elections) Order in Council, 1931, to have his or her name entered in the register for the above-named electoral district and whose name has been omitted or expunged from such register and who claims to have it entered therein, may submit a written claim, which must reach the Registering Officer, Colombo Kachcheri, within two weeks of the date of the publication of this notice in the Government Gazette, to have his or her name inserted in such register. Such claim must be in the form "A" in the Second Schedule to the Ceylon (State Council Elections) Order in Council as amended by the Ceylon (State Council Elections) Amendment Order in Council, 1935 (copies of which form may be obtained from the said Registering Officer), must set out the grounds of claim and must give an address for the receipt of notices: Provided that no person shall be entitled to claim to have his or her name inserted in the register on the ground that he or she is qualified under Article 8 or Article 9 of the above Order in Council unless an application made by that person in accordance with the requirements of Article 14 was duly received by the said Registering Officer on or before the 16th day of September, 1935.

Every person whose name appears in the register for the above-named electoral district who objects to the name of any other person or his or her own name appearing therein, may submit a written application, which must reach the Registering Officer, Colombo Kachcheri, within two weeks from the date of the publication of this notice in the Government Gazette, to have such name omitted from such register. Such application must be in the form "B" in the Second Schedule to the Ceylon (State Council Elections) Order in Council, 1931 (copies of which form may be obtained from the said Registering Officer), must set out the grounds of objection and must give an address for the receipt of notices.
