THE IRRIGATION ORDINANCE, No. 45 OF 1917.

RULES for the Tabbowa irrigation work, Puttalam District, North-Western Province, made by the Governor by virtue of the powers vested in him by section 60 of the Irrigation Ordinance, No. 45 of 1917, and by Article 93 of the Ceylon (State Council) Order in Council, 1931.

RULES.

1. No person shall interfere with, prevent the flow of, distribute, cut off, or divert the water in any channel or water-course constructed and maintained by the joint labour of the proprietors, except under the direction or with the consent of the Irrigation Headman.

2. No person shall encroach upon, alter, divert, block, obstruct, or in any way interfere with or cause injury to any channel or water-course constructed and maintained by the Irrigation Department.

3. No person shall interfere with or in any way damage any sluice, dam, or regulating work comprised in the irrigation work.

4. No person shall obstruct or interfere with or in any way damage any road or path comprised in the irrigation work.

5. No person shall so pollute the water in any channel or other water-course comprised in the irrigation work as to render it unfit for the purposes of irrigation.

6. No person shall use more water from the irrigation work than is absolutely necessary for the irrigation of his holding, or allow to run to waste, or cause any other person to waste, any such water.

7. No person other than the Director of Irrigation or a person authorized by him shall control or distribute water in the irrigation work or interfere with the distribution or flow of water:

Provided that whenever there is a shortage of water, the Assistant Government Agent or the Cultivation Officer may decide upon the quantity of water to be allowed to each holding and the manner in which it is to be distributed.

8. For the purpose of inspection and effecting repairs to the irrigation work, the issue of water for distribution to the fields may be suspended each year between (a) March 16 to April 15 and (b) August 16 to September 30.

9. The issue of water from any channel, sluice, or regulator may be suspended by the Director of Irrigation at any time after consultation with the Assistant Government Agent, should such suspension be necessary in order to carry out repairs urgently needed for the safety of any part of the irrigation work.

10. The rules under section 60 published in the *Gazette* of July 18, 1930, are hereby repealed.

THE GAME PROTECTION ORDINANCE, 1909.

REGULATIONS relating to the use of fishing nets within the area of the territorial waters adjoining Weligam korale and Wellaboda pattu in the Matara District of the Southern Province, made by the Governor by virtue of the powers vested in him by section 27 of the Game Protection Ordinance, 1909, and by Article 93 of the Ceylon (State Council) Order in Council, 1931.

REGULATIONS.

1. Within the area of the territorial waters adjoining Weligam korale and Wellaboda pattu no person shall use at any time any madela which has not been registered in the manner hereinafter prescribed.

2. Application for the registration of any madela shall be made by producing the madela before such headmen and upon such date as may be specified each year in a notice published in that behalf by the Mudaliyar, not less than one month earlier, by beat of tom-tom for six consecutive days and in writing or in print affixed in conspicuous places in the area concerned.

3. All madel which are in good order, and fully equipped with its two mandas and its boat, shall be accepted provisionally for registration, and the owners so informed there and then, on condition that the equipment shall be usable only for that madela when it is duly registered.

4. (a) All madel so accepted provisionally for registration shall be produced again before such headmen on such further date, as may be fixed by notice as aforesaid, together with their mandas and boats.

(b) If after such further inspection as may be necessary, they are found to be in good order they shall be registered, and a registration number assigned to each of them, and the registration number shall be painted on each boat and a metal tag with the registration number and letter denoting the waraya and a crown mark marked on it shall be attached to each such registered net.

(c) No madela shall be registered unless it is produced with its full equipment in accordance with regulation 3.

5. (a) The Assistant Government Agent may in his discretion by suitable notice published in each area concerned, prescribe or limit the number of madel to be used in any waraya; and only the number so prescribed and limited shall be registered for use in such waraya.

(b) No madela registered for use in any one of the warayas defined in the schedule to these rules, shall be used in any other of those warayas.

6. The register shall be forwarded to the Assistant Government Agent, and a true copy kept by each of the said headmen.

7. All registered madel shall be cast in turns according to the sequence of their registration numbers.

8. (1) In Weligam korale, the turn of the first madela shall begin at sunrise on a given day and terminate on the madela being drawn ashore; but if the first owner has not exercised his right by sunrise of the following morning, his turn shall be considered to have passed to the next on the register.

On each madela being drawn ashore, the next owner on the register shall have the right to cast his madela, and his turn shall terminate in like manner on his madela being drawn ashore or at sunrise the next morning. In this manner any number of madel may be drawn on one and the same day; provided, however, that the next on the register may elect to wait for his turn to begin till sunrise on the next day.

(2) In the Wellaboda pattu, the 24 hours of a day shall be divided into four periods, viz.:—midnight to 6 A.M., 6 A.M. to noon, noon to 6 P.M., and 6 P.M. to midnight.

The turn of each net shall coincide with one of these periods. Each net shall be cast on four successive days and for each of the above-named periods in turn, according to the table annexed. At the commencement, and in order to start the table of rotation, the first net shall be cast on the first day only, the second net on the first and second days only, and the third net on the first, second, and third days only. Thus, on the first day nets bearing registered numbers 1, 2, 3, and 4 shall be cast from midnight to 6 A.M., 6 A.M. to noon, noon to 6 P.M., and 6 P.M. to midnight, respectively; on the second day nets bearing registered numbers 2, 3, 4, and 5 shall be cast from midnight to 6 A.M., 6 A.M. to noon, noon to 6 P.M., and 6 P.M. to midnight, respectively, and so on, the turn of No. 1 coming round again when all the registered nets have been cast, as further illustrated in the annexed table: provided that any owner failing to exercise his right before midnight of any day on which his turn comes round, shall be deemed to have renounced his right for that turn.

9. After both ends of the madela are brought ashore for the purpose of being drawn, no casting or other net shall be thrown within the madela.

10. No net other than a registered madela, or a visidela, or a nul (*alias* elena) dela, or ahurana dela may be used inside a waraya, unless special provision therefor is made in the regulations following.

11. The following provisions shall be applicable to fishing in Weligam korale only, namely:—

(a) The catching of Koramburuwo or Bollo fish by visidel within the Weligama Bay is forbidden but the Mudaliyar may by beat of tom-tom, suspend this rule for a special number of days at a time, when Koramburuwo are plentiful in the Bay.

(b) The owners of nuldel shall be allowed unrestricted fishing on one day in each week in Moderewel Waraya and on another day in the week in the portions of the bay ordinarily known as Mirihiwella and Madellwella in Mirihi Waraya. These days shall be fixed by the Assistant Government Agent from time to time by notice published in the areas concerned.

- (c) On the remaining days the owners of madel shall be at liberty to fish herein, in accordance with the foregoing regulations.
- (d) On the day set apart for nuldol no madela shall be cast, and on the days allowed to madel no nuldela shall be cast in the above warayas.
- (e) All nuldol fishing is prohibited in Weligama Waraya in Weligama Bay, except on Mondays, Thursdays, and Saturdays; and all nuldol fishing is prohibited in the Pelena and Kaluwella Warayas within the Weligama Bay.
- (f) The catching of Koramburuwo or Bollo fish with nets at the places called and known as Etulwala and Katuwawala in Weligama Waraya is prohibited. The catching of fish by rod and line after 1 P.M. in these warayas is also prohibited.
- (g) The catching of Koramburuwo or Bollo fish within the Denuwala Waraya by any means other than rod and line, or otherwise than by a person standing on the coral reef or in water, is prohibited.
- (h) It shall not be lawful for the Mirissa fishermen to use nuldol in Weligama Waraya, or for the Weligama fishermen to use nuldol in Mirissa Waraya.

12. The following provisions shall be applicable to fishing in the Wellaboda pattu only, namely:—

(1) Fishing by other means than those indicated below in the following warayas is prohibited:—

- (a) By rod and line in Undugodawella *alias* Parawella.
- (b) By rod and line and atangu in Punchiwella.
- (c) By rod and line at any time and by visidel from 6 A.M. to 12 noon provided that not more than two turns of each net are cast in Etulassewella.
- (d) By rod and line, and madel in Madel Waraya *alias* Nilwella.
- (e) By visidel, waradel, and atangu in Madapatuna.
- (f) By any kind of net except elenadela, between 6 A.M. and 12 noon in Pehembiyawella and by rod and line alone from 12 noon to 6 P.M.
- (g) By rod and line, and madel alone in Hanwella.
- (h) By visidel alone in Dalawelikadwella.
- (i) By visidel alone in Kemagodawella.
- (j) By madel at Kiralawe Waraya.
- (k) By rod and line in knee-deep water in Tallala Waraya.

(2) (a) No delkandas shall be cast inshore of a line from Hambanagala to Halawagala in Gandara Waraya.

(b) Between Halawagala and Hambanagala in Gandara Waraya fishing by rod and line shall be from 6 A.M. to 12 noon.

(c) Any other form of fishing in Gandara Waraya is prohibited.

(3) (a) Between Weheratuduwa and Muttugala in Nunewella Waraya fishing with rod and line is permitted from 6 A.M. to 10 A.M.

(b) Fishing with atangu is permitted in this waraya from 10 A.M. to 2 P.M. in knee-deep water only.

(c) From 2 P.M. to 6 P.M. the use of waradel is permitted in this waraya.

(d) From 6 P.M. the catching of fish with yoth is permitted provided that the fishermen stand on either side of the reef called Galboda, or in boats anchored beyond Weheratuduwa and Muttugala.

(e) Any other form of fishing in Nunawella Waraya is prohibited.

(4) Fishing by visidel in Kavisawella, Etulwella, and Wauwawella is prohibited except on such days as may be fixed by the headmen hereinafter named, and at all other times subject to the exceptions hereinafter set out, fishing in these warayas, shall take place only by rod and line with bait.

(5) Fishing in the warayas of Laggowella, Buranewella, and Sinhasanawella shall be only by rod and line, with or without bait, except as hereinafter provided.

(6) In the six warayas mentioned in paragraphs (4) and (5) of this regulation it shall be lawful for any person to cast waradel once a day till four "peyas" after daybreak, or till 7.30 A.M. whichever shall be later. See 3 (1), 8 (2), 12 (7). Provided that waradel may be cast in knee-deep water at any time between the hours of 5 and 7.30 A.M.

(7) Fishing with rod and line is permitted in Ikituduwa Waraya between 6 A.M. and 6 P.M. provided also that two turns of fishing with visidel and atangu shall be allowed to each person between 6 A.M. and 12 noon.

(8) Fishing by any other means than those indicated below in the following warayas is prohibited:—

(a) By rod and line in knee-deep water from 6 A.M. to 12 noon in Oruwella Waraya.

(b) By atangu in knee-deep water from 12 noon to 6 P.M. in Oruwella Waraya.

(c) By rod and line, or line and hook, in boats from 6 A.M. to 12 noon in Bogahawella Waraya.

(d) By visidel from boats between 6 A.M. and 12 noon in Bogahawella Waraya: provided that not more than two turns shall be allowed to each individual in such boats.

(e) By rod and line, or line and hook from boats between 6 A.M. and 12 noon in Hinnagalmulle Waraya.

(f) By rod and line or line and hook, either in knee-deep water or from boats between 6 A.M. and 12 noon in Kopparawella Waraya.

(g) By atangu or by rod and line in knee-deep water from 12 noon to 6 P.M. in Kopparawella Waraya.

(h) By rod and line in knee-deep water from 6 A.M. to 12 noon in Edandewella Waraya.

(i) By visidel from 6 A.M. to 9 A.M. in Edandewella Waraya: provided that not more than three turns shall be allowed to each individual within that time.

(j) By atangu and rod and line from 12 noon to 6 P.M. in Edandewella Waraya, in knee-deep water or from the rocks within the waraya.

(k) By rod and line or line and hook from boats between 6 A.M. and 12 noon in Maddegalketiya Waraya.

(l) By rod and line and atangu between 12 noon and 6 P.M. in Maddegalketiya Waraya in knee-deep water.

(m) By visidel from 6 A.M. to 12 noon in Mattiwala Waraya: provided that not more than three turns shall be allowed to each individual.

(n) By rod and line in the water at any depth, or from the rocks from 12 noon to 6 P.M. in Mattiwala Waraya.

(o) By rod and line and atangu, in knee-deep water from 6 A.M. to 6 P.M. in Heetagalla Waraya, Hurullobokka Waraya, and Goigodawelle Waraya.

(9) It shall be the duty of the Patabendi Arachchi of Dondra and the Vidane Arachchi of Dondra South to give two full days' notice to the inhabitants by beat of tom-tom when they see proper to permit the use of visidel nets in the warayas referred to in paragraph (4) of this regulation. Such permission shall not be granted till these headmen are satisfied that the fish have properly shoaled.

(10) It shall be lawful for the Patabendi Arachchi of Dondra on application to procure even from prohibited areas bait-fish for boats launching into the deep sea according to existing customs.

(11) In the Wauwawella, Kavisawella, Etulwalawella, Sinhasanawella, Buranewella, Hambanwalawella, and Laggowella Warayas, it shall not be lawful to fish with atangu in water which is more than knee deep between 7.30 A.M. and 5 P.M.

13. All disputes arising out of these rules shall be referred to the Assistant Government Agent, whose decision thereon shall be final.

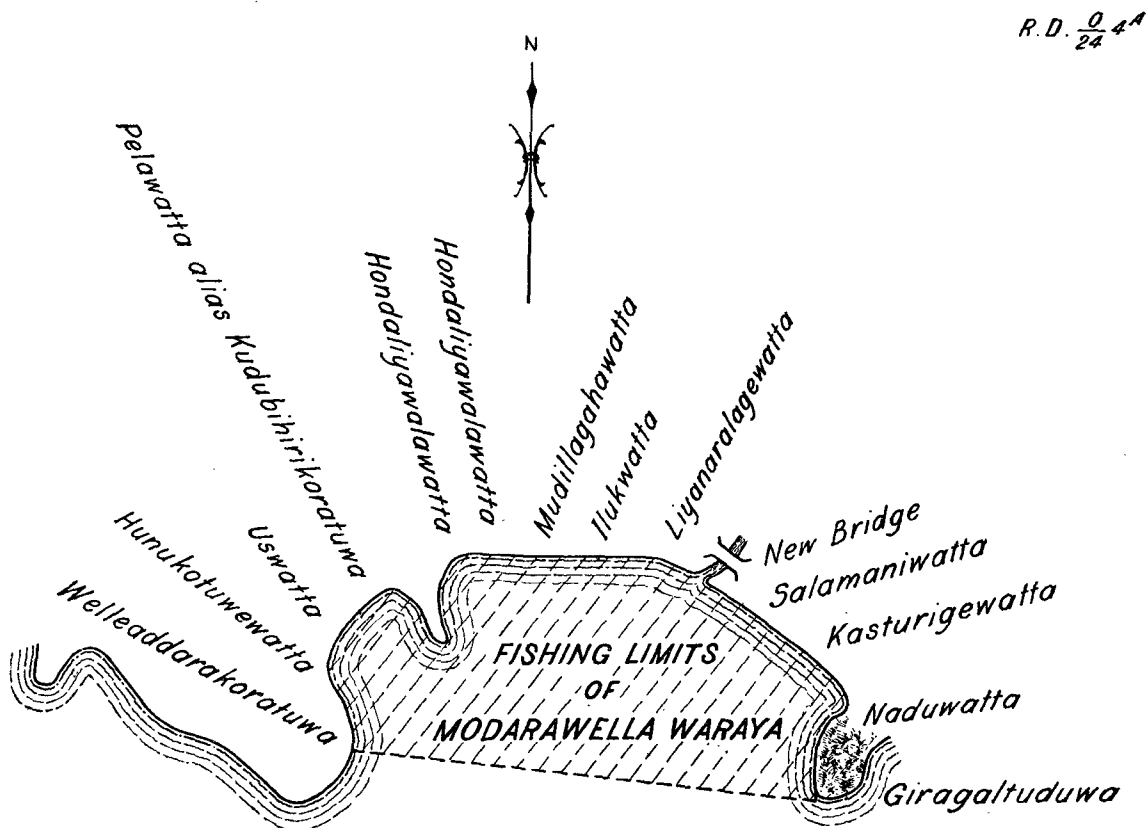

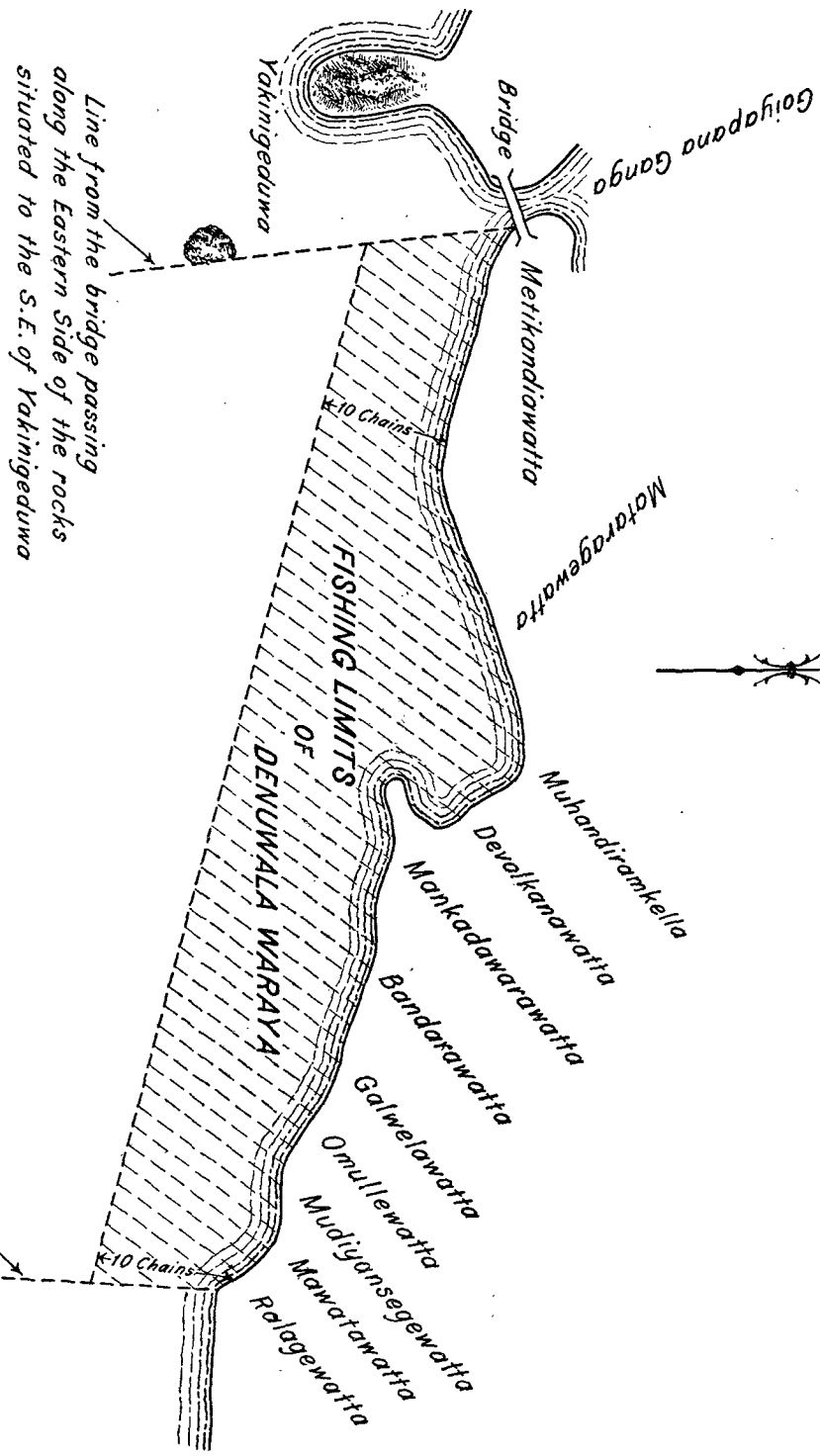

Scale of 16 Chains to an Inch



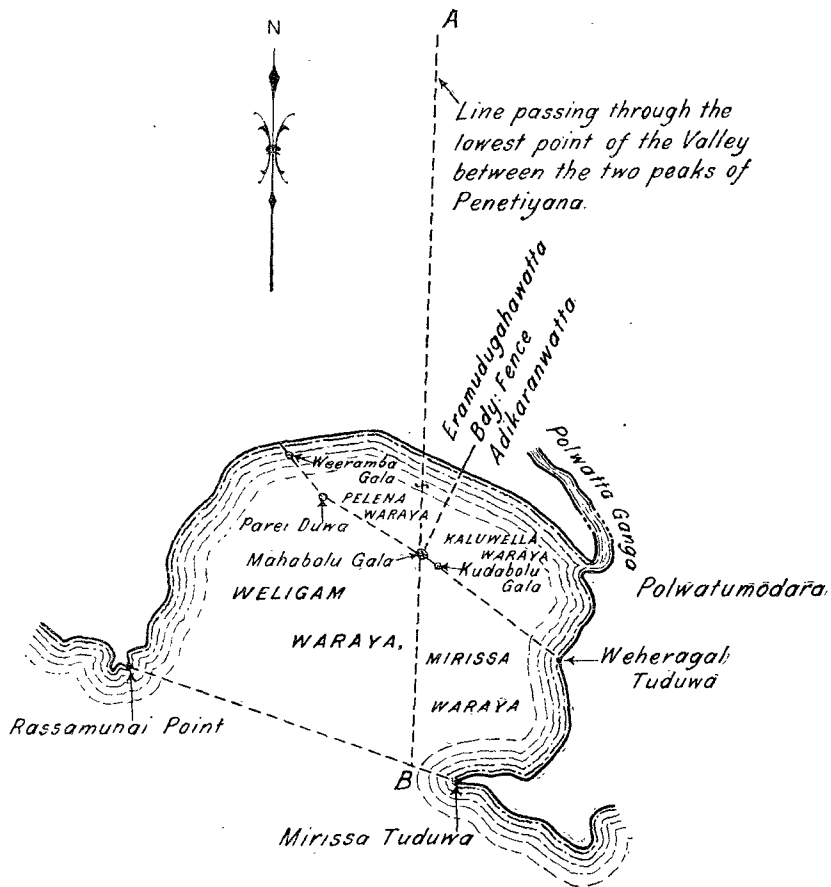

BY-LAWS.

(Conditions for the Issue of Licences for Dangerous and Offensive Trades as defined under the General By-laws relating to Licensed Trades, published in Government Gazette of October 20, 1933.)

1. All materials required for the purpose of carrying on any dangerous or offensive trade as defined in by-law 1 of the general by-law relating to licences shall be so stored as to prevent the diffusion of effluvia or other similar nuisance; and all such materials which have to be brought along any public thoroughfare, and which are likely to give off effluvia or be otherwise offensive shall be transported in non-absorbent covered receptacles or in such other manner as the Chairman may direct, so as to obviate the creation of any nuisance.

2. All offensive vapours or gases emitted during any process or manufacture, shall either be discharged into the external air in such manner and at such a height as to ensure their absorption into the upper air without injurious or offensive effects upon the neighbourhood, or be passed directly through a fire into a condensing apparatus.

3. (1) All premises shall be adequately drained and the drains kept in efficient order and washed daily.

(2) Floors shall be maintained in a proper state of repair and cleansed daily, and when so ordered by the Chairman shall be reconstructed of any impermeable material he may specify.

(3) Walls shall be kept in good order so as to prevent the absorption of filth, and whitewashed twice at least annually and at such other times as the Chairman or the Medical Officer of Health may by written notice specify.

4. (1) All apparatus including implements and vessels shall be kept clean, and where possible they shall be cleansed daily.

(2) All refuse, sweepings, and scrapings, together with waste and bye-products, shall be removed daily from the premises in covered receptacles, unless intended to be forthwith subjected to further trade purposes on the premises.

5. All tanks, used for washing or soaking skins or any other similar materials, shall be emptied and cleansed as often as may be necessary to prevent the creation or diffusion of effluvia.

6. No person carrying on any dangerous or offensive trade, and no owner or occupier of any land or premises upon which such dangerous or offensive trade is carried on, shall pollute any river, stream, canal, channel, well, tank, or open piece of water, by discharging thereto or suffering to flow thereto, any foul, ill-smelling, or offensive water or other fluid, or by throwing thereto, or suffering to be washed thereto, any offensive substance, nor shall he in any other way pollute or contaminate such river, stream, canal, channel, well, tank, or open piece of water.

7. The owner or occupier of any land from which clay, earth, stone, gravel, cabook, or any other material is cut for the manufacture of bricks or tiles, or for building, or for any other purpose, shall take all necessary steps to ensure that proper drainage is provided, and that the pits or trenches cut are afterwards so filled as to prevent the collection of stagnant water therein.

8. Any person who contravenes any of the provisions of the above by-laws shall be guilty of an offence and shall be liable on conviction to a fine not exceeding Rs. 25 for any such offence, and in the case of a continuing offence to an additional fine not exceeding Rs. 5 for every day during which the offence is committed after conviction, or after written notice from the Chairman of such contravention.

LAUNDRIES.

In these by-laws the term "laundry" shall mean any building of any kind, or any land, place, or premises used for the purpose of washing, drying, and ironing clothes by any person carrying on the business or trade of a washerman, and shall include any building used for storing such clothes, and any well, tank or other source of the water used by such person for the purposes of his business or trade.

I.—*Conditions of Issue of Licence.*

No person shall be entitled to a licence for a laundry unless the premises to be licensed comply with the following conditions:—

(i.) (a) That the premises are in good repair and well ventilated and well lighted and that every room is provided with windows capable of being opened which when open shall not be of less area than one-fifteenth of the superficial floor space.

(b) That the walls of every room in every part are not less than 6 feet in height, with the inside thereof lime-plastered and limewashed.

(ii.) That a separate room is provided for the storage of soiled linen.

II.—*Regulations for Licensed Laundries.*

1. No licensee of a laundry shall store any soiled linen in any place other than the room specially provided for it.

2. No licensee of a laundry shall wash or dry clothes at any place other than such special places as may be allocated by the Chairman from time to time for that purpose and indicated by notice boards on the respective sites.

3. Every licensee of a laundry shall report to the Chairman within 24 hours the occurrence of any infectious or contagious disease in his family or household.

4. In the event of any licensee of a laundry or any member of his family or household contracting any infectious or contagious disease, he shall immediately cease all work in the laundry and shall not allow any clothes to be taken into the laundry, or sent out of it after the outbreak and during the prevalence of such disease, save by special permission of the Chairman.

5. No licensee of a laundry shall, without the permission of the Chairman, receive soiled linen from any house in which there is reason to believe that some person is suffering from any infectious or contagious disease.

6. Every licensee of a laundry shall, when called upon by the Chairman, give a list of the persons for whom he washes.

7. Every licensee of a laundry shall cause every part of the laundry, its surroundings, drains, furniture, utensils, and all equipment used for the purposes of the laundry, to be kept clean and in good repair.

8. Every licensee of a laundry shall cause the inside of the soiled linen room to be limewashed twice a year in the months of January and July.

9. No licensee of a laundry shall keep washed linen in any room used as a sleeping room.

Report of the Directors of the Ceylon State Mortgage Bank for the Year ending September 30, 1935.

The Annual Report of The Ceylon State Mortgage Bank is submitted together with the statement of accounts and balance sheet for the year ending September 30, 1935.

Debentures.—To the value of Rs. 1,001,600 were sold during the year ended September 30, 1935, carrying interest at 3½ per cent. Out of this amount 109 debentures of the 4½ per cent. issue to the value of Rs. 5,450 and 223 debentures of the 3½ per cent. issue to the value of Rs. 36,750 were sold in place of compulsorily redeemed ones.

Interest to Debenture Holders.—Amount paid as interest to debenture holders for the year ended September 30, 1935, was Rs. 80,913·56 being Rs. 35,701·72 for half-year ended March 31, 1935, and Rs. 45,211·84 for half-year ended September 30, 1935.

Redemption of Debentures.—During the year under review 1,550 debentures of the first 5 per cent. issue amounting to Rs. 77,500 were redeemed—49 voluntarily and 1,501 compulsorily.

Loans.—47 loans were granted during the year ended September 30, 1935, amounting to Rs. 908,487, as against 24 loans amounting to Rs. 458,829 during the previous year.

Securities.—The securities for these loans consist of 14 properties in town and 5,331½ acres of agricultural lands consisting of 1,136½ acres tea, 1,095½ acres rubber, 1,404½ acres coconut, 253½ acres paddy, 168½ acres other products, and 1,273½ acres undeveloped land.

Interest received on Loans.—Interest on loans for the year amounts to Rs. 133,900·57—Rs. 87,079·21 represent interest actually earned during the year and Rs. 46,821·36 accrued interest to September 30, 1935.

Capital Repayment of Loans.—Repayment of principal of loans for year ended September 30, 1935, was Rs. 81,381·23.

Cost of Maintaining the Bank.—The working expenses of the Bank during the year amounted to Rs. 63,671·49, as against Rs. 40,523·79 during the previous year.

Profits.—The nett profit for the year ended September 30, 1935, was Rs. 34,170·36.

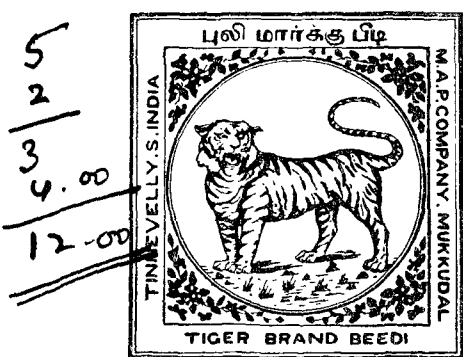

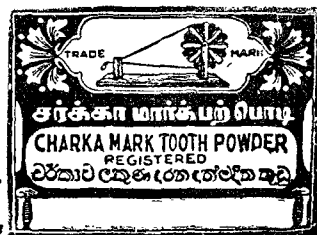
