5. The purchaser shall not assign or sublet the lease to any other person without the permission previously obtained in writing from the Government Agent.

6. The purchaser shall keep the premises clean and in good order, pay all rates and taxes, and also comply with the regulations of the Local Administrative Body. He shall, during the months of January and June, 1936, clear the jungle and undergrowth on the land included in the lease exclusive of the portions allotted for the use of the canal or maintained by the Public Works Department and obtain a certificate to such effect from the District Engineer, Colombo North.

8. In the event of any breach of the foregoing conditions the Government Agent shall have the power to resume possession of the lessee's rights and eject the lessee and his workmen without compensation. ŝ.
