FINAL ORDERS.

LAND SETTLEMENT ORDINANCE, 1931.

Settlement Order.

WHEREAS a settlement notice under section 1 of the Waste Lands Ordinances was duly published in the *Gazette* No. 7,730 of August 30, 1929, and as otherwise required by the said section, in respect of the lands situated in Bogamuwa village, in the Kohoka korale of the Uda Hewaheta division of the Nuwara Eliya District, in the Central Province, and described as lots 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, and 17 in preliminary plan No. 8,288 (*vide* W.
