SEASON REPORT FOR THE MONTH ENDED SEPTEMBER 30, 1895.

NORTHERN PROVINCE.

MANNAR DISTRICT.

Paddy fields and beds of tanks on the mainland are being manured and fenced for next maha paddy cultivation. Jungles are being cleared and burnt both on the mainland and in Mannar island for dry grain cultivation. Paddy sells at Re. 1.62 per bushel; kurakkan sells at Re. 1.50 per bushel.

Health of people: fair. Health of cattle: cattle generally suffer greatly for want of water and pasture. Losses from murrain have been very heavy among buffaloes, and cattle for ploughing will be difficult to procure.

Sea-fishing: poor, south-west wind being still very strong.

Rainfall: 09 in. The drought has been unprecedented.
