# GOVERNMENT NOTIFICATIONS.

THE CEYLON (STATE COUNCIL) ORDER IN COUNCIL, 1931.

### Order.

BY virtue of the powers conferred by section 11A of the Interpretation Ordinance, 1901, and by Article 95 of the Ceylon (State Council), Order in Council, 1931, construed in accordance with the provisions of Article 4 (3) of that Order in Council, I, Reginald Edward Stubbs, Governor of Ceylon, do, with effect from the 1st day of October, 1936, by this Order—

(1) amend the Order dated July 6, 1931, and published in Gazette Extraordinary No. 7,867 of July 6, 1931, by the omission from the schedule to that Order of the items relating to the delegation to the Attorney-General of the powers, authorities, and functions vested in the Colonial Secretary by the provisions of written law specified in the schedule hereto other than section 374 (2) of the Criminal Procedure Code, 1898;

- (2) rescind the Order dated August 2, 1931, and published in *Gazette* No. 7,874 of August 7, 1931, whereby the function vested in the Colonial Secretary by section 374 (2) of the Criminal Procedure Code, 1898, was vested in the Attorney-General; and
- (3) direct that the powers, authorities, or functions vested in the Colonial Secretary by the several provisions of written law specified in the schedule hereto shall be vested in the Legal Secretary.

THE CEYLON (STATE COUNCIL) ORDER IN COUNCIL, 1931.

### Order.

BY virtue of the powers conferred by section 11A of the Interpretation Ordinance, 1901, and by Article 94 of the Ceylon (State Council) Order in Council, 1931, construed in accordance with the provisions of Article 4 (3) of that Order in Council, I, Reginald Edward Stubbs, Governor of Ceylon, do, with effect from the 1st day of October, 1936, by this Order-

(1) rescind the Order dated September 28, 1933, and published in Gazette No. 8,011 of October 6, 1933, whereby the powers, authorities, and

functions vested in the Governor by section 378 of the Criminal Procedure Code, 1898, were delegated to the Attorney-General; and

(2) delegate to the Legal Secretary the powers, authorities, or functions vested in the Governor by the provisions of written law specified in the schedule hereto.

### Customs Notification (Tariff) No. 36/5.

ORDINANCE No. 17 of 1869.

IT is hereby notified that the following resolution under section 11 of Ordinance No. 17 of 1869, passed by the State Council at its public session on September 29, 1936, and sanctioned by the Governor, has been duly submitted to and sanctioned by the Secretary of State for the Colonies.

### RESOLUTION REFERRED TO.

This Council resolves under section 11 of Ordinance No. 17 of 1869, that from and after the date on which the sanction of the Secretary of State to this resolution is notified in the Government Gazette, an export duty of eighty and one-half cents (whereof a sum of seventy-five cents shall be deemed to be appropriated under section 28 of the Medical Wants Ordinance, No. 9 of 1912, for the purpose of meeting the expenses of that Ordinance) shall be levied and paid on every hundred pounds of rubber produced in Ceylon and exported therefrom, in lieu of the export duty payable on such rubber at the date of this resolution:

Provided that nothing herein contained shall affect the export duty of one-eighth of a cent per pound levied under section 6 (1) (a) of the Rubber Research Ordinance, 1930, or the export duty of one-quarter of one cent per pound levied under section 47 (1) of the Rubber Control Ordinance, No. 6 of 1934.
