Lease of Grazing Rights on Crown Land at Buller's Road.

NOTICE is hereby given that the Government Agent, Western Province, will receive sealed tenders for the purchase of the grazing rights on the Crown land described herein below for a period of one year from January 1, 1937, subject to the following conditions.

2. The tenders, which must be in sealed envelopes superscribed "Reclaimed Land at Buller's road," will be received at the Colombo Kachcheri until 11 A.M. on Friday, December 4, 1936, when they will be opened. All persons making the tenders will be required to be present or to satisfy the Government Agent by some duly accredited agent that the tenders are made *bona fide*.

Conditions.

(1) The purchase amount shall be paid in full on the day of sale.

(2) The purchaser is only entitled to the grazing rights.

(3) The purchaser or his workmen shall not cut any tree or interfere with any existing fence or boundary.

(4) The purchaser shall keep the land clean and in good order, and also comply with Municipal regulations, and also pay Municipal rates and taxes.

(5) No milch cows or she-buffaloes shall be permitted to graze on the land, and any such animals found grazing thereon will be liable to seizure by the lessor or any person duly authorized by him. The lessee shall allow the Municipal officers direct control with a view to enforcing this prohibition.

(6) Each animal must be securely tethered with an iron peg and strut 20 feet, and at a distance not less than 20 yards from a road.

(7) Cattle not tethered are liable to be seized and dealt with as stray cattle.

(8) The purchaser shall not assign, transfer, or sublet this right without the previous consent in writing of the Government Agent, Western Province.

(9) If the whole or any portion of the land is required by Government before the expiry of the lease, such land or portion shall be surrendered on a week's notice being given, and a *pro rata* refund of the purchase amount will be paid to the purchaser for the unexpired period of the lease respecting the land or portion thereof for which rent has been previously paid.

(10) Structures of any sort or the running of tea booths on the land without the special permission of the Government Agent previously obtained in writing are prohibited.

(11) In the event of any breach of the foregoing conditions, the Government Agent shall have the power to resume possession of the land and eject the purchaser and his workmen from the land without compensation.

(12) The Government Agent reserves the right to reject any or all tenders, or to accept any part of a tender, or to deal with the land in any other way as if tenders had not been called for.
