3. Plans can be seen at the Colombo Kachcheri on application made to the Government Agent.

4. A separate tender should be made for each separate lot or for definite portions thereof and the tenderers should state therein-

- (a) the purpose or purposes for which he proposes to use the land;
- (b) the nature of the buildings he proposes to erect thereon;

(c) the annual rent which he is prepared to pay;
(d) when tendering for definite portions out of the surveyed lots, the actual extents desired showing as precisely as possible the relative position of the plot desired annexing an explanatory sketch.
