FINAL ORDERS.

LAND SETTLEMENT ORDINANCE, 1931.

Settlement Order.

WHEREAS a settlement notice under section 4 of the Land Settlement Ordinance, 1931, was duly published in the Gazette No. 8,221 of May 29, 1936, and as otherwise required by the said section, in respect of the lands situated in the village of Maha Maeliya, in Annaivilundan pattu north of Pitigal korale north, in Chilaw District, North-Western Province, and described as lots 53, 54, 55, 56, 57, 58, 59, 60, 61, 62, 63, and 64 in preliminary plan No. 7,090 (vide Settlement Notice No. 1,281, Chilaw).
