THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Munasingha Kariyawasam Appuhamilage Don Somadasa Gunawardana, Minister of Lands hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Allotments of land called Kajugaha Kumbura having following mentioned extent and limitation in total extent of 0.5040 Hectare shown as Lots 'A' and 'B' in Amended Advance Tracing No. Gam/Watt/2013/122 and dated 29th May, 2013, prepared by the Superintendent of Surveys situated in the Village of Nawammahara in Ragam Pattuwa Minor Division in the Divisional Secretary's Division of Wattala in the District of Gampaha in Western Province:

01. Lot 'A' – Extent: 0.1020 Hectare
