THE PUBLIC REVENUE PROTECTION ORDINANCE, No. 33 OF 1921.

THE PUBLIC REVENUE PROTECTION ORDINANCE, No. 33 OF 1921.

Order under Section 2.

Whereas I, Reginald Edward Stubbs, Governor of Ceylon, have, during the present session of the State Council, approved of the introduction into that Council of a resolution whereby the import duties now payable on the goods, wares, or merchandise specified in Column I. of the schedule hereto shall be altered:

Now, therefore, in pursuance of the powers vested in me by section 2 of the Public Revenue Protection Ordinance, No. 33 of 1921, and by Article 93 of the Ceylon (State Council) Order in Council, 1931, I do hereby order the Principal Collector of Customs from midnight of the twentieth day of March, 1937, to demand and to levy on the goods, wares, or merchandise specified in Column I. of the schedule hereto the respective import duties set out in Column II. in lieu of the import duties payable thereon under the existing law.
