PART I.—GENERAL.

PROCLAMATION BY THE GOVERNOR.

IN the Name of His Majesty GEORGE VI., by the Grace of God of Great Britain, Ireland and the British Dominions beyond the Seas King, Defender of the Faith, Emperor of India :

PROCLAMATION.

By His Excellency Sir REGINALD EDWARD STUBBS, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Governor and Commander-in-Chief in and over the Island of Ceylon, with the Territories and Dependencies thereof.

WHEREAS by Article 1 of the Order (hereinafter referred to as the Principal Order) made by Her Late Majesty Queen Victoria in Council on the 26th day of October, 1896, it is provided that the said Order shall apply to and have effect in all or any of the Colonies specified in the Schedule thereto in which it shall be proclaimed by the Governor of the Colony, and shall come into operation in each such Colony on being so proclaimed therein, and shall continue in operation therein until the Governor shall by Proclamation declare that it has ceased to be in operation therein :

And whereas Ceylon is a Colony mentioned in the Schedule to the Principal Order :

And whereas the Principal Order was brought into operation in Ceylon by a Proclamation dated August 5, 1914, and published in *Ceylon Government Gazette Extraordinary* No. 6,638 of the same date :

And whereas the Principal Order was amended by an Order (hereinafter referred to as the First Amending Order) made by His Late Majesty King George V. in Council on the 28th day of August, 1914 :

And whereas by Article 2 of the First Amending Order it was provided that the said First Amending Order shall have effect in any Colony in which the Principal Order had been proclaimed as from the date of such Proclamation :

And whereas by an Order (hereinafter referred to as the Second Amending Order) made by His Late Majesty King George V. in Council on the 21st day of March, 1916, the Principal Order was further amended :

And whereas by Article 1 of the Second Amending Order it is provided that the said Second Amending Order shall continue in operation in any Colony in which the Principal Order is proclaimed until the Governor shall by Proclamation declare that the Principal Order shall cease to be in operation therein :

And whereas by Proclamation published in *Ceylon Government Gazette Extraordinary* No. 6,798 of June 5, 1916, it was declared that the Principal Order as amended by the First Amending Order and the Second Amending Order should be in force in Ceylon as from the date of that Proclamation :

And whereas it is expedient that the continuance of the operation of the Principal Order (as amended by the First Amending Order) and of the Second Amending Order shall be terminated :

Now, therefore, know Ye that in pursuance of the powers in Us vested by Article 1 of the Principal Order We, the Governor of Ceylon, do by this Proclamation declare that the said Principal Order has ceased to be in operation in Ceylon.

Given at Colombo, in the said Island of Ceylon, this Twenty-sixth day of June, in the year of our Lord One thousand Nine hundred and Thirty-seven.
